Khaleda lands in jail

Court hands her 5 years in prison; bail prayer likely Sunday; Tarique, 4 others get 10 years in Zia orphanage graft case

BNP Chairperson Khaleda Zia landed in jail yesterday after a special court sentenced her to five years' rigorous imprisonment in a graft case, dealing a severe blow to the party ahead of the upcoming national elections.

corruption case came amid heightening tension that kept people's nerves on edge over the last few days. The BNP chief's conviction could have

significant political implications as it makes uncertain her participation in the next national polls slated for later this year. "As the prosecution has been able to

prove the charges against Khaleda Zia, she has been awarded five years' rigorous imprisonment, considering her social status and physical condition," said Judge Md Akhtaruzzaman of the Special Court-5 in Dhaka, delivering the much-talked about verdict in a packed courtroom.

The court cancelled Khaleda's bail and sent her to prison. Law enforcers then took her to the old Central Jail on Nazimuddin Road in the capital amid tight security around 3:00pm.

Khaleda Zia woke up early in the morning yesterday. By 9:00am, she had her breakfast -- roti, vegetables and

fruit juice -- prepared by domestic help Fatema. The BNP chief appeared quite composed as she was talking to family members after breakfast. Some of them helped her get ready and packed her suitcases.

It was not just any other day.

Close relatives, BNP leaders and lawyers were waiting at her Gulshan house -- some to say her goodbye and some to accompany her to Bakshibazar in Old Dhaka.

Sporadic violence Her first few on a day of alarm hours in jail

People across the country were fearing widespread violence and were panicking as tension built up ahead of yesterday's verdict in the Zia Orphanage Trust graft case against BNP Chairperson Khaleda Zia.

Much to their relief, it was not as bad as feared.

There were incidents of violence in the capital, Chittagong, Sylhet and a few other places. One person was killed and around 100 others were injured across the country

yesterday. An Awami League supporter was killed as two groups of the ruling party men had a gunfight at Rupganj of Narayanganj over showing off muscle power ahead of the verdict delivery. At least 50 people, including AL activists, police and journalists were wounded.

Khaleda's son Tarique Rahman, also senior vice chairman of BNP, is supposed to run the party in her absence. But he has been in London since 2008 facing multiple charges of corruption.

Nevertheless, BNP leaders hope that Tarique will run the party as it is not necessary to remain physically present to do that in the

era of technology. "He [Tarique] can run the party from anywhere," Nazrul Islam Khan, BNP standing committee member, told reporters yesterday.

Meanwhile, Tarique, now the acting chairman of BNP, in a statement issued after Khaleda was taken to jail, said the verdict was politically motivated and demanded her immediate release.

Commenting on how the BNP would function in the coming days, Nazrul said Tarique would run the party in consultation with the standing committee members.

"He is the second most powerful person in the party." Tarique was made the BNP senior vice-chairman at a council of the party in 2009. He had already left the country

when the council took place. According to BNP constitution, senior vice-chairman is its second-highest post. In the absence of chairperson, the senior vice-chairman can call for meetings of the standing and executive committees and can also exercise the powers vested in the chairperson.

BNP leaders hope that Khaleda would be released on bail soon and no major issues will arise during her absence.
