Defence seeks Huji man's acquittal

COURT CORRESPONDENT

The defence counsel for Huji leader Hossain Ahmed Tamim yesterday concluded closing arguments and sought acquittal for his client from all charges in the cases filed over August 21 grenade attack.

Advocate Ehsanul Karim placed his submissions for over two hours and said his client was forced to give a confessional statement before a magistrate.

The lawyer also said three other accused gave confessional

statements where they involved his client. But there are contradictions between the confessional statements given by Tamim and those by four others, including Mufti Abdul Hannan. Judge Shahed Nuruddin of the Speedy Trial Tribunal-1 of

Dhaka heard the arguments and later adjourned the hearing till February 19 and 20.

Earlier, defence lawyers for 20 others including BNP Senior Vice-Chairman Tarique Rahman, former BNP lawmaker Kazi Shah Mofazzal Hossain Kaikobad and Hanif Paribahan owner Mohammad Hanif concluded their closing arguments in the cases. Twenty-four leaders and activists of the AL and its associate bodies were killed and over 300 others suffered splinter injuries in the August 21 attack. Ivy Rahman, the then Mohila AL presi-

dent and also the wife of late president Zillur Rahman, was among the deceased. Of the 49 accused, eight, including three former inspectors general of police, are now on bail, while 18, including Tarique Rahman, are absconding. Twenty-three accused, including former state minister

Lutfozzaman Babar and ex-deputy minister Abdus Salam Pintu, who are now behind bars, were produced before the court yesterday.

BRIBERY CASE

Lakehead owner granted bail COURT CORRESPONDENT

A Dhaka court yesterday granted bail to Khaled Hassan Matin, owner of Lakehead Grammar School, in a bribery case as the sections under which the case was filed are bailable.

Judge Kamrul Hossain Mollah of the Metropolitar Sessions Judge's Court of Dhaka passed the order after Matin's lawyer had moved a criminal appeal against the rejection order of the lower court.

The Chief Metropolitan Magistrate's Court of Dhaka rejected the bail and sent Matin along with two education ministry officials to jail after they were

ATTACK ON JOURNOS AT SYLHET COURT

Names of four main accused dropped from charge sheet

In the case filed over attacking two journalists by alleged Awami League men in Sylhet court area in January, police have submitted a charge sheet dropping the names of four prime accused, much to the surprise of the complainant. On Tuesday, Sub-inspector Hadiul

Islam of Kotwali Police Station, also investigation officer (IO) of the case, submitted the charge sheet to Sylhet Metropolitan Magistrate's Court. But names of four prime accused

were dropped from the case, according to the charge sheet. The Daily Star has obtained a copy of it.

Nirananda Paul, video journalist of Jamuna TV, and Mamun Hasan, photo

journalist of the daily Jugantor, were injured in an attack allegedly by followers of Liaquat Ali, general secretary of Jaintiapur upazila Awami League, in Sylhet court area on January 25.

Liaquat was denied bail in a murder case at a Sylhet court that day. When the journalists were recording video footages and taking photos of Liaquat and 29 others while they were being taken to jail, around 50 followers of Liaquat attacked them, and also broke their cameras, said witnesses.

Following that, the next day, a case was filed accusing Liaquat Ali, Shamim Ahmed, Foyej Ahmed Babar, Jewel Arman, Hossain Ahmed, Najrul and 15 other unnamed persons.

On February 2, the court granted two-day remand for Liaquat Ali, the prime accused of the case.

Regarding the charge sheet, the complainant, Nirananda Paul, said the IO pressed the charge sheet without talking to him.

Contacted, the IO brushed aside the allegation. He said he had spoken to the complainant.

The names of Liaquat, Foyej Shamim and Hossain were dropped as their involvement was not found during investigation, the IO added.

Gousul Hossain, officer-in-charge of Kotwali Police Station, also said the IO pressed the charge sheet after taking Nirananda's consent.

However, Bappa Gosh Chowdhury, former vice-president of Sylhet Press Club, said the police are cooking up a

Coast guard to recruit own manpower soon

The Bangladesh Coast Guard will soon start recruiting its own manpower, Home Minister Asaduzzaman Khan Kamal said yesterday.

Since its inception 23 years ago, on February 14 in 1995, the paramilitary force has been in operation with officers and sailors on deputation from the Bangladesh Navy.

The home minister made the announcement regarding the recruitment plan of the government while speaking as the chief guest at the 23rd founding anniversary of the coast guard at its headquarters in the capital's Agargaon.

A proposal for the recruitment of coast guard's own manpower is being processed, said Coast Guard Assistant Director (intelli-

gence) Lt Commander Abdullah Al Maruf. Once the recruitment proposal is

approved, all the 142 officers and 2,397 sailors, currently working on deputation from the navy, will be replaced with new recruits in phases. Some navy officers, however, will be permanently posted in the coast guard, said coast guard officials. The minister during the programme said
