Roadside trees face risk

Signboards, banners hung by hammering nails

Many private organisations and even individuals in Nilphamari hang their signboards and banners from busy roadside trees unethically to advertise either their goods or personal service.

Usually, people hang signboards and banners by hammering big nails into the tree.

Trees are regarded as the main source of oxygen and this practice will gradually cause serious infection of the trees, even leading to their death, said Prof Abdul Latif, head of Botany department at Nilphamari Government College.

"If one inserts big nails deep into a tree trunk or branch fluids containing food nutrients will come out through the wound and hamper its natural growth."

"Different kind of bacteria, virus and rain water enter inside it through the wound and rot the affected part, which could even lead to its death," added Prof Latif. While visiting some important

roads, including Nilphamari-Saidpur, Domar-Dimla, Dimla-Sutibari, Nilphamari-Domar and Domar-Chilahati road, this correspondent saw many giant roadside trees are covered with banners and signboards of herbal medicine practitioners, coaching centres,

diagnostic clinics, school admission, travel agents and shopping

"I prefer doing this because I am having a good advertisement of my service free of cost," said marriage registrar Aftabuddin Ahmed, 60, who hung a signboard on a giant blackberry tree near Uttara EPZ in Sadar upazila. Like him, herbal ointment seller

Fateh Ali, 55, of Ambari village in Domar upazila, said he is doing nothing wrong hanging his signboard as one can easily learn about his medicine.

Most of the roadside trees across the district belong to the Zila Parishad, LGED and RHD depart-

ment, but the authorities concerned seem less bothered with the problem.

Zila Parishad Engineer Rabiul Islam said, "Roadside trees are government property and causing any harm to them is a punishable offence."

They cannot monitor the trees properly due to inadequate manpower, Rabiul added.

ing to songs on Language Movement are still his inspiration for living. After passing his matriculation examination, Sumanta, born at Roykali village on January 25, 1922,


took admission at Government Azizul

Principal embezzles Tk 20 lakh

Says letter to DC, signed by 47 out of 48 college teachers

The principal of Moukaran BLP Degree College in Sadar upazila allegedly misappropriated Tk 20 lakh in 30 months after joining the college. Following a complaint submitted by 47

of the 48 teachers of the college, the Patuakhali deputy commissioner (DC), also chairman of the college governing body, on January 25, has ordered investigation in this regard.

According to the letter, HM Golam Mostafa joined the college as the principal on August 1 in 2015, and since then he allegedly misappropriated around Tk 20 lakh till January 2018, while the total income of the college was about Tk 36 lakh.

Vice-Principal Md Jasim Uddin Howlader said, according to the rules, all income should be deposited in account No

184 in Moukaran branch of Sonali Bank, but the principal did not deposit the incomes in the bank and misappropriated the money. Mostafa misappropriated money by

submitting false vouchers, Jasim alleged. Principal Mostafa rejected the allegations

as false and said some teachers are making propaganda against him. "Some teachers wanted to be principal but in vain, and after I joined they

engaged in false propaganda to harass me," he said. Nurul Hafij, additional deputy commis-

sioner for ICT and education, said they have started investigation into the matter and he has visited the college.

"If we find the principal guilty, action will be taken against him as per rule," he added.
