QUESTION LEAK

Lawyers rebuked for defending accused

A Dhaka court yesterday criticised lawyers for moving a bail petition for an accused held over his alleged involvement in leaking Dhaka University D-unit admission test questions.

Judge Kamrul Hossain Mollah of the Metropolitan Sessions Judge's Court of Dhaka lambasted Advocate Anisur Rahman and two others who moved a bail petition for Mohammad Maruf Hossain, 24.

The judge told the lawyers that they should not stand with the question leaksters as such people damage the talent

of the students.

The judge said that the accused have confessed to his crime and after getting bail he will again do the same act. On December 9 last year, Criminal Investigation Department (CID) detained Boni Israel, 23, and

Mohammad Maruf, 24, from Rajshahi. They were remanded for quizzing about the question leak and they confessed to their crime under section 164 in

December last year. On October 20 last year, a full set of the question paper for the test for the 2017-18 academic session was leaked,



LOSING EYESIGHT AFTER SURGERY

Why not pay Tk 20cr to victims for 25,000 pilgrims

HC asks director, physician of Chuadanga health centre

The High Court yesterday issued a rule asking the director and a physician of the Impact Masudul Haque Memorial Community Health Centre (IMHMCHC) in Chuadanga to explain why they should not be directed to give Tk 20 crore in compensation to 20 people who lost their eyesight following surgeries at the health centre on March 5.

Director of IMHMCHC Hasib Mahmud and its physician Mohammad Shahin, who reportedly conducted the eye surgeries on 20 poor people, have been asked to give the explanation in two weeks.

In the rule, the court asked the authorities concerned of the government and IMHMCHC to show causes why inaction of Hasib and Shahin in adopting proper safety measures while conducting the eye operations should not be declared illegal.

The court in the rule also asked the authorities to come up with an answer why legal action should not be taken against Hasib and Shahin for their reported misdeed and negligence in conducting unsafe eye operations during a three-day eye camp. The health secretary, home secretary, director

general of the directorate of the health services, civil surgeon of Chuadanga, deputy commissioner and superintendent of police of Chuadanga, director of IMHMCHC Hasib Mahmud and its physician Shahin have been made respondents to the rule.

The bench of Justice Zubayer Rahman Chowdhury and Justice Md Iqbal Kabir came up with the rule following a writ petition filed by Supreme Court lawyer Advocate Amit Das Gupta seeking a HC directive on IMHMCHC.

The bench asked the petitioner to place the matter before it on May 6 for hearing the rule.

Advocate Amit Das Gupta yesterday submitted the petition as a public interest litigation based on a report of the daily Samakal on March 29.

The report says 20 persons have lost their eyes following the surgeries on March 5 as the authorities did not adopt appropriate safety measures.

HAJJ REGISTRATION

Deadline extended


Around 25,000 hajj aspirants failed to complete their registration before the deadline ended at 8:00pm last night.

So far, around 1,02,000 of the aspirants have completed registration to perform this year's hajj that is likely to be held on August 21, subject to moon sighting, said sources at the religious affairs ministry.

In a bid to fill up the quota of 1,27,198 hajis, the ministry will now consider a second list of pre-registered aspirant hajj pilgrims today and 25,000 more hajj aspirants, based on their serial numbers, will be given the opportunity to complete registration, Anisur Rahman, secretary-in charge of the

ministry, told this paper. The aspirants from the new list will have to complete their registration by April 5, he also said.

This year, the final registration of the pilgrims under government management started on March 1 while the process under private hajj management began on March 6.
