### Three Bangladeshis die in Australia car crash

Three Bangladeshis were killed and four others injured following a car crash on an Australian highway on Saturday.

Saiful Islam, Sadeka Kamal Nipa and Maisha Kuddus died after an SUV carrying them rolled on the Kakadu Highway around 12:30pm (local time), reports ABC News and Prothom Alo.

Four others in the vehicle were flown to Darwin, the capital of Australia's Northern Territory.

Although they were in a stable condition at Royal Darwin Hospital, three of them were at the intensive care unit.

Two of the injured might have limbs amputated, and another had a severe head injury, a spokesperson of the hospital told ABC News.



## HC verdict on writ petition today

The High Court will deliver its verdict today on a writ petition that challenged the legality of earth filling in croplands and wetlands in some areas of Sonargaon upazila in Narayanganj.

The bench of Justice Md Ashfaqul Islam and Justice Ashish Ranjan Das is set to deliver the verdict.

The bench concluded the hearing on the petition on October 19 last year and kept the matter for delivering its verdict any day.

Bangladesh Environmental Lawyers Association (Bela) submitted the petition in 2014, saying that Unique Properties Development Ltd, a private housing company, had filled up land for establishing its Sonargaon Resort City, a housing project.

The Department of Environment (DoE) in 2012 had fined the company Tk 50 lakh for damaging the agricultural land and wetland.

The DoE also asked the company to remove the dumped soil, but it did not do so.

Sonargaon upazila cannot grow crops in their land that is allegedly grabbed by the company, it said.

Following the petition, the HC on March 2, 2014 directed Unique Properties Development Ltd, a private housing company, to stop further filling up of land and to remove the dumped soil.

It also issued a rule upon the authorities concerned of the government and the company to explain as to why the earth filling activities should not be declared illegal.

During the hearing on the rule on October 19 last year, Bela's lawyer and its chief executive Advocate Syeda Rizwana Hasan told the HC that Bangladesh Economic Zone Authority (BEZA) had illegally permitted the company to fill up the land for establishing hotel and resort, although BEZA has no right to do so.

## Find out 'missing' Rangpur public prosecutor

Demonstrators issue 48-hr ultimatum to govt

Different social-cultural organisations in Rangpur yesterday threatened to paralyse the district if the government fails to rescue the "missing" special public prosecutor Rathish Chandra Bhowmik within 48 hours.

The announcement came from a human chain formed in front of Rangpur Press Club in the morning.

Rangpur unit of Bangladesh Puja Udjapan Parishad; Bangladesh Hindu, Buddhist, Christian Oikya Parishad; Sammilito Sangskritik Jote; and Group Theatre Federation, jointly organised the human chain demanding immediate rescue of the missing lawyer.

Advocate Rathish Chandra Bhowmik, 55, who represented the state in cases over the murder of Japanese national Hoshi Kunio and Rahmat Ali, khadem (caretaker) of a shrine, has been "missing" since Friday morning.

#### QUESTION LEAKS TIB stages countrywide

Transparency International Bangladesh (TIB) yesterday staged nationwide demonstrations demanding exemplary punishment to the culprits involved in question paper leaks.

The anti-corruption watchdog also demanded reducing the number of steps between preparing question papers and distribution, and increasing punishment for the leaksters up to 10 years of imprisonment.

The demands were raised at a human chain formed by TIB members and officials, students, teachers and social activists in front of TSC at Dhaka University.

TIB in association with two of its platforms --Socheton Nagorik Committee and Youth Engagement and Support -organised such programmes at 45 locations across the country on the eve of this year's HSC exams.

"The impact of question leak is very lengthy and dangerous, although it seems that it is a small corruption. Such impact exists till the professional life," said Mohammad Rafigul Hasan, director of research and policy of TIB. SEE PAGE 5 COL 4
