Runners

ast summer a bout of chikungunia stopped my running. The best I could manage on a good day was a short walk in the park. Many a runner passed me by during these walks. I have always known that different people run differently, but for the first time I started observing their running

And I realized there are so many ways to run!

The runner I admire most - or, let's face it, feel most jealous of - is the seasoned runner. This person's body parts move easily to the beat of an unseen inner drum, delicate and cadenced. Stepping softly to protect their knees and feet from the impact, they make running look effortless. The way they move their wrists or bob their head from side to side - it is as if a ripple passes over their body. This graceful runner seems not to run but to dance.

Then there are the vigorous, powerful runners. They remind me of soldiers exercising, forceful strides lunging forward, posture erect, muscles bulging, and no sign of fatigue. They look heroic, almost like they are going to charge into the battlefield. I have never aspired to be one of them; for me, running is very much an introspective act, not a martial one.

Once in a while, a voice inside my head says "That person should not be running" because even though this runner has come to the park dressed for a serious workout they are not physically fit for it. They warm up and stretch before confidently starting to run. But when they run into trouble, they have an almost surprised look on their face while panting for breath, as

if to say, "I used to be an athlete, so why is this so hard for me?" Many of them carry on relentlessly, varying their pace with their energy level; others drop to walking to catch their breath before valiantly resuming their run. But who is going to tell them that running while unfit is a recipe for trouble or even disaster?

Sometimes I am taken aback, like the pair I saw one evening. One was walking briskly while the other ran in slow motion. Keeping pace with each other they remained engrossed in conversation. As far as I could tell they moved in tandem for the duration of their outing, seemingly violating the laws of physics.

Masochist runners run to torture themselves. You can see that every limb of their body is protesting and their face is contorted, verging on pain. Yet they carry on, one painful step after another. Why, I wonder, would you do it if you are not enjoying it?

Sometimes I see runners who get carried away. They start walking vigorously and then break into a spontaneous run. From their clothes and shoes you can tell running was not their plan, but they could not contain themselves at the fresh air or feeling of freedom. Their running style and posture is atrocious but who cares, they are enjoying the moment!

As for me, who knows? I have enjoyed running for almost four decades, but how does that reflect in my running style? I guess that's for others to judge. Would I like to know how you would categorize my style? Err – probably not!

The anti-graft watchdog urges all STAFF CORRESPONDENT

The Anti-Corruption Commission (ACC) has requested the people to report to it if anyone, impersonating an ACC official, makes phone calls, sends electronic mails or communicates personally to discuss corruption allega-

The commission has recently learnt that several syndicates, impersonating ACC officials, are demanding financial facilities from people via phone calls, e-mails or fake notices for withdrawing graft allegations against them.

An ACC officer alone cannot bring or withdraw any allegation against someone; it is a team-work and is done after intensive investigation, said the anti-graft watchdog in a cautionary press release on Thursday.

To avoid unwarranted incidents, the ACC directed its investigation and inquiry officers to establish communication with alleged persons and witnesses only through letters.

Man, woman impersonating two accused confess they acted upon the lawyer's direction

Selim Mia and Hazera Begum, who impersonated two accused in two different cases, have recently given a description of how they acted upon the instruction of a defence lawyer.

Abdul Hannan, union parishad member of Akhaura Dakshin and general secretary of Akhaura Municipal Swechhasebak League, and one Shuva Begum of Razapur village are accused in two separate drug smuggling cases in which Selim and Hazera respectively

acted as their proxies. Advocate Dolonara Begum is the defence lawyer in both the cases.

In his confessional statement before magistrate's court on Wednesday, Selim said, "Hannan Member took me to advocate Dolonara's chamber. She

taught me how to copy his signature." "In front of her, I practiced it several times on a white paper to avoid any suspicion," said Selim. He also said he was offered an auto-rickshaw worth Tk 1.5 lakh.

Selim, impersonating Hannan, surrendered before the District and Sessions Judge's Court on March 11. The court sent him to jail in the drug smuggling case filed against the latter on December 13, 2014.

As the matter came to light, Brahmanbaria Bar Association has found that Dolonara, a few days back,

did the same in Shuva's case. In her confessional statement before police on Sunday, Hazera said the defence lawyer asked her to memo-

Sub-inspector of Brahmanbaria Sadar Model Police Station Sumon Chakrabarty, who interrogated Hazera, told The Daily Star that illiterate Hazera, who gave a thumbprint, was offered Tk 50,000 for the job.

Both Selim and Hazera were shown

arrested for cheating. The defence lawyer was also detained on March 30. She was later released on the pretext of being sick.

Road crashes claim 14 lives

Fourteen people were killed and six others injured in road accidents across the country yesterday.

Our Brahmanbaria correspondent reports, nine people were killed in separate road accidents on Dhaka-Sylhet highway in Narsingdi.

In Raipura upazila, four masons died on the spot when a Dhaka-bound bus, Anonnya, hit their motorcycle at Charabagh, said Bhairab highway police.

The dead, motorcyclist Yamin Mia, 24, of Shibpur upazila, Sohag Mia, 17, son of Sharif Mia, Dalim Mia, 17, son of Hafizuddin, and Ramjan Mia, 17, son of

Asad Choukidar, hailed from Morjal area. Vehicular movement was halted for half an hour in the area following the accident. Later,

highway police recovered the bodies and sent them to Narsingdi Sadar Hospital morgue. Meanwhile, three people, including a

rickshaw puller, died when a Habiganjbound bus named Agradut hit the vehicle

and a passerby at Madhabdi. Two of the dead were identified as Ratan Mia, 44, passenger of the rickshaw who

hailed from Birampur, and Mokbul, the passerby who hailed from Mymensingh. Meanwhile in Baghata, two persons were

killed when their motorcycle was hit by a

bus in Sadar upazila.

Separate cases were filed with police stations concerned.

Our Chittagong correspondent adds, a four-month-old boy was killed and three others were injured when a CNG-run autorickshaw carrying them was hit by an oncoming truck at Dantmara in Bhujpur union.

The deceased is Sabrin Hossain, son of Abdul Mannan in Bhujpur village. The injured -- mother and aunt of Sabrin and the auto-rickshaw driver -- were admitted to Fatikchhari Upazila Health Complex.

Police confiscated the truck but its driver managed to flee.
