Diarrhoea sees sharp rise

Affects capital, surrounding areas

The capital and its surrounding areas are suddenly witnessing a phenomenal rise in diarrhoea patients.

Diarrhoea cases usually increase during the summer, but this year the disease is being spread even before the summer reached its peak.

Higher temperatures in summer are suitable for growth of bacteria, virus or parasites in water and food.

Consumption of such unsafe water or food primarily contributes to the spread of diarrhoea in summer time, according to experts.

By far, the highest number of diarrhoea patients taking admission at icddr,b -- the world's largest diarrhoeal disease hospital -- in one day during the first week of April had been 450. But this year, since April 2

till yesterday, the hospital has been seeing close to or higher than 700 admissions a day.

Icddr,b admitted 752 patients on April 3, 788 on April 6 and 735 on April 7 -- a sign of unusual rise of the disease before peak of summer, said icddr,b officials.

By 6:00pm yesterday, a total of 578 people were admitted to the hospital with diarrhoea symptoms.

AKM Tariful Islam Khan, media manager at icddr,b, said 70 percent of the patients are adults and the rest are children. Among all, some 35 percent are suffering from severe dehydration.

Patients are coming from different parts of Dhaka and some are coming from the periphery of the city, he said, adding that the majority are from Jatrabari, Kadamtoli,

Dakkhin Khan, Badda, Lalbagh, Mirpur, Ramna and Mohammadpur areas.

Dr Azharul Islam Khan, chief physician and head of hospitals at the icddr,b, said many of the patients at the hospital reported to have drunk water, supplied in their areas, that emits foul odour. "... Based on patients' accounts, we think the unusual rise in diarrhoea cases is possibly due to the compromise in water quality."

"The water supplied by Wasa cannot become contaminated all on a sudden. What we suspect is that there have been development works on many roads in recent days. And it's possible that the water pipes in some of [those] places might have developed leaks, resulting in the contamination of SEE PAGE 5 COL 7

Fire breaks out at Gulshan Shopping Centre STAFF CORRESPONDENT

A fire broke out at a market in the capital's Gulshan-1 yesterday evening, burning goods in at least five furniture shops.

The fire originated on the first floor of six-storied Gulshan Shopping Centre around 7:25pm. It was doused by seven firefighting units around 9:30pm, said fire service officials.

No one was hurt as the market was closed, said Gulshan police.

The fire might have originated from an electric shortcircuit, said Faisalur Rahman senior station officer of Tejgaon Fire Service Station. A three-member probe body was formed.

Release trade union leaders

Demands int'l garment workers' rights body

The Clean Clothes Campaign (CCC), a global workers' rights body, called for an immediate release of seven trade union leaders of the Garment Workers Trade Union Centre (GWTUC) in Bangladesh from prison.

In a statement issued on Saturday, the CCC said the union leaders were detained last week on the basis of false charges filed by the Bangladesh Garment Manufacturers and Exporters Association (BGMEA), the garment makers' platform.

The CCC called for the release of the detainees including Joly Talukdar, KM Mintu, Monjur Moin, Jalal Howladar, Lutfar Rahman and Md Shahjahan, all leaders of the GWTUC.

The rights group also demanded release of Sazedur Rahman Shameem, a leader of Communist Party of Bangladesh, who was allegedly detained on April 1 after attending the court to request an extension of their bail.

Of the GWTUC leaders, only Montu Ghosh was granted bail. On April 5, the High Court agreed to grant an interim bail to the seven, but to date all remain in custody at Dhaka Central Jail, the CCC statement said. The BGMEA filed the complaint following a

protest by the workers of the Ashiana garments factory. The protest took place outside the BGMEA headquarters on January 31. The workers claimed that they initially went to the building, along with a number of

GWTUC leaders, after receiving a request to join a meeting with the owner of Ashiana garments. The meeting was for negotiating the payment of severance and unpaid wages, following the sudden and indefinite closure of the factory.

According to the testimonies taken from those who were present that day, around 450 workers arrived at the proposed time. But the BGMEA security informed them that

Rajib still traumatised

The Titumir College student, who lost hand in road accident, will take a few months to recover, say doctors

The physical condition of Government Titumir College student Rajib Hossain, who lost his right hand in a road mishap in the city five days ago, is improving, but he is mentally unwell, doctors said yesterday.

"There is a fracture in his skull, and a small injury in the brain. However it's now improving," said Prof MS Zaman Shaheen, head of orthopedic department at Dhaka Medical College Hospital (DMCH).

It will take a few months for Rajib to fully recover from the condition and then the operation to set an artificial hand can be conducted on him, they added.

Rajib's aunt Jahanara Begum said the recent CT scan and blood test reports

which came yesterday indicated improvement in his health.

However, Rajib is not taking his meals properly, she added. "He is traumatised," the aunt said.

Prof MS Zaman said Rajib may behave differently due to his head injury. But it will recover gradually, he hoped.

"We have to encourage him psychologically too," the doctor said.

Eldest among three brothers, Rajib lost both his parents. He worked for a computer shop in the Old Dhaka to pay for his own education.

The 22-year-old college student lost his hand after it got stuck between two speeding buses trying to overtake each other in the capital's Bangla Motor area on Tuesday.

Profusely bleeding, he was taken to

Govt to buy rice at Tk 38 per kg

decided to buy rice from millers at Tk 38 per kg this Boro season, which is 12 percent higher than the previous season. The decision was taken

yesterday at a meeting of the Food Planning and Monitoring Committee at the secretariat, presided over by Food Minister Qamrul Islam.

The minister said the production cost of rice in this Boro season was Tk 36 per kg and the purchasing price was fixed adding Tk 2. Last year, the production cost of Boro

Killed for a memory card!

A woman was stabbed to death and two of her family members were injured following a quarrel with neighbours over a memory card in Chittagong city's Sadarghat area on Saturday night.

Stabbed in the chest, Bali Begum, 25, was declared dead at Chittagong Medical College Hospital, said CMCH police.

Her mother Baby Akther, 50, and brother Suman, 28, were undergoing treatment at the hospital with stab injuries in different parts of their bodies, they said.

Nezam Uddin, officer-in-charge of Sadarghat Police Station, told The Daily Star that Suman lent a mobile phone set to his neighbour Akramul Haque, 18, as the latter wanted to make a call.

When Akram gave the cellphone back to Suman he refused to take it as he did not find a memory card.

Akram told Suman that there was no memory card in the phone, triggering an altercation between them, said the OC. Later, the family members of both the

two youths quarreled when Akram's brother Joy, 20, stabbed Bali, said the police official. The other two were injured

as they tried to save Bali. Police arrested Joy, his mother Mita Begum and brother Akram, said the OC.

"Nurul Huda is a listed Yaba peddler...," said Inspector Habibur Rahman of the detective branch, who led the drive. "While working as a bus helper, Nurul started the business and peddled the contraband pills from Teknaf to Chittagong. He knew the route very well.

He sold the pills to individuals as well as other sellers in the port city, he added. "Based on secret information, we intercepted his car in front of a community centre and arrested the duo. The vehicle is registered under his wife's name."

"Through selling Yaba, he accumulated a huge amount of wealth. He is also known as Nurul Huda Driver."

Inspector Habib said one Mohammed Ullah, 35, hailing from Teknaf used to supply the pills to Nurul. Mohammed Ullah is an accused in a narcotics case filed with Bakalia Police Station. "We are trying to arrest him."

Nurul is also an accused in two narcotics cases filed with Chandgaon and Chawakbazar police stations, said police sources.

recently and her mother has already sold all belongings to meet the expenses of the treatment. An additional TK 40 lakh is needed to cure her illness. Rabeya's family cannot


afford her treatment any further and has requested all to come forward to save the girl. Financial assistance can
