Pvt univ student demo adds to sufferings on roads

Commuters yesterday suffered hours of traffic jam as students of several private universities in the capital demonstrated on different city roads, demanding reforms in the quota system.

Hundreds of students blocked important thoroughfares causing severe gridlock.

Several hundred students of Daffodil International University (DIU) took to Mirpur Road at Sukrabad, in front of Rapa Plaza, around 11:00am. They demonstrated till 5:00pm, blocking one side of the busy road and its link

Rokibul Alam Lipton, a student at DIU, told The Daily Star that they called off their demonstration at 5:00pm. He said they will resume today morning.

"The existing quota system is illogical. We will continue demonstrating until the system is reformed," said Atiqul Islam, another DIU student.

Students of State University of Bangladesh and University of Liberal Arts Bangladesh blocked Satmasjid Road near Dhanmondi 27 at the same time. Police were present there. Due to the blockade, traffic came to a standstill. Students

left the area vowing to take to the street at 10:00am today to realise their demands. Severe gridlocks were also created on Pragati Sarani and in Gulshan-Banani areas as students of North South University, American International University of Bangladesh,

East West University and University of Information

Evidence found against five Jessore men

Says ICT probe agency

The investigation agency of International Crimes Tribunal yesterday said to have found evidence against five Jessore men over their alleged involvement in crimes committed during the 1971 Liberation War.

They were allegedly involved with Razakar Bahini, an auxiliary force of the Pakistan army, and committed crimes including killing and raping in Monirampur upazila of the district, said agency officials.

Agency Coordinator Abdul Hannan Khan said the investigators found involvement of at least 13 people who abducted, tortured and killed 11 people and raped four women.

But, eight of them have died already, so they will ask the prosecution to press charges against the five accused who are still alive, Hannan said.

Of the accused, Siddiqur Rahman Gazi, 70, sub-commander of Razakar Bahini's Monirampur upazila unit, is now in jail.

Sanaul Huq, co-coordinator of the agency, said Siddiqur was involved with Muslim League, an anti-liberation party during the Liberation War, and later got affiliated with the BNP.

The agency officials did not reveal the names of other accused as they were not arrested yet.

Abdur Razzak Khan, the case's investigation officer, said he will hand over the report to the chief prosecutor's office with a request to take necessary steps to secure arrest of the four accused.

The six incidents they were allegedly involved in are: abducting, torturing and killing Mokshed Biswas of Bhojgati village; abducting, torturing and killing Mojam Morol of Bijoyrampur; raping three women, and killing a two-year-old while raping in Dikdana and Noali villages; raping wife of a freedom fighter of Durbadangha for three days; killing three freedom fighters of Saraskata village and killing five other freedom fighters of Chinatola village.

GANG RAPE IN BUS 5 transport workers

remanded

A Dhaka court yesterday placed five transport workers on a three-day remand each in a case filed over a gang-rape incident in a moving bus on Dhaka-Aricha highway in Dhamrai on Sunday night.

Senior Judicial Magistrate Atiqur Rahman gave the order after Inspector Zakaria Hossain of Dhamrai Police Station, also the case's investigation officer, produced them before the court seeking a seven-day remand for each.

The accused are bus driver Babu Mollik, 24, his two assistants Abdul Aziz, 25, and Bol Ram, 20, and Shohel Rana, 20, and Mokbul Hossen, 40.

On Sunday, the 24-yearold garment factory worker boarded the bus around 10:00pm to go home after work.

She told police that the suspects locked the door and closed the windows

TACKLING GROWING RAPE INCIDENTS JP's Firoz Rashid for extrajudicial killing

Jatiya Party lawmaker Kazi Firoz Rashid in parliament yesterday recommended extrajudicial killing as a means to tackle the growing incidents of rape across the country.

Citing a recent incident when a rapist of a nineyear-old girl was killed in a "gun fight" with members of Rapid Action Battalion in Ashulia, Kazi Firoz said, "People want to see such incidents [killings of rapists]. The Rab members concerned should be awarded.'

Thesenior lawmaker from the opposition bench made the remarks as he spoke on a point of order.

"We cannot accept the recurrence of rape incidents and rape victims' going to court. People want to see immediate action against the rapists."

Referring to the incident of Zakia Sultana Rupa, who was killed after being raped in a bus in Tangail, Kazi : Firoz said the lower court has handed down death sentences to the ones who raped her. But, the offenders will have the option to go to the higher court, then to two other transport workers: the Appellate Division and finally to the president.

"We aren't sure whether their death sentences will remain upheld by the higher court. If we could ensure immediate and exemplary punishment to those culprits, we would've been able to avoid the recurrence of rape incidents in other places," he argued.

The country cannot sit idle if women do not feel safe on their way to and from their workplaces and any other destinations, the parliament member said, adding that since the extrajudicial killings have proved to be successful

beauty.

The bench of Justice Salma Masud Chowdhury and Justice AKM Zahirul Hoque issued the order with the rule after hearing a writ petition filed by Barrister Fazlur Rahman Milon, executive director of Justice Watch Foundation, a rights organisation. He submitted the petition on April 8 as a public interest litigation.
