suspect dies

An accused of lawyer Rathish murder case died at Rangpur Medical College Hospital on Friday night.

Police picked him up on March 30 for interrogation.

The dead, Milon Mohanta, 30, a resident of Rangpur city's Tajhat area, was the personal assistant of Rathish Chandra Bhowmik, 58. Amzad Hossain Don, jailer of

Rangpur Jail, said showing Milon arrested in the murder case on April 5, police produced him before a court which sent him to jail. Later in the day, Milon was admit-

ted to Rangpur Medical College Hospital as he fell sick. He died there around 9:00pm on Friday, said the

On Saturday, police handed over Milon's body to his family after an autopsy.

Rathish, public prosecutor at the Special Judge's Court in Rangpur, was murdered over alleged extramarital affairs between his wife Snigdha Sarkar Dipa and her colleague Kamrul Islam, police and Rab said earlier. Snigdha and Kamrul are teachers

at Tajhat High School, while Rathish was the president of the school managing committee. On information gleaned from Dipa, a team of Rab-13 dug out the

lawyer's body from an underconstruction building in the city's Tajhat Mollahpara area on April 4. Quoting Dipa, Rab Director General Benazir Ahmed on that day

said Dipa and Kamrul murdered Rathish at his home in Tajhat Babupara area on March 29 night. The Rab chief was speaking at a press conference at the Rab-13

Rangpur office. Police arrested five people, includ-

ing Dipa, Kamrul and Milon, in connection with the murder. All the arrestees gave their confes-

sional statements before the Additional Chief Judicial Magistrate's Court in Rangpur, said Abdul Mia, officer-in-charge of Rangpur Sadar Police Station.

Russia-West 'alienation' is worrying

Says German president

German President Frank-Walter Steinmeier yesterday voiced alarm over the growing "alienation" between Russia and the West, stressing the need for dialogue as post-Cold War tensions peak. Speaking to the Bild am Sonntag

newspaper, Steinmeier said last month's poisoning of a former Russian spy in England, which Britain and its allies blame on Moscow, was "a very serious incident".

"But we should be at least as worried about the galloping alienation between Russia and the West, the consequences of which stretch far beyond this case," the former foreign minister said.

Moscow vehemently denies involvement in the nerve agent poisoning of former double agent Sergei Skripal and his daughter, which triggered a wave of tit-for-tat diplomatic

expulsions between Russia and Western countries. A dispute over Western interven-

tion in Syria has dramatically added to the tensions in recent days. Defying Russian warnings, the

United States, France and Britain carried out air strikes to punish the regime of President Bashar al-Assad, a close Moscow ally, for an alleged deadly chemical attack on the town of Douma.

Russia on Saturday failed to win UN backing for a resolution that would have condemned the "aggression" against Syria, highlighting Moscow's isolation on the international stage.

Steinmeier said while it was right to show Russia its actions have consequences, as demonstrated by the sanctions imposed over the annexation of Crimea and the conflict in Ukraine, "we can't abandon direct dialogue".

He also cautioned against demonising an entire nation.

"Independently of Putin, we can't declare the whole of Russia, the country and its people, as our enemy," he said, warning there was "too much at stake".

On Syria, Steinmeier said there could be no improvement on the ground until US President Donald Trump and his Russian counterpart Vladimir Putin engaged with each

other in a constructive manner to try to negotiate a solution.

"Of course you can't do it without the regional neighbours in the end, but everything begins with the US

and Russia," he was quoted as saying. "Putin and Trump owe it to the

world to take the first step."

service recruitment comes from the merit list and the remaining 56 percent from various quotas. Addressing the protestors, the

shipping minister said, "You may not respect the freedom fighters, but [you] can't disrespect them." "Prime Minister Sheikh Hasina is

ruling the country with the spirit of liberation war. Is it right to give jobs

to the children of Razakar and Jamaat-Shibir?" he asked.

The parishad also announced a sixpoint demand, including exemplary punishment of those who created anarchy by spreading rumours in the name of quota reform movement, an enactment of a law similar to the Holocaust Denial Act and ensuring trial of those who demean freedom fighters, liberation war and Bangabandhu.

"You have seen students protesting for quota reform. Students can protest for any cause. But those who have attempted to kill Dhaka University's Vice-Chancellor...we have to find them," the minister said. At the rally, Mukijoddha Santan O

The movement turned violent on Sunday after police action against protestors. At least 100 people were injured and several others detained as violence flared up in Shahbagh and its adjacent areas.

concerns in different countries, including Telenor Myanmar, said Prince Mojumder, co-founder and chief executive officer of the company.

It picks up over 60 million calls a

Genex also serves multinational companies in Bangladesh but it is not the only one. Other companies compete for the work here in Bangladesh.

Acceleco is maintaining UK-based company metafour's accounts online. It has about 150 clients in the country and is gradually meeting business firms outsourcing demands in the accounting segment.

Government helpline 999 receives 15,000 calls every day and is run by the police. It too is attending the BPO Summit 2018. Wahidur Rahman Sharif, president

of Bangladesh Association of Call Centre and Outsourcing (BACCO), which organised the event, said some of their members were doing well in different countries. He said their target was to explore the untapped local market as well.

"Local market will be our practice field ..., " said Sharif.

Right now, global BPO market is about \$500 billion and Bangladeshi companies hardly grab \$180 million of that. Another \$120 million a year is earned from the local market, Sharif said.

This earning would exceed \$1 billion a year in the next three years, he hoped.

In different sessions of the first day of the summit, industry insiders said more than 40,000 people work in about 105 BPO companies in Bangladesh. They predicted that the number of workers would reach 100,000 by 2021.

Prime Minister's ICT Affairs Adviser Sajeeb Wazed Joy inaugurated the event at the Sonargaon Hotel while Telecom and ICT Minister Mustafa Jabbar chaired a session.

A large number of young men and women, mostly university students, went there on the first day. "Youths do not need to wait for

government jobs ... ICT has created a huge opportunity for them and now they can earn a lot of dollars through outsourcing, even staying at their rural homes," said Joy in the inauguration session, reports BSS. It has become possible because of

the government's policies, Joy said. "The present government has intro-

duced ICT education at primary level," he said, adding that he wants the youths and children of the country to know how to operate computers and understand the language of computer.

Industry leaders said BPO in the country began in 2008 with just 300 jobs, which now has turned into

Attending a session, Telecom Secretary Shyam Sundar Sikder said, "We want to increase our income from digital products, but in the education curriculum, digital contents like big data analysis, artificial intelligence, and IOT issues are fully ignored."

At least 20 foreign experts and 60 local speakers are sharing their knowledge and experience at the seminars being held on the side lines of the summit. Some companies were also doing on-the-spot recruitment.

journalists that when his wife's condition deteriorated on Friday morning. The on-duty doctor administered an injection to her. "After that, her condition began to worsen more." He said the on-duty doctor then requested them to take her to the ICU
