87pc vehicles violate rules

Finds survey by passenger welfare body; puts forward recommendations for safe roads

At least 87 percent buses and minibuses ply the roads in the capital recklessly in violation of traffic rules, creating anarchy in the public transport sector, said a passenger welfare platform citing its survey covering over one thousand vehicles.

"The management and order in the road sector has deteriorated severely," said Mozammel Haque Chowdhury, secretary general of Bangladesh Jatri Kalyan Samity, while presenting the findings at a roundtable at the Jatiya Press Club yesterday.

"Commuters, drivers, transport owners and traffic officials and highway police are acting at will. There are relevant laws and rules but nobody is following those. Actually there is no enforcement of laws on roads," Mozammel said in his written speech. Based on another survey conducted in 2015 in 16 districts

Tarique to be brought back by any means

PM says, slams attack on high commission in London

Prime Minister Sheikh Hasina yesterday expressed her firm resolve to take back BNP acting chairperson Tarique Zia from London by any means and bring him under the ambit of law.

"We'll bring him back to the country by any means Inshallah, and put him on trial," she said.

The prime minister was speaking at a reception accorded to her marking Bangladesh's becoming eligible for graduating to a developing country from a least developed one.

Govt took limited steps to prosecute rights abuses

Says US state dept report on Bangladesh

Bangladesh government took limited measures to investigate and prosecute cases of extrajudicial killings and enforced disappearances, said the US State Department in its 2017 Country Reports on Human Rights Practices.

"There were reports of widespread impunity for security force abuses... public distrust of police and security services deterred many from approaching government forces for assistance or to report criminal incidents," it said.

The annual report, released by the US Acting Secretary of State John J Sullivan in Washington on Friday, considered extrajudicial killings, torture, arbitrary or unlawful detentions, and forced disappearances by government security forces as the

HOPING against HOPE

Families of about 80 victims of enforced disappearance relive tragic events, still expect govt to wake up to their cries

For Rehana Banu Munni, visiting morgues and other places has become routine as she checks unidentified bodies to know if any of those was her younger brother's.

Selim Reza Pintu, a leader of Sutrapur Chhatra Dal, was picked up allegedly by plainclothes law enforcers from one of his relative's house in the capital's Pallabi on the night of December 11, 2013. He has been missing ever since.

Rehana and other members of her family desperately searched for Selim at every possible places, including police stations and Rab offices.

"You cannot live like this," an emotional Rehana told a "mass hearing" on enforced disappearance at the Jatiya Press Club yesterday.

"Don't you hear us cry and see our tears? Why have you

turned deaf and dumb?" she asked the government.

Members of around 80 families joined the programme under the banner of "Mayer Daak", a platform of victims' family members, from across the country. Speaking at the event, supported by rights activists,

family members slammed the state for denying justice to their dear ones. According to them, the incidents of enforced disappear-

ance took place in between early 2012 and late last year. Some victims never returned home while bodies of a few were recovered later.

While the families made repeated pleas for tracing the whereabouts of the missing people, the government on several occasions denied the involvement of law enforcement agencies in the incidents.


Run over by bus, teen loses leg
