Shomman Foundation awards people who made life easier for domestic helps in their households

Khairuzzaman Monnu hired Jharna as a domestic help in his house back in 2007. Widowed at an early age, she was given a shelter more than a simple livelihood.

Jharna found a new home and a family, which she started to consider as her own. And Monnu never treated her like anyone else other than his own sister. "I couldn't do much for her. But I never felt that she isn't

my sister," said Khairuzzaman, the head teacher at a Sirajganj school for persons with intellectual disabilities. His contribution for this destitute domestic help was

recognised yesterday at a programme at the capital's Chhayannaut Sangskriti Bhaban. In urban areas, helping hands and people doing so-called

lowly jobs like gardeners, cooks, and drivers are part of daily living. But their basic rights such as fixed wage, healthcare and proper accommodation are largely overlooked. Speakers at the programme said the government needs to

fulfil the needs of domestic helps under a legal framework. Moreover, a change in the mindset of the employers and their families is also important for the wellbeing of such workers.

"It is true that a faction infiltrated into the protest programme and that faction launched the attack on the vicechancellor's residence," he added.

Speaking about the quota system, the professor said a special privilege can be effective for a short period, but it should not continue for generations.

"I am also a freedom fighter. I do not think that the freedom fighters fought for any privileges. The government should reform the quota system to build the public administration on the basis of merit," he added.

Teachers will wage tougher move-

enforcing agencies or the university administration, warned Dhaka University's mass communication and journalism teacher Dr Fahmidul Haq.

"We gave silent consent to the issue but we could not resist ourselves from being vocal after seeing the incident of April 8," he said.

"If the guideline or a law is delayed to be formulated, we strongly demand that judges will have to be appointed as per the HC verdict on April 13, 2017," said SCBA President Advocate Zainul Abedin.

Formulate new Metro rail to be ready 4yrs earlier than planned

Claims Obaidul Quader

The country's first ever metro rail project will be completed by 2020, four years before the stipulated time, said Road Transport and Bridges Minister Obaidul Quader yesterday. The works up to Agargaon will be com-

pleted within 2019 and the entire works from Uttara third phase to Bangladesh Bank [at Motijheel] within 2020, he said. "The project is scheduled to be com-

pleted by 2024," Quader told reporters after joining a contract signing ceremony regarding the metro rail project at a Dhaka hotel. However, the overall real progress of the

project is 15 percent till April 16, 2018, according to the documents provided by the authorities to journalists yesterday. The government signed contracts with two

joint-venture companies for constructing a portion of metro rail, formally known as MRT Line-6, to give the project a further boost.

Works of MRT Line-6 are divided into eight packages. Package 5 and 6 are for the tions from Agargaon to Motijheel. Dhaka Mass Transit Company Ltd

(DMTCL), the government company formed

construction of viaducts and elevated sta-

to implement the metro rail lines, singed two separate contracts for package 5 and 6. DMTCL signed Tk 1,855 crore contract for package 5 with a joint venture of Takken

Corporation, Abdul Monem Ltd and Abenikko. It signed Tk 2,332 crore deal with another joint venture of Sumitomo Mitsui Construction Co Ltd and Italian-Thai Development Public Company Ltd for package 6. Among the firms, Abdul Monem Ltd is a Bangladeshi one.

DMTCL Managing Director MAN Siddique singed for his company while Tsuyooshi Nishimura and Ikuo Kitada singed for their respective joint venture.

Under the project, they will construct 8.1 kilometre viaducts and seven stations from Agargaon to Motijheel.

ROAD ACCIDENTS

2,123 killed, 5,558 injured in four months

Says Jatri Kalyan Samity statistics STAFF CORRESPXONDENT

At least 2,123 people were killed and 5,558 others injured in 1,871 road accidents in the country during the last four months, a passenger platform said yesterday.

The figures are higher than that of the same period of time of last year.

Bangladesh Jatri Kalyan Samity prepared the statistics on the basis of news reports published by national and local newspapers and online news portals, says a press release. A total of 1,979 people were killed and 4,727 others injured in 1,765 accidents in

the first four months of last year, it says. The statistics came when mismanagement in road transport sector, reckless driving and race among vehicles to pick passen-

gers came to the fore. The organisation said 514 people were killed in 499 accidents in January, 459 killed in February, 483 in March and 461 in April.

Seven cops sued for framing 2 in yaba case

A woman has sued seven policemen, including an officer-in-charge, accusing them of framing her son and his friend last week in what she released hours later. says was a fabricated yaba case.

Meherunnesa, a resident of the port city's Pahartali area, filed the case yesterday with the court of Additional Chittagong Metropolitan Magistrate Shahdat Hossain Bhuiyan against the policemen of Pahartali Police Station, said her lawyer Babul Das.

The accused are Officer-in-Charge Rafigul Islam, subinspectors Abu Sayed and Uttam Dhar, assistant sub-inspectors Fazlul Bari and Jintu Barua, and constables Nazim Uddin and Mohiuddin.

The court ordered Police Bureau of Investigation to investigate the case and submit its report in 30days, Babul told The Daily Star.

Quoting the case statement, he said a team of police led by SI Abu Sayed picked her son Mehedi Hasan

Nayeem and his friend Tanjil Islam up minutes after they left her house on Wednesday night.

and his friend had been watching an IPL match before they went outside and got picked up. When Meherunnesa went to the

police station and asked about her son, SI Abu Sayed allegedly demanded Tk 3 lakh for their release, Babul said.

As the woman refused to give money, the officer verbally abused her, headded.

Police produced Nayeem and Tanjil before a court the next day stating that they were arrested in possession of 52 yaba pills, Babul

added. Contacted, OC Rafigul Islam said police found the yaba pills by frisking the two young men. He added that Nayeem was arrested in 2017 in a case filed with Kotwali Police Station.
