## Pass rate 5-year low in Ctg

The success rate in this year's SSC examinations has hit a five-year low in Chittagong. It fell around 8.5 percentage points to 75.5 percent from last year's 83.99 percent. The pass rate was 90.45 percent in 2016, 82.77 in 2015 and 91.4 in 2014. Md Tawarik Alam, acting exam controller of Board of Intermediate and Secondary Education in Chittagong, announced the result yesterday. He said they found four reasons behind the lower pass rate. "Rumours of question leak; students' poor performance in math and humanities; poor results of students in three hill districts; and a lack of quality teachers in remote hill areas -- all these had a cumulative effect on the results," he said. The number of GPA-5 achievers also dropped. This year, 8,094 students got GPA-5 while it was 8,344 last year. Meanwhile, students expelled for adopting unfair means also rose to 75, highest in the last five years. According to the board's data, number of educational institutions with cent percent pass rate also dropped. This year, the number stands at 27 compared to last year's 56. At least 13.5 lakh students appeared at this year's exam from 1,023 schools in Chittagong.

## 7 SSC examinees attempt suicide in Rangpur

### Dakhil student kills herself

Failing to secure pass marks in this year's SSC and equivalent examinations, at least eight examinees tried to commit suicide in Rangpur yesterday. Among them, a Dakhil examinee eventually died at Rangpur Medical College Hospital in the afternoon. Rokeya Khanam of Haridebpur village under Rangpur Sadar upazila was found hanging from the ceiling of a room in her house. The seven others, six girls and one boy, were also admitted to RMCH. One of the girls tried to commit suicide by taking poison while the rest tried to hang themselves, according to family members. Dr Moklesur Rahman of the hospital said the seven were in critical conditions. Meanwhile, none of the students of five schools under

Dinajpur Education Board were able to pass this year's SSC examination. The schools are Thutiapukur Girls' High School and Sarbananda Girls' High School in Gaibandha; Bhadai Dakshin Para High School in Lalmonirhat; Nalbari Girls' High School in Dinajpur; and Laxmirhat High School in Panchagarh. Tofazzur Rahman, controller of the board, said a total of 15 students from the five schools sat for the exams, but neither of them succeeded. "We would recommend the education ministry to take action against the schools," he said at a press conference at the board office. A total of 1,86,644 students from 2,619 schools under Dinajpur and Rangpur regions sat for the SSC exams. Of them, 1,44,876 came out successful. Eighty-four schools secured cent percent pass rate.

## 'Don't sign blank cheques

### Says ACC chief, urges women not to aid husbands in corruption

Anti-Corruption Commission (ACC) Chairman Iqbal Mahmood yesterday warned that those women who assist their husbands in amassing illegal wealth, will also have to face punishment for corruption. "Husbands often keep wealth in the names of their wives to cover up their corruption. I call upon women not to assist their husbands in corrupt activities; otherwise, they will also have to face trial," he said. Iqbal said this while addressing a views-exchange meeting titled "Families' liabilities behind illegal wealth and income: Women's role, risk and duty" organised by Transparency International, Bangladesh (TIB) at its Dhanmondi office in the capital. TIB presented a work paper in the meeting. As per the paper, ACC is enquiring 118 allegations where it has been found that husbands amassed wealth illegally but kept those in the names of their wives. ACC received those allegations in between 2015 and 2017. The commission is investigating 30 such cases and submitted charge sheets in 14 cases, reads the paper.

In 29 cases between 2007 and 2018, 29 women were sentenced to imprisonment and fined for assisting their husbands in amassing wealth beyond the known source of income or concealing information of wealth, according to the paper. Iqbal said, in many cases, women do not know that they are becoming victims. Addressing the women, he said, "...Don't sign blank cheques." Without ensuring freedom for women, development is not possible, he said. TIB Executive Director Dr Iftekharuzzaman said the impact of corruption is high among the weak section of society. From that perspective, its impact is high on women as they are not empowered, he said. Shaheen Anam, executive director of Manusher Jonno Foundation, said women should be empowered and given due dignity. "In our society, women's opinions are not given due importance; that is why, they cannot raise voice against corruption in and outside home," she added. Rokeya Kabir of Bangladesh Nari

Progati Sangha said the society is dominated by men. As a result, women have less scope to make decisions, she said. Eminent Political Scientist Dr Dilara Choudhury said, "We live in a society where amassing wealth illegally is not considered a crime. Here, corrupt persons are honoured." Asif Nazrul, a professor of law at the University of Dhaka, said if wives become strict, husbands will not be able to do corruption. Farah Kabir, country director of ActionAid Bangladesh, said corruption is ingrained in the society where women easily become victims of corruption. Referring to the example of micro-credit, she said husbands, brothers and fathers trap rural women in applying for loans. Later, they misappropriate the funds, leaving the women solely responsible for the loans, she said. "I request ACC to air advertisements in national radio and television to make women aware of how they become victims of corruption," she added.

## COP, WIFE MURDER Domestic help Khadiza acquitted

A Dhaka court yesterday acquitted domestic help Khadiza Akhter Sumi, a co-accused with Oishee Rahman, in the case filed for killing a police inspector and his wife in 2013. She was made an accused for assisting Oishee in removing the bodies of the couple. Khadiza was cleared of the charges as the prosecution failed to prove the allegations brought against her. Judge Md Al Mamun of Dhaka Juvenile Court said while passing the order in her presence. Soon after the verdict, she broke down in tears and expressed satisfaction. Earlier on April 22, prosecution and defence lawyers completed their arguments. During the trial, the court recorded statements of 23 prosecution witnesses. On August 16, 2013, Oishee stabbed dead both of her parents, Mahfuzur Rahman, inspector of Special Branch of Police, and Shapna Rahman in their

Chamelibagh residence in the capital. Khadiza gave confessional statement before a magistrate on August 24, 2013 and said she saw the killing of the couple by their daughter and assisted her to remove the bodies. In March 2014, Abul Khaiyer Matubbar, inspector of Detective Branch of Police and also the case's investigation officer, submitted two charge sheets -- one against Oishee and her two friends and the other against Khadiza. The juvenile court framed charges against Khadiza on May 20, 2014 and recorded statements of prosecution witnesses. In 2015, the Speedy Trial Tribunal-3 of Dhaka gave death sentence to Oishee. Her friend Mizanur Rahman Roni was sentenced to two years' rigorous imprisonment for giving her shelter. The High Court on June 5 last year commuted Oishee's death sentence to life in jail.

## Maintain cordial relations with other forces IGP says

Inspector General of Police (IGP) Mohammad Javed Patwary yesterday directed police personnel to maintain friendly relations with members of other forces while discharging their duties. The directive came from a meeting held at police headquarters, said an official release. "We have to behave professionally, maintaining mutual respect and friendly relations with members of other law enforcement agencies while performing our duties," the IGP said. Police personnel should tackle unwarranted incidents with patience and in line with the law, he said, adding otherwise, actions will be taken against them after investigation. He asked all unit chiefs of police to circulate the directive to officers and other unit members. The reason of the directive was not mentioned in the press release. Earlier in 2016, Rapid Action Battalion sent a letter to the home ministry complaining of police excesses against its members, saying the prevailing situation is so tense that it might go out of hand anytime soon. A list of six such incidents was attached with the letter.
