### DMCH doc stabbed on DU campus

A physician of Dhaka Medical College Hospital was stabbed by unidentified criminals on Dhaka University campus yesterday, police said.

Samiul Alam Sohan, 45, a doctor at burn and plastic surgery unit of DMCH, was attacked by two unknown assailants near Dr Muhammad Shahidullah Hall around 11:00am, Abul Hasan, officer-in-charge of Shahbagh Police Station, told The Daily Star.

Samiul was riding a motorbike on way to his workplace when two attackers, also on a motorbike, stabbed him in the back and sped away, the OC said, adding that the victim was injured critically.

The 25-centimetre-long gash from the neck down on Samiul's back needed 42 stitches, said Shariful Islam, a physician of DMCH. His condition was stable and he was under observation at DMCH, Shariful added.

Samiul is a leader of Doctors Association of Bangladesh (DAB), according to DMCH sources.

"I still hold the post of prosecutor of International

Crimes Tribunal. None has suspended me," she said. "According to the International Crimes Tribunal's Act, a prosecutor has jurisdiction to work as an investigation officer. So I have the right to investigate any case. And various strategies need to be taken to investigate things. So I can take any necessary strategy for the sake of investigation," Tureen said.

"So far what I've done at the International Crimes Tribunal, the higher authorities were informed. Since the matter is being investigated, for the sake of proper investigation, I don't want to make any comment. After the investigation, I will share my opinion with all," she added.

### 373 tonnes of Indian aid

He said Bangladesh also seeks India's support in putting international pressure on Myanmar to take their citizens -- the Rohingyas who have taken shelter in Bangladesh -- back to their homeland.

Bangladesh wants a permanent solution to end the Rohingya crisis and the problem cannot be addressed through humanitarian assistance only, Maya said, adding that citizens of Myanmar will have to go back to Myanmar. Seeking a special role from India in this

regard, the minister said, "It is more essential to send back the Rohingyas to their country with due dignity, rather than sending relief materials for them."

Indian High Commissioner Shringla said, "It is our endeavour as it is yours to ensure that these people return to their homes as soon as possible."

... today we have seen the relief consignment which has been brought by INS Airavat which is essentially to deal with the monsoon affecting the people living in the refugee camps," he said, adding, "We are also working to provide low cost housing and other socioeconomic benefits to the Rakhine state that will facilitate the safe and sustainable return of the refugees.

"India has always stood by Bangladesh in times of need. Ours is a relationship based on trust, friendship and shared martyrdom that goes beyond strategic partnership."

Just after the onset of the humanitarian crisis last year, Indian External Affairs Minister Sushma Swaraj had announced "Operation Insaniyat" and the first consignment of relief supplies arrived by both air and sea within a couple of weeks of that announcement, Shringla said.

Another Indian vessel carrying one million litres of kerosene and 20,000 kerosene stoves will arrive in Bangladesh shortly to help the refugees in the monsoon season since it is very difficult to collect firewood during rainy weather, the high commissioner also said.

Disaster Management and Relief ministry Secretary Shah Kamal, Chittagong Deputy Commissioner Ilias Hossain, Additional Deputy Commissioner Habibur Rahman and Chittagong Port Member (administration and planning) Zafar Alam were present among others.

INS Airavat will stay at Chittagong port for three days to offload the relief good.

Last year in September, India sent 981 metric tonnes of relief aid including rice, sugar, salt, oil, tea, noodles, biscuits and mosquito nets.

Focusing on managing land for agricultural purpose, President of Krishibid Institution Bangladesh (KIB) AMM Saleh said arable land is decreasing, so there should be a policy regarding the use of land.

Poultry farm entrepreneur Shirin Sultana, also a national-level wrestler, said the price of poultry feed needs to be reduced so that poultry farmers can sell their products at a low cost and still make profit. She also stressed on integrating information regarding new advancements in agriculture, among the farmers.

Coordinator of Prothom Alo's youth programme Munir Hasan said youth must come forward in agriculture, to bring innovations to the sector.

Dr Atiur Rahman, former governor of Bangladesh Bank, said half of the country's population will live in urban areas by 2030, leading to a further clumsy situation.

Therefore, he underscored the need for planned development onwards.

Dr Sadiq Ahmed, vice chairman of Policy Research Institute, said only 12 percent of the country's population have access to piped water and only 20 percent of Dhaka dwellers have sewer service.

PKSF Chairman and noted economist Dr Qazi Kholiquzzaman Ahmad said recommendations of detailed area plan (DAP) of Dhaka are not implemented as expected, while population of this city is increasing consistently at 4 to 5 percent rate annually.
