Sri Lankan parliament on Wednesday approved a new law to establish courts to handle cases related to bribery and corruption to speed up cases that have dragged on for years. Currently, Sri Lanka's courts, which act as investigative magistrates weighing evidence before a trial can be started, can take up to five years before a defendant

even reaches the dock. "Parliament has responsibility over public money and all members have a right to take legal action against the people who wasted it," Justice Minister Thalatha Atukorale told parliament.

Death toll in Kabul attacks rises to 10

Pak top judge orders first official probe

Pakistan's top judge has ordered the first official investigation into the country's deadliest terror attack, a massacre at a school that killed more than 150 people in 2014, authorities said yesterday.

Relatives of the victims -mainly children -- have long called for an accounting of the security and intelligence failures that allowed Pakistani Taliban gunmen to storm the school, run by the powerful military, in the northwestern city of Peshawar on

December 16 that year. No government or military official has ever been held to account for the security failings. Criticism of Pakistan's powerful armed forces, especially their counter-insurgency operations, is largely seen

as a red line in the country.

Supreme Court Chief Justice Mian Saqib Nisar ordered the formation of a judicial commission to examine the attack during a court hearing in Peshawar Wednesday, Abdul Latif Yousafzai, advocate general of Khyber Pakhtunkhwa

province, told AFP. The inquiry was set to be completed in two months, he added.

Summit set for Singapore to work around curbs

Trump says he will meet Kim on June 12 to discuss denuclearisation, welcomes three American prisoners freed by North Korea

US President Donald Trump yesterday announced his historic summit with North Korean leader Kim Jong Un will take place in Singapore on June 12.

"We will both try to make it a very special moment for World Peace!" Trump said in a tweeted announcement.

The location and date of the summit -- the first ever between a sitting US president and a North Korean leader -were revealed hours after three American prisoners were released by North Korea and arrived back in the United States.

to the three men "who have been detained in the DPRK for their anti-DPRK hostilities", according to KCNA.

Meanwhile, Trump greeted three Americans released by North Korea at an air base near Washington early yesterday.

Trump and first lady Melania made the short helicopter ride from the White House to Joint Base Andrews to personally welcome Kim Hak-song, Tony Kim and Kim Dong-chul back to the United States, after their release.

SCRAPPING OF IRAN NUKE DEAL

US sanctions could well lead to

As the Iran nuclear deal lies in tatters after US President Donald Trump walked out on it, India finds itself back on familiar territory of having to stay engaged with Tehran despite a coming rash of US sanctions.

Playing safe, the India's Ministry of External Affairs said on Wednesday, "India

has always maintained that the Iranian nuclear issue should be resolved peacefully through dialogue and diplomacy by respecting Iran's right to peaceful uses of nuclear energy as also the international

community's strong interest in the exclusively peaceful nature of Iran's nuclear programme. All parties should engage constructively to address and resolve issues that have arisen with respect to the Joint Comprehensive Plan of Action (JCPOA)."

India was one of the countries most relieved when the JCPOA was signed in

2015, with PM Narendra Modi describing it as a "triumph of diplomacy and sagacity". During Iranian President Hassan Rouhani's visit here earlier this year, a joint statement recorded India's support, describing the deal as a "crucial contribution to the nonproliferation framework and international peace, stability and security".

India came under intense US pressure from 2011 regarding its exposure to Iran and the Persian nation slipped from being India's top source for oil, replaced by Iraq and Saudi Arabia. In 2018, India

promised to up its offtake of oil from Iran. This may be impacted.

During the first round of sanctions, India built an alternative system of engaging with Iran while keeping its nose clean with the US — like using UCO Bank for payments. Those same processes will kick in this time too, officials said.

41 killed in Kenya after dam collapse

2,000 people left homeless after weeks of heavy rains

At least 41 people died after a dam burst in central Kenya, police said yesterday, as residents described muddy waters ripping through their homes in what one survivor called "hell on earth".

After a severe drought, weeks of torrential rains in Kenya have led to flooding and mudslides that have left 172 dead.

The private Patel dam, used for irrigation and fish farming, burst its earthen banks on Wednesday evening in Solai, near the Rift Valley city of Nakuru, regional police chief Gideon Kibunjah told AFP.

The raging waters wiped out two villages, a local resident



said, while power lines were swept away, leaving many without electricity. The search for victims hampered by heavy rains yesterday afternoon.

More than 2,000 people are said to have been left homeless. "We have 41 people dead from this tragedy," Kibunjah said, adding 20 of them were children. He said the search for

victims was still going on. "It is a disaster because most people were asleep when the tragedy occurred and their houses were swept away."

He said 36 people had been hospitalised. Survivor Ngugi Njoroge said he and his family had been having dinner when there was a "loud explosion of water that washed away our home."

REUTERS JOURNO CASE Whistleblower details ops to Myanmar court

A Myanmar policeman now serving a prison sentence gave more details to a court on Wednesday about how he says two Reuters reporters were framed by police, in what has become a landmark press freedom case for the Southeast Asian nation.

Police captain Moe Yan Naing, 47, who since his original testimony on April 20 has been sentenced to a year in jail for violating police discipline, gave a blow-by-blow account of how he says a police chief ordered subordinates to give "secret" documents to Reuters reporter Wa Lone in a sting operation.


"I gave the testimony as I know and as I saw," Moe Yan Naing told reporters after the hearing. He said he did not regret giving his testimony.

Lead prosecutor Kyaw Min Aung did not respond to a request for comment after the hearing.

Myanmar government spokesman Zaw Htay said: "It will be carried out according to the law. The court is free, impartial, independent and reliable. We guarantee that the defendants will have their own rights, which means choosing their own lawyers etc."
