## BCL leader Rony among three sued for defamation

A defamation case has been filed against three including former general secretary of Bangladesh Chhatra League's (BCL) Chittagong city unit, Nurul Azim Rony, and the news editor of local daily Dainik Azadi yesterday.

Tanjirul Haque Chowdhury, a member of BCL's city unit, lodged the case with the court of Chittagong Metropolitan Magistrate Mehnaj Rahman. The other accused is Azmir Hossen alias Azmir Shah, 28, a BCL activist.

After lodging the case, the court directed officer-in-charge (OC) Bakalia Police Station to investigate it and asked to submit the report by June 21, said Tanjirul's lawyer Advocate Amena Begum.

According to the case statement, a team of DB led by Assistant Commissioner (AC) SM Mobassher Hossain detained Tanjirul along with Md Sharif and Md Abu Tayeb on February 15 in connection with a case filed under section 57 of ICT Act from city's Charchaktai area.

Later DB released Sharif and Abu after verifying their details, said the statements.

On February 16, Dainik Azadi ran a news on its back page with the headline "BCL leader among three held" stating that "witnesses said yaba pills were seized during the arrest of the trio including the BCL leader".

Azmir and Rony circulated the news from their respective Facebook accounts, giving their own views.

The complainant's lawyer Amena Begum said DB men did not seize any yaba from his possession but the newspaper and Facebook statuses of the two BCL men tarnished the image of Tanjirul Haque.

However, after filing the case, Nurul Azim Rony wrote on his Facebook that he shared the news on social media as such kind of BCL men tarnished the image of Chhatra League.

"And the so called BCL man filed the defamation case against me after coming out of jail," wrote Rony.

# Horror far from over for Satkania stampede survivors

Eleven-year-old Fatema Akter is still in disbelief that her mother is no more, despite watching helplessly as her mother was engulfed by a stampede on Monday.

The third-grader at a local primary school in South Dehmsha village of Satkania went to collect iftar essentials with her mother Rina Akter, 36, early on the day.

Seeing excessive crowd on the spot at Gatiyadanga village of the upazila, her mother did not allow her to stand in the queue. She herself stood in line and left her daughter nearby at a safe space.

"She was waving at me from the queue and gestured to me to stay safe," Fatema told this correspondent. "When the gate opened, I heard a sudden commotion in the queue. All the women ran towards it hurriedly, and some of them fell down."

"I was trying to find my mother but I did not see her as women were falling down on one another," she continued, adding, "I got frightened and started crying for my mother, until a local person took me away from the spot."

"As the situation calmed down, I came back to the spot looking for my mother but in vain," she said. "Then an

uncle of mine said that my mother was lying unconscious at a corner... I rushed there, and kept calling out to her but she did not reply."

"I never heard my mother's voice again," she burst into tears.

Nurul Amin, an uncle of Fatema, said his niece cannot sleep at night since the incident. "She wakes up in the middle of the night and starts crying," said Amin.

Fatema's younger brother Raihan, 6, still does not understand that his mother is no more. He thinks she has gone some place.

The girl was admitted to Dhaka Medical College Hospital (DMCH). She is undergoing treatment at the One-Stop Crisis Centre (OCC).

## ECHO, Unicef join hands to protect children, women

European Civil Protection and Humanitarian Aid Operations (ECHO) and Unicef have teamed up to provide more protection for nearly 42,000 children, adolescents and young women in Cox's Bazar.

The ECHO has provided US \$2.6 million to Unicef to ensure that children, adolescents and young women can live in a safe and protective environment free from Gender Based Violence (GBV) and with better access to social services.

The measures will benefit 41,500 children and adolescents living in Rohingya camps as well as local Bangladeshis, known as the host community, according to a Unicef press release yesterday.

Myanmar have arrived in Cox's Bazar since cal child protection services. August 2017 -- more than half of them (an

estimated 58 percent) are children.

The Rohingya population in Cox's Bazar, particularly children, adolescent girls and young women, are highly vulnerable. They face significant risks in addition to disease outbreaks. The host community has also been under pressure since the arrival of refugees.

"Many of the refugees who have fled from Myanmar have experienced violence and traumatic events," said Edouard Beigbeder, Unicef representative in Bangladesh. "This initiative will allow us to protect the most vulnerable..."

Some of the problems encountered in the camps by children, adolescents and young women are not uncommon in the host community.

Unicef is providing more than 1.82 More than 693,000 refugees from lakh children and adolescents with criti-

The US administration "unlawfully" opened its embassy in Jerusalem, said the OIC on Monday terming it a "clear violation" of international law and legitimacy and in clear contempt of international community's position regarding Jerusalem.

The OIC said it considers this action as an attack on the rights of the Palestinian people.

It undermines the standing of the United Nations and rule of international law, and thus represents an affront to international peace and security; as expressed at the Extraordinary OIC Islamic Summit held in Istanbul on December 13, 2017, and also by the international community at the UN General Assembly held on December 21, 2017. Bangladesh has con-

demned the use of force by the Israeli authorities against the Palestinians, which has left scores of Palestine civilians dead and several thousand injured. Bangladesh called on the international community to

put pressure on Israel to stop the atrocities immediately, said a foreign ministry statement. Bangladesh also expressed its dismay at the

United States' move of shifting its embassy to Jerusalem and stressed on preserving the legal status of Jerusalem within the framework of relevant UN resolutions. Bangladesh reaffirmed its

position in favour of establishing the State of Palestine on the basis of the two-state solution and on the pre-1967 borders with East Jerusalem as its capital.
