Newly-built bus terminal abandoned due to lack of approach roads

An apocalyptic atmosphere pervades the bus terminal in Char Sujanagar village of Pabna's Sujanagar upazila. Overgrown with grass, strewn with rubbish and cow dung, the hoped-for transport hub was built at a cost of Tk 1.74 crore by Sujanagar municipality, with construction completed in 2016. But the brand new terminal has never seen a bus. For want of approach roads it remains abandoned.

"We have already taken the initiative to make a two-kilometre concrete road to link the terminal with the upazila headquarters," says the local mayor Md Abdul Wahab. "The municipality has acquired two acres for the purpose. At a cost of Tk 3.3 crore, road construction will soon begin."

The municipality told The Daily Star that any repair work is the responsibility of the construction firm since they are yet to take charge of the building. "Tk 30 lakh is yet to be paid to the construction firm. They have to hand over a building that is ready to use, and that includes repair work," says the mayor.

In the meantime the project's mishandling is a source of frustration for locals. "It is ridiculous that we have a newly-built terminal abandoned and on the verge of destruction while the people of this municipality still endure the traffic jams caused by buses being stranded in the upazila headquarters," says one resident, Md Sadek Ali.

Schoolboy Police yet to arrest found dead rapist of schoolgirl

The body of a schoolboy was found in Sezamura area under Bijoynagar upazila of the district yesterday.

The deceased was identified as Abdul Mannan, 16, son of Abdul Karim of Kalachora village, and a Class X student of Kalachora High School.

Quoting family members, police said Mannan didn't return home after harvesting paddy from a field near the Rupa river on Friday afternoon.

Mannan drowned in the river due to onrush of water, said Md Ali Arshad, officer-in-charge of Bijoynagar Police Station.

Informed by locals, police recovered the body from the area yesterday morning and sent it to Brahmanbaria Sadar Hospital morgue for autopsy, said the OC.

Forced settlement!

Rape of class V girl was settled for Tk 20,000 in Habiganj's Chunarughat

A Class V girl student, raped allegedly by a neighbour on May 2 and 3 at her house in Habiganj's Chunarughat upazila, is undergoing treatment at hospital while the accused remained scot-free after paying Tk 20,000 in an out-of-court settlement mediated by a local councillor.

The victim's father filed a case over the incident on Wednesday night, naming Ujjal as the prime accused.

He alleged that police have not arrested Ujjal although he is moving freely.

The girl's parents left for a wetland area in search of work on May 2, leaving the girl alone at home.

Taking the opportunity, a neighbour named Ujjal Mia, 37, drugged and raped the child for two consecutive nights.

Locals learned about the incident as the victim suffered severe physical complications including bleeding following the abuse and her parents also returned home after being informed.

Annika Das, organiser of Brac's social empowerment programme, arranged the girl's admission to Habiganj Sadar Hospital.

"Ujjal is known as a miscreant in the area and two of his three wives left him," she said.

Although the minor girl suffered serious physical injuries due to brutalities by Ujjal, local councillor Kajal Mia arranged a socalled settlement of the matter through a salish (village arbitration), asking Ujjal to pay the victim's family Tk 20,000, said Tofazzal Sohel, former organising secretary of Bangladesh Group Theatre Federation's Sylhet divisional unit.

Asked about the matter, Kajal Mia said, "The girl's family is poor. They will not be able to go through with the legal process. So, the matter was settled by making Ujjal pay a compensation of Tk 20,000."

Police said they are trying their best to arrest the rapist, who went into hiding.

Miners reject talks offer, continue strike

Bangladeshi miners at Barapukuria Coal Mine Company Ltd (BCMCL) and villagers affected by land subsidence nearby continued their indefinite strike yesterday as no effective steps have been taken to resolve the ongoing crisis.

Due to the strike, coal production remained suspended for the seventh consecutive day yesterday, BCMCL Managing Director (MD) Habib Uddin Ahmed said.

The agitating miners and affected villagers encircled the BCMCL complex from outside and resisted movement of about 150 Bangladeshi officials and 300 foreign nationals. But the confined officials were allowed to buy food, medicines and other essentials under police protection on Friday night. MD Habib said BCMCL authorities requested the agitating

miners and villagers to sit for talks with Petrobangla chairman to reach a solution in this regard, which the latter rejected. BCMCL Miners and Workers Union President Rabiul

Islam and its Secretary Abu Sufian at a press conference in front of the coalmine compound yesterday said they won't be sitting with anybody unless the four cases, including two in 2014, filed against them are not withdrawn immediately.

Around 1,000 miners and villagers affected by land subsidence in Parbatipur went on the indefinite strike on May 13 demanding implementation of their 13-point and six-point demands respectively.

Meanwhile, the agitating miners demanded removal of BCMCL MD Habib Uddin, Secretary Kashem Prodhania and GM (Admin) Masudur Rahman.

Hundreds of farmers in Kalmakanda upazila of Netrakona are facing great trouble in harvesting their Boro crops after the embankment of a beel has broken down due to heavy rain and onrush of water from hills across the border.

The farmers in eight unions also faced disaster due to flood last year, but this year they are facing sudden flood and heavy rain, locals said.

Boro paddy on around 28 hectares of land went under water as the Medhikanda village, said he cultivated embankment on Mandaura Beel, a local water body in Pogla union, broke down on May 12, and around 120 farmers were affected, said Kalmakanda Upazila Agriculture Officer (UAO) Abdullah Al Mamun.

There are around 150 hectares of land in the area and crops on 122 hectares have been harvested, he added.

Locals claimed that nearly 50 percent of the standing crop in the beel area was affected in the flood, and the farmers are still struggling to harvest their produce. They added that adjacent unions were also affected.

Now, it has become difficult to harvest the paddy from knee and ankle deep water, farmers said.

"The rate of day labourers has also gone up in recent days, making it more difficult for us," said Abdus Salam, a farmer of Munshipur village.


"The situation has put us in critical condition as the price is not reasonable and the NGOs are putting pressure on us to repay the loans," said Phool Banu, a farmer of the same area.
