Mercedes-Benz to make Tesla-rivalling electric compact car

Daimler will invest 500 million euros (\$589) million) in Hambach, France, to start producing a small compact electric Mercedes-Benz in addition to its electric cars currently manufactured there for the Smart brand.

It plans to launch more than 10 electric vehicles for Mercedes-Benz Cars by 2022 as U.S. rival Tesla struggles to ramp up production of its Tesla Model 3.

"The Smart plant in Hambach will become a part of our global compact car production network with the lead plant in Rastatt, Germany," Mercedes-Benz production chief Markus Schaefer said in a statement on Friday.

Mercedes is adapting its vehicle underpinnings so that it can mass produce electric variants on the same production line as equivalent

volume models with petrol, hybrid or diesel engines, allowing the German carmaker to scale up production quickly if demand spikes, a spokesman for Daimler said.

Mercedes currently makes its compact Aclass, B-class and GLA models at plants in Rastatt, Germany, Kecskemét, Hungary, Beijing and in Aguascalientes, Mexico, and made 620,000 compact vehicles last year.

By contrast, U.S. rival electric car manufacturer Tesla delivered 101,312 vehicles last year. In September Mercedes-Benz presented "Concept EQA," an electric car with a range of around 400 kilometres which can be recharged without having to be plugged in.

Daimler said it is adapting its French plant to expand assembly facilities and reshape the site's infrastructure to produce the first ever Mercedes-Benz passenger car in France, Daimler said.

Hollywood's China dreams get tangled in trade talks

Hollywood's push for greater access to China's booming film market - delayed since last year - has become tangled in broader trade talks between Washington and Beijing, a potentially thorny position amid whipsawing trade relations.

Negotiations to raise a Chinese quota on imported films and boost the share that overseas producers get of box office takings are now being discussed within the broader framework of a US-China trade stand-off, four industry sources

The shift from earlier talks is a double-edged sword for US producers looking at China's \$8.6 billion cinema market. It could be bad news if broader talks go sour, but it could offer a potential path forward if the two countries find common ground.

China's quota system allows 34 imported movies a year to be shown in theatres, while overseas producers get a 25 percent share of box office takings - less than in other international markets. Since 2016 a handful more have been allowed in via a "cultural exchange" channel.

In a government document provided to the US delegation in Beijing two weeks ago, Chinese negotiators said that opening up the market more for US movies was a concession China could offer to Washington as part of a broader trade deal.

The document, seen by Reuters, said that China was "willing to discuss expanding movie imports with the US side".

Chinese Vice Premier Liu He is currently in Washington leading a Chinese trade delegation on a second round of talks to find a deal with the "It wouldn't really hit the domestic movie United States and avert a full-blown trade war between the world's two biggest economies.

> China on Friday said it was dropping an antidumping probe into imports of US sorghum, a

conciliatory gesture hours after US officials familiar with the matter said China was offering a package to slash the US trade deficit by up to \$200 billion.

On Thursday, US President Donald Trump criticised China as being "very spoiled" on trade with the United States but said he was aiming for an overall deal with Beijing.

US studios had hoped for an improved deal for imported films last year. This, however, had been held up as Beijing rejigged its film regulator, handing more control to the ruling Communist Party, and then as trade tensions with the United States grew.

"The movie deal is essentially on pause," one person familiar with US-China negotiations on the movie agreement told Reuters, adding that Beijing's willingness to ease up would likely be swayed by the state of trade tensions.

Hollywood producers are pushing for more access, but a bigger share of revenues was even higher on the agenda, especially as locally-made productions became more competitive.

Apple-Samsung iPhone design copying case goes to jury

Jurors return to a Silicon Valley courtroom Monday to put a price on patented iPhone design features copied by Samsung in a legal case dating back seven years.

Apple is seeking slightly more than a billion dollars in damages, while Samsung wants a figure closer to \$28 million. The jury has been asked to determine whether design features at issue in the case are worth all profit made from Samsung smartphones that copied them or whether those features are worth just a fraction because they are components.

"Samsung isn't saying it isn't required to pay profits," Samsung attorney John Quinn said during closing arguments on Friday.

"It is just saying it isn't required to pay profits on the whole phone."

The three design patents in the case apply to the shape of the iPhone's black screen with rounded edges and a bezel, and the rows of colorful icons displayed.

Samsung no longer sells the smartphone models at issue in the case. Two utility patents also involved apply to

"bounce-back" and "tap-to-zoom" functions. "This is a case that is focused on design, and the application of design to smartphones," Apple attorney Joseph

Mueller said in closing arguments. When one company copies a rival's design, that "is not a level playing field, and that is just not right," he contended.

EU could compensate firms hit by US sanctions over Iran: French minister

France is looking to see if the European Union could compensate European companies that might be facing sanctions by the United States for doing business with Iran, said French finance minister Bruno Le Maire on Sunday.

Le Maire referred to EU rules going back to 1996 which he said could allow the EU to intervene in this manner to protect European companies against any US sanctions, adding that France wanted the EU to toughen its stance in this area.

In 1996, when the United States tried to penalize foreign companies trading with Cuba, the EU forced Washington to back down by threatening retaliatory sanctions.

European firms doing business in Iran face sanctions from the United States after President Donald Trump withdrew from a 2015 nuclear deal with Iran. "Are we going to allow the United States to be the

economic policeman of the world? The answer is no," Le Maire told C News TV and Europe 1 radio on Sunday.

Le Maire added it was important Italy kept its EU budget commitments, in light of plans by Italy's new coalition government to ramp up spending - which could put Rome at odds with the EU.
