HC declares 2 housing projects illegal

The High Court yesterday declared illegal the Rimjhim Police Town and Italian City housing projects under Rupganj upazila in Narayanganj.

The court also ordered authorities concerned to bring the land to its original shape, which was changed for construction of the housing projects.

The bench of Justice Syed Muhammad Dastagir Husain and Justice Md Ataur Rahman Khan delivered the verdict after hearing a petition challenging the legality of the projects.

The HC order came as the projects were being constructed on over 5,000 acres of land in violation of the

Bangladesh Environment Protection Act, 1995, said Advocate Taimur Alam Khondaker. The lawyer said following the HC directive, owners of the

projects cannot carry on the construction work.

The authorities of Rimjhim Police Town and Italian City projects forcibly grabbed and filled up agricultural land. Numerous news reports were published in newspapers in this regard. Following the reports, locals communicated the matter to the department of environment (DoE) for taking appropriate steps.

However, DoE did not take any effective steps, he added. Deputy Attorney General Amit Talukder said the DoE has submitted a report to the HC, saying that some of the lands of the projects were not purchased by the owners, but were illegally grabbed and filled withearth.

Family demands probe into third party involvement

Mohammed Amin -- father of Tasfia Amin, whose body was found on concrete blocks at embankment of the Karnaphuli in the city's Patenga Naval area on May 3 -- yesterday demanded investigation to determine if there was involvement of any third party in the incident.

Meanwhile, investigators are yet to receive the post-mortem report of Tasfia, 19 days after the reports of chemical analysis and vaginal swab were sent to forensic lab of Criminal Investigation Department (CID).

Tasfia, a ninth-grader of Sunshine Grammar School and College in Chittagong, used to live with her parents in the city's OR Nizam Road area.

After the recovery of the body, her father filed a case accusing six persons including a 16-year old friend of hers, with Patenga Police Station on May 03. Police had sought remand for the

prime accused in the murder case on May 6. But a court in Chittagong sent him to Tongi Kishore Unnayan Kendra (juvenile

correction centre) in Gazipur and ordered the IO to quiz him there. Addressing a press conference yesterday at Chittagong Press Club, Tasfia's father Mohammad Amin said his

daughter was brutally "murdered" by a section of criminals. "The fate of the murder case now dependents on the viscera report.

I have sought assistance and cooperation from the administration so that the report is neutral and unbiased," said the father.

The investigators should look into whether any third party was involved

with the death, he demanded. Replying to a question, Amin

claimed her aforementioned friend, the prime accused in the case, is responsible for the murder and he knows every-

"[He] planned the murder, after calling my daughter out over the phone to meet.

Effects of climate change

Northwestern Bangladesh to see extreme weather conditions, study says

The northwestern part of Bangladesh is likely to experience more frequent extreme weather conditions like drought, flood, thunderstorm and cold wave in the coming years due to adverse impacts of climate change, a study finds.

The average increase in temperature especially in the region, will severely affect people's livelihoods and living, the study also said.

NETZ Bangladesh, a non-profit organisation registered in Germany and Bangladesh, and Bangladesh Centre for Advanced Studies (BCAS) jointly conducted the study in seven northwestern districts of

BCL, supporters of ward councillor clash

A group of Bangladesh Chhatra League and supporters of a pro-Awami League ward councillor clashed over "collecting extortion money" from traders on a Savar footpath on Sunday night.

At least 20 people from both groups were injured.

A motorcycle was burnt during the incident which occurred in Katlapur area. The injured were admitted to Savar Upazila Health Complex and local hospitals, said police.

According to locals, there has been a longstanding dispute between Atikur Rahman Atik, president of Savar Upazila BCL, and Abdus Sattar Miah, councillor of ward no-6 in Savar municipality, to establish dominance over the footpath hawkers.

Usually, the followers of the ward councillor regularly extort money from the traders and thus patronise them to run their businesses illegally.

The clash ensued as the other group hungered for the money, said locals.

Seeking anonymity, several hawkers said Sattar's supporters beat one of the followers of Atik when he demanded money from the traders in Ulail area.

Later, Atik's supporters attacked their rivals when they went to Katlapur area, triggering the clash, they said.

The groups were equipped with sticks and firearms, said locals.

Sattar told The Daily Star that BCI activists attacked his supporters without any reason. The ward councillor, however,

denied his involvement in such extortion. But, Savar Police Station Officerin-Charge Mohshinul Kadir con-

firmed that the groups clashed over collecting extortion money.
