# Vegetables, meat pricier

Wide gap between wholesale and retail prices in Chittagong

Prices of vegetables and meat have soared in kitchen markets despite no reasonable change in wholesale prices in the port city.

Vegetables at the nearest wholesale market were being sold at nearly half the price yesterday.

At the Nayabazar kitchen market, cucumbers were being sold at Tk 50 per kg, while at Pahartali Bazar -only 1.4 kilometres away -- they were going for Tk 35 per kg. Brinjals were being sold at Tk 60,

and carrots at Tk 60 per kg at Nayabazar, while prices of these vegetables were Tk 50, Tk 35, Tk 35, and Tk 35 respectively at Pahartali Bazar. According to market sources,

papayas at Tk 70, tomatoes at Tk 50,

prices of brinjals, papayas, tomatoes and carrots were Tk 40, Tk 35, Tk 40 and Tk 40 respectively before Ramadan. Mohammad Momin, a vendor at

Pahartali bazar, said traders of all the kitchen markets around the area come to the market to purchase vegetables.

"Rickshaw fare between Nayabazar and Pahartali Bazar is Tk 40 at most. There is no reason for prices to go up that much," said Momin, adding that prices of vegetables were stable at the wholesale market.

Mohammad Alamgir, a customer at Nayabazar said though the daily consumption of vegetables

#### HINDUS SEEK SECURITY Habiganj SP directed to settle issue

The High Court has directed the superintendent of police (SP) of Habiganj to dispose of an application submitted for providing security to the Hindu people of Sunaru village in Baniachang upazila of Habiganj.

The SP has been asked to comply with the order within one month on receipt of the order.

The bench of Justice Md Ashfaqul Islam and Justice KM Kamrul Kader passed the order on May 14 following a writ petition filed by Sushanta Das Gupta, a resident of Sunaru village, seeking its direction on the SP to dispose of his application.

Sushanta Das Gupta submitted the application to the office of the SP on April 19.

He said in the application that a vested quarter, particularly local Jubo League leader Ataur Rahman Selim, is torturing the Hindu people of Sunaru village in different manners in order to occupy their properties.

Sushanta also said the vested quarter has threatened him and his family members over cellphone, saying that they will kill them if they do not convert to Islam.

## Khulna polls saw 'peaceful rigging'

Observes Shujan, slams EC for failure

As the recent Khulna City Corporation elections were marked by "peaceful rigging", there is no scope to term it free, fair and flawless, Shushashoner Jonno Nagorik (Shujan) said yesterday.

Reading out a written statement at a press conference at Dhaka Reporters Unity, Dilip Kumar Sarkar, central coordinator of Shujan, a civil society platform working for good governance, said, "We feel the Khulna City Corporation election was a questionable one."

People's confidence and the credibility that the Election Commission had gained following the Rangpur City Corporation elections has dissipated in the KCC election, Dilip Kumar added.

For some candidates, the KCC polling atmosphere was frightening even though

there were no noticeable incidents of violence or cases of mass irregularities, he said at the event.

This is why voter presence was very low, at only 62.19 percent, he added.

After holding three good city corporation elections -- Narayanganj, Comilla and Rangpur -- an example of non-transparent and faulty election was set through the Khulna election, said Dilip.

Dr Tofail Ahmed, a local government expert, said a new model was set up during the election, where no chasing, counterchasing or snatching of ballot boxes took place. Rather, the election was done under peaceful rigging.

The EC had no control over the law enforcers, said Shujan President M Hafizuddin Khan while speaking at the press conference.

Long before the election of Rajshahi City Corporation, the incumbent mayor and his predecessor have got involved in conflict

over hanging campaign banners. Tensions arose when followers of Mayor Mosaddek Hossain Bulbul and former mayor Khairuzzaman Liton took positions near the foot-bridge on Monday night. However, no untoward incident occurred

due to the presence of police. More than a year ago, the Rajshahi city unit of the Awami League had hung a banner on the foot-bridge in front of RDA Market, the city's busiest shopping centre. Recently, the wornout banner was blown off, according to local shop owners. They said the banner projected portraits of the ruling party bigwigs and highlighted its development activities.

Three days ago, on Saturday, RCC staff hung a new banner with greetings from Mayor Mosaddek to the city residents on the occasion of Ramadan.

All was well until Monday night when Mayor Bulbul, also the president of the Rajshahi city unit BNP, noticed that his banner was replaced by one of former mayor Liton. Also president of Rajshahi city AL, Liton greeted city dwellers for Eid and asked for votes in the upcoming city elec-

tion, which is due this year. The same night, an infuriated Bulbul sat on the road, in front of the bridge, protesting removal of his banner and stayed there for almost three hours till midnight yesterday. He had altercations with police and city AL men, sparking tensions.


