# Bridge unused for five years

Approach road of the bridge collapsed within one year of construction

A bridge in Haliport area in Charbhadrasan upazila has not been used for five years as the approach road on one side collapsed within one year after it was built.

Ministry of Relief and Rehabilitation built the 40-feetlong and 14-feet-wide bridge over a canal beside an old bridge in the same area during the 2011-2012 fiscal year at a cost of Tk. 19,98,851. The new bridge was inaugurated by the then Member of Parliament Nilufar Jafarullah.

During a recent visit, this correspondent found that local people still use the old, risky bridge beside the new bridge to go to their destinations.

Locals said thousands of people of five villages under Charbhadrasan union still use the old bridge every day facing serious problems. The old bridge, which was built in 1985, became unusable, so they demanded a new bridge there, adding that the Ministry of Relief and Rehabilitation built a new bridge in the fiscal year 2011-2012.

The earthen approach road on one side of the new bridge collapsed within one year, so the villagers use the old bridge as there is no other option, they said.

"People of three villages use the road on which the bridge was built to go to the upazila headquarters, but they are using the old and risky bridge instead of the new one," said Charbhadrasan Union Parishad Member Fajlur Rahman.

"The bridge is of no use to us without approach road. We are victims of negligence of the authorities," said Pannu Sheikh, a resident of the area.

"A concrete road will built over the bridge very soon, and we will fill up the approach road then," said Charbhadrasan Upazila Engineer Nur Mohammad Mollah.

# Jubo League man arrested

A local Jubo League leader was arrested yesterday from his house in Rangabali upazila for assaulting a forest guard.

The arrestee is Md Reaz Hawlader, 40, joint secretary of Rangabali upazila unit of Jubo League.

Abul Hossain is a forest guard at Gongipara Forest Camp in Rangabali upazila, police said.

Reaz beat Abul with a stick on May 19 as Abul stopped people from taking their cattle to graze in the newly planted forest land. Reaz left the place after threatening Abul that he would kill him.

Abul filed a case with Rangabali Police Station yesterday and police arrested Reaz from his house in the town, said Milon Krisna Mitra, officer-in-charge of the police station.

It may be mentioned that Reaz assaulted Abu Zafar Saleh, Tahshilder of Rangabali union, on March 19 this year as Saleh refused to lease khas land to him. Reaz also ransacked some furniture of the office.

Saleh filed a case under the Speedy Tribunal Act with the same police station on March 21 and the case is under investigation.

# Four frauds held

upazila on Tuesday for collecting money from the poor. The arrestees are Fuad Al Islam, 35, son of Abdul Karim

of Rasulpur village, Halima Begum, 25, wife of Nasir Uddin of Lakcha village in Satkhira Sadar, Motiar Rahman, 60, son of Sapijuddin of Kantamoni village and Abdul Bari, 28, son of Abdul Khalek of Khasmahal village in Panchagarh Sadar.

Police and locals said the four collected Tk 2,000 to Tk 5,000 from the distressed families of different villages in Satmera union of Panchagarh Sadar upazila promising to build houses for them under Asrayan Project.

Seeing their suspicious activities, local people caught them while they were collecting money from people, said Rabiul Islam, officer-in-charge of Panchagarh Police Station. On information, police went to the spot and arrested the

four, said Afsar Ali, member of Satmera Union Parishad. A case was filed in connection with the incident, said the police official.

# Santals' fish on sale?

Rangpur Sugar Mills authorities selling fish cultivated by members of Santal community

Rangpur Sugar Mills authorities in Gobindaganj upazila of Gaibandha are selling fish of seven ponds cultivated by the Santals evicted from Sahebganj-Bagda farmland in November 2016.

Many evicted Santal men claimed that they cultivated paddy on 140 acres of land and about 63 maunds of different varieties of fish spawns in seven ponds inside the farm area in July 2016. Since their eviction from the Sahebganj

Bagda farmland, Santal people have set up some makeshift houses in nearby areas and had been demanding their land back from the mill authorities. According to East Bengal Emergency

Bherbhera, Gaachulka, Harinmari and Bachhurmari ponds in July 2016. But the mill authorities are now selling the fish without our consent," said Sufal Hembram of Joypurpara village.

"In the wee hours of April 30, the mill authorities sold some 80 to 90 maunds of fish from one of the seven ponds," Ganesh Murmu of the village said, adding that after hearing the news acting upazila nirbahi officer (UNO) seized Tk 1, 95,000 earned

from selling the fish. Managing Director (MD) Anwar Hossain of Rangpur Sugar Mills said the sugar mill authorities cultivated the ponds through tender in 2016 and are now selling the fish through fresh tender.

The ponds and fish belong to the sugar mill, not the Santals, the MD added.

Meanwhile, the evicted Santals submitted a memorandum to Gaibandha Deputy Commissioner Gautam Chandra Pal urging him to take legal steps for returning the money, earned from selling the fish, to its original beneficiaries.
