Thunderbolt fear hampers Boro harvesting

Day labourers reluctant to go for harvesting in Nilphamari

Farmers in the district are passing their days in anxiety as excessive rain, storms and lightning are damaging and killing the ripe Boro paddy in the harvesting season that started one month ago.

Moreover, day labourers are reluctant to go to the Boro fields for harvesting as they are afraid of being struck by lightning, which has killed several people in the open fields.

Sub-Assistant Agriculture Officer of the district Department of Agriculture Extension (DAE) Sanarul Islam said the district had

200 mm of rainfall accompanied by hailstorm and lightning in May, severely affecting agriculture. "Due to continuous natural

calamities and unavailability of day labourers, only 60% of the paddy has been harvested so far, though it is supposed to be 80% by this time," he added. Storm and hail caused damage

to Boro paddy on 12,036 hectares of land out of a total of 84,360 hectares cultivated in the district, and threat of further damage is still there, Sanarul said.

"My house yard is supposed to be filled with paddy at this time,

but it has not happened this year as I cannot harvest the paddy due to scarcity of day labourers, who are unwilling to go to the fields for fear of lightning," said farmer Hamidar Rahman of Jigabari village in Dimla upazila.

"Misfortune never stops haunting us as neck blast disease caused much harm at the fag end of the cultivation season. Now delay in harvesting is ruining the crop," lamented farmer Pran Roy of Ramnagar village in Sadar upazila.

"We do not want to harvest paddy in the rain as thunderbolts usually strike open fields, causing

deaths, although farmers offer high pay," said Solaiman Ali, a day labourer of Khalisha village in Saidpur upazila.

According to newspaper reports and information revealed by the district health department, 10 people, mostly day labourers, were killed by lightning during this Boro season.

"Farmers should not delay in harvesting ripe Boro paddy to prevent ruining of the crops. We encourage farmers to use family labour to overcome the labour crisis, said district DAE Deputy Director Abul Kashem Azad.

Slain rape victim yet to be identified

Nine months into the incident, police are yet to identify the girl who was murdered after rape.

Law enforcers recovered the body of an unidentified girl from a pond near Pathorghata College in Barguna on August 10 last year.

Two days after the incident, police filed a case with Pathorghata Police Station, accusing unidentified people.

Detectives are investigating the case.

After three months, police learnt that the girl was killed after rape with the help of the night guard Md Jahangir Hossain of the college. Police arrested him on November 11. The following day, the night guard gave confessional state-

ment to the Senior Judicial Magistrate's Court in this regard. Based on his statement, police later arrested four local Bangladesh Chhatra League (BCL) men. They are Ruhi

Anan Danial, president of Pathorghata College unit BCL, its secretary Saddam Hossen Chotto, organising secretary Mahidul Islam Rayhan, and Md Mahmud, assistant secretary of Pathorghata upazila unit BCL. On November 14, central BCL expelled all the arrestees over the matter.

Jahangir was recently freed from the jail following an order of the High Court while others are still in Barguna Jail.

Inspector of Barguna DB police Md Bashir Uddin, also the investigation officer of the case, said they are trying their best to identify the victim.

Abducted teen tound murdered

Over two months into his abduction, a teenage boy was found murdered at Keshoreganj Bazar in Phulbaria upazila yesterday.

Victim Mehedi Hasan Babu, 15, son of Shahjahan Ali of Shibpur village, got GPA-5 in this year's SSC examinations. He went out of his house on March 6 and remained missing since then. The following day, Minara Khatun received a message

from her son's mobile phone demanding Tk 6 lakh for his safe return and not to disclose the matter to others, the mother said, adding that since then Babu's phone was found switched-off. Later, a general diary was filed with Phulbaria Police

Station. Police then detained HSC examinee Mohammad Tushar, 19, for his alleged involvement in the abduction and took him on a two-day remand.

During police interrogation, Tushar admitted that although he and Babu traveled to Dhaka together in the same bus, Babu got down from the vehicle in Kuril Biswa Road area in the capital, said Officer-in-Charge of Phulbaria Police Station Sheikh Kabirul Islam.

Tushar was later released on bail on April 1 and the case was transferred to Detective Branch (DB) of police, said the OC.

On suspicion, a team of DB police arrested Tushar on Tuesday in another murder case. During primary interrogation, Tushar confessed to killing Babu following an altercation over love affair. The body was dumped at Keshoreganj Bazar.

Tushar's friend Al Amin was also arrested in this connection, said detectives.

Freed Raza back to family after 20 yrs

Acquitted from a murder charge, Azaher Ali Raza, who was freed from jail on Wednesday after 20 years of confinement, is passing a busy time as relatives, neighbours and locals thronged at his Uttar Joydebpur village home in Dinajpur Sadar upazila.

"My daughter Ajmira Khatun was an 11-month-old girl when I went to jail in 1998. Now she has met me with her 15-monthold daughter Rekha," Raza told this correspondent when the latter went to his home on Wednesday.

"My sisters, brothers and daughter were little when I went to jail in 1998. Now I can hardly recognise them. My mother met me several times in last 20 years when I was in jail, but my other relatives never went to jail to

meet me," he said. "It's really a wonderful moment for us," said Raza's sister

Rehana. Raza's wife left him after he went to jail, being arrested in a

murder case in 1998. "Dinajpur has changed a lot in last 20 years. There were a few high-rise buildings in the town, but I saw many high-rise buildings here on Wednesday. The road to my home is car-

Family members of a man, who recently returned from Qatar, alleged that plainclothes Detective Branch (DB) men of Meherpur picked him up from his house

village in Gangni upazila of Meherpur. DB officials said he was a listed drug trader and accused in five cases.

Magrib's wife Shaheda Khatun alleged that five or six plainclothes armed men stormed into their house at about 6:30am yesterday. They introduced themselves as DB men and looked for her husband, who arrest. was sleeping.

The DB men picked up Magrib and asked Shahida to meet them at the DB office.

Shahida admitted that her husband was

involved in drug trading five years ago.

"My husband went to Qatar in June of 2015 to escape arrest," Shahida said.

Magrib returned home after two years and started farming and beef fattening, but he did not go back to drug dealing, she said.

A DB team arrested Magrib and sent him to jail in October 2017, a week after he returned from Qatar, Shahida said, adding that he was released on bail after two

months. Meherpur DB Police Officer-in-Charge (OC) Shahin Uddin said Magrib was a listed drug dealer in Gangni upazila and five Yaba tablets were recovered from him during the

"Magrib was accused in five cases, including one for robbery and four for drugs," the

DB OC said.

Magrib will be produced before a court after interrogation, the police official said.
