'Tree-man' gives up hope

Abul Bajandar leaves DMCH after 2.5 years

Abul Bajandar, 28, dubbed "tree-man" for massive bark-like warts on his hands and feet, left Dhaka Medical College Hospital (DMCH) on Saturday, giving up hopes of a full recovery after around two and half years of treatment.

He had a surgery scheduled to be held this week, which would be his 26th.

"My last surgery was done around four months back, but new warts are coming out from most of the places where surgeries were done. It is not improving," said a hapless Bajandar.

Doctors saying it is a genetic problem, and will not be cured totally, also contributed to the frustration, he said.

attention from the hospital authorities like ear-"Earlier, my family members (wife and a kid) and I used to get meals from the hospital, but

since May 8, authorities are providing meals only to me," Bajandar said.

Finally, on Thursday, he wanted to go to his village home in Paikgachha of Khulna to enjoy Eid-ul-Fitr with his family and relatives, but the authorities did not allow him to go.



Later, the authorities gave him a form where it was written that he is going home with his own decision and the authorities would not held responsible for any untoward incidents, he said, adding that he left the hospital on

Saturday afternoon.

Burn expert Samanta Lal Sen, who was supervising the treatment of Bajander, said he left the hospital suddenly without informing them.

He said the treatment was going on in a systematic way, and they hoped that his condition would be improved significantly after few more surgeries.

"If he wants to return for treatment, the authorities will give him the same support," he said.

About the meals, he said Bajandar was provided meals following the system of the hospital, but they were thinking about providing meals to his family members as well in alternative ways. The warts, which first started appearing when

Bajander was a teenager but began spreading rapidly four years ago, have been diagnosed as epidermodysplasia verruciformis, a rare genetic skin disease that makes the person susceptible to skin growths.

He was undergoing free treatment under the supervision of Samanta Lal since January 30, 2016.

Bajander came to mainstream attention after reports were published about him in newspapers. Bajander, who is now home, requested the prime minister to send him abroad if the treatment facility is not available in Bangladesh.

ICC LETTER ON ROHINGYA

TIB urges govt to respond

to the ICC.

Transparency International Bangladesh (TIB) has called upon Bangladesh to provide observations, including evidence of mass atrocities against Rohingyas, to the International Criminal Court (ICC).

By starting trial for the crimes against humanity in the Hague-based court, ICC will provide a chance for justice for the Rohingyas and help create international pressure on Myanmar and its allied states, said TIB in a statement yesterday. The ICC on May 7 sent a letter to

Bangladesh seeking written observations by June 11 on whether the court can exercise jurisdiction over forced deportation of the Rohingyas from Myanmar to Bangladesh.

Some 700,000 Rohingyas have fled military crackdown in Rakhine state since August last year. Rights groups said thousands were killed, women raped and houses burnt and bulldozed -- events that the UN said have hallmarks of genocide.

UN Security Council has failed to refer the situation in Myanmar to the ICC. Against this backdrop, ICC wrote to Bangladesh.

Earlier on April 9, ICC prosecutor Fatou Bensouda asked the court to rule whether it has the jurisdiction over deportation of the Myanmar nationals, a possible crime against humanity.

Referring to media reports, TIB said Bangladesh is still in confusion regarding response to the ICC letter.

The anti-corruption watchdog said it is unjust to pass on the burden of one million Rohingyas to Bangladesh. Myanmar government and the international community

have to take responsibility for them, it said. "The ICC initiative is a ray of hope for justice for the Rohingyas who faced mass killings and atrocities by the Myanmar military. The armed forces operated the crackdown meant for ethnic cleansing," said TIB

Executive Director Dr Iftekharuzzman. It is an expectation that Bangladesh, which itself is a victim of crimes against humanity, will stand strong for justice. It will be a significant step for the country to provide observations, including evidence,

"A strong position in favour of the ICC initiative will speed up the whole process," said Dr Iftekharuzzaman. Besides, as a member country of ICC,

Bangladesh can play an important role in bringing the perpetrators of mass atrocities to account, he said.

"As a result, a historic opportunity will be created for accountability of the international community, including the United Nations, which has been playing a role of silent spectators in the preparation period of ethnic cleansing by the Myanmar's armed forces," said Dr Iftekharuzzaman.

ICT begins trial in RP Shaha killing case

First prosecution witness places deposition

The trial in a case filed in connection with the abduction and killing of philanthropist Ranada Prasad Shaha aka RP Shaha, his son and dozens other during the Liberation War in 1971, began yesterday.

Eminent educationist Pratibha Mutsuddy gave testimony as first prosecution witness in the case at the International Crimes Tribunal-1, linking Mahbubur Rahman of Tangail with the offences.

Before her testimony, Prosecutor Rana Dasgupta placed opening statement in front of the three-member tribunal, led by Justice Md Shahinur Islam.

Mahbubur, 69, the lone accused of the case and also an alleged Razakar from Mirzapur in Tangail, is facing three charges. He, however, pleaded not guilty

before the tribunal.

In her long testimony, Pratibha, 84, a director of Kumudini Welfare Trust of Bengal, which was established by RP Shaha, gave details about RP Shaha and his philanthropic activities. Pratibha, who received Ekushey Padak in

2002 as an educationist, said she joined Bharateswari Homes, an educational institution run by Kumudini Welfare Trust, in 1963 and served as its principal from 1968 to 1998. She said after the Pakistan-India war in

1965, the then East Pakistan provincial governor Abdul Monem Khan declared Kumudini Trust as enemy property, and hatched conspiracy against RP Shaha.

One Maolana Abdul Wadud (now late) of Mirzapur used to oppose RP Shaha's philanthropic activities, she said, adding SEE PAGE 4 COL 4

Robber killed, another injured in N'ganj, Savar 'gunfights'

Police rushed to the spot on information that a gang of 10 to 12 robbers was preparing to commit robbery in the area, said the OC.

Sensing their presence, the robbers opened fire on the law enforcers prompting them to fire back, he added.

Other robbers managed to flee, said the OC. Tower Suman is an accused of 11 cases with Araihazar and Sonargaon police stations. Similarly, Majid is an

accused of 12 cases, he said. Meanwhile, police arrested a robber who sustained bullet injuries in another "gunfight" between a gang and the law enforcers in Moragang area of Ashulia in Savar yesterday, our Savar correspondent adds.

Shohag Mia, 35, is a member of inter-district highway robbery gang, said police.

He was admitted to a Savar hospital.

A gang of five to six robbers in a pickup truck were taking preparations for committing robbery in the area.

The shootout ensued when the gang opened fire on police sensing their presence, said Javed Mashud, inspector (investigation) of Ashulia Police Station.

ORDEAL OF FEMALE MIGRANT WORKERS IN KSA

MJF, Naripokkho urge bilateral solutions

Manusher Jonno Foundation yesterday expressed grave concern over the return of Bangladeshi female migrant workers from Saudi Arabia following sexual abuse and/or harassment, and urged government to take

steps to resolve the problem bilaterally. "Bangladesh authorities can't evade the responsibility for the sexual harassment of the female migrant workers in Saudi Arabia following joint commitment of the two countries," MJF Executive Director Shaheen Anam said in a statement.

Over 100 women, who faced abuse, are waiting at shelter centres in Saudi Arabia for returning home, she said citing various media reports. Many countries, including the Philippines and Indonesia, have stopped sending female workers to Saudi Arabia following reports of such incidents, Shaheen Anam added.

The organisation urged government to take effective measures to realise dues, compensation and medical expenses of the victims from the employers in Saudi Arabia.

It also strongly requested the government to

place the issue to the Saudi government to take responsibility of the children of those who got

pregnant following sexual abuse in the KSA.

Meanwhile, rights organisation Naripokkho also condemned the physical and sexual assault to female migrant workers in Saudi Arabia, who were forced to return to the country, said a press release. Around 4,000 female migrant workers returned home last year and said recruiting agencies duped them with false hopes of

sold off to Saudi families and said agencies do not take any responsibility once they were sent abroad. Female workers were subjected to various physical and mental tortures overseas. They were starved and their passports
