Rights body Ain o Salish Kendra (ASK) yesterday again expressed concern over the "extrajudicial killings" and condemned the shootout spree. Citing media reports, it said 119

people have been killed in so-called gunfights and around 10,000 people have been apprehended during the ongoing clampdown. "The deaths of such a huge number

of people in such a short span of time are not acceptable," the ASK said in a spot. press release. As per the constitution and interna-

tional human rights charters, every citizen is entitled to justice. Therefore, the offenders must be tried through the legal process but not by law enforcement agencies, the release added.

Earlier, different rights activists and political leaders criticised the deaths, saying "killing could never be a solution to ending crimes". Recently, diplomats stationed in Dhaka also expressed concern over the "extrajudicial" kill-

Rab-7 Company Commander in Cox's Bazar Maj Ruhul Amin said Mujibur was a top-listed drug dealer in Netrakona and accused in 10 cases. The Rab claimed that its officials recovered gun, five bullets and 6,000 yaba tablets from the spot.

In port city Chittagong, Md Ishaq alias Yaba Ishaq, 35, was killed in a "shootout" between Rab and a group of drug dealers in Pologround area around 1:30am, said Rab-7 Deputy Director Ashequr Rahman. In a text message, the Rab said Ishaq was

accused in at least 19 cases.

In Comilla, Rosmat Ali, 40, was killed at Laribagh in Burichang upazila around 1:00am, said OC Manoj Kumar of Burichang Police Station. Rosmat was wanted in seven cases filed under the narcotics control act, he added.

Police claimed to have recovered a pipe gun and 40kgs of cannabis from his possession. Another alleged drug dealer Shah

Alam sustained bullet wounds in a

"shootout" with police in Palpara Bridge area. He is accused in six cases, including for possessing drugs and firearms, police said. In Narail, Sajib was killed at Malibagh in the suburban area of the district town, UNB reports quoting

Mehedi Hasan, senior assistant superintendent of Narail police. A firearm, one sharp weapon and some illegal drugs were recovered from the spot, the report said quoting the

official. In Chuadanga, Tanjil Hossain, 40, a "top drug dealer" and an accused in 12 cases, was killed at Satgari Natunpara in the municipality area around 3:00am, said Abdul Khalek, officer-in-

charge of Sadar Police Station. Law enforcers also claimed to have recovered a firearm, four bullets and 170 bottles of phensedyl from the spot.

Tanjil's cousin Akram Hossain, however, said they heard Tanjil was arrested by plainclothes men on Monday night from Bostapatti area of Chuadanga town. "Since then, we had no communication with him," he said.

In Sirajganj, alleged drug peddler Ahsan Habib, 45, was killed in A firearm, ammunition and 4,000 Kamarkhand upazila, said Md Sakibul

Three Rab personnel were also hurt during the "gunfight" that left Ahsan dead, the Rab official said.

Two alleged drug peddlers -- Liton Mia, 42, and an unidentified man, aged around 45 -- were killed in an infighting of two rival gangs of drug peddlers in Boro Archa area of Benapole around 4:00am, said Apurba Hasan, OC of Benapole Port Police Station.

Police seized 10kgs of cannabis, one pistol, two bullets and shells of bullets from the spot, he claimed.

In Magura, three alleged drug dealers were killed in a similar incident between two groups of drug peddlers at Batikadanga in Sadar upazila around 1:30am, said Sayruddin Ahammad, assistant superintendent of police in Magura.

They were identified as Bacchu Chopdar, 48, Raihan Dhali alias British, 22, and Kishore Odhikari alias Kala, 32.

Police recovered 320 grams of heroin, 1kg of cannabis, six bottles of phensedyl, two bullets and eight bullet shells from the spot, the law enforcers claimed.

Raihan and Kishore were accused in 10 narcotics-related cases each and Bacchu was wanted in seven such cases, they said.

A lucky escape? Family members of Chittagong man

accuse police of 'crossfire attempt'

Police allegedly implicated a 60-year man, Samar Krishna Chowdhury, in two cases related to narcotics and arms recovery, after being influenced by a local expatriate man.

Family members claimed Samar was being taken to a deserted area where he might have become another victim of "crossfire". However, the plan changed after police high-ups got involved.

Plainclothes men "picked up" Samar, who works as an assistant to lawyers in the Judge's Court of Chittagong, from the city's Hawkers' Market area on Sunday evening, alleged the family members. They added his cell phone was seized after he was forced into a microbus and then blind-folded.

"My father was taken to Boalkhali Police Station and fortunately a local man saw him there," said Alakananda Chowdhury, one of Samar's daughters, adding, "He [the man] informed the local union parishad member Suresh Chowdhury. "As Suresh informed us, we

instantly went to Kotwali Police Station to record a general diary but the on-duty officer refused to record any complaint against police."

She said they then contacted Boalkhali Police Station but they too were uncooperative. Police said Samar was arrested in a

case filed against him under the narcotics act in March while he was on bail in another case filed over yaba recovery in November last year. "As per his accounts, Samar was

taken to his house at Sarwatoli village [where the family would go on holidays]. From there, 310 pieces of yaba pills were recovered from under the couch of the bedroom along with a light gun with four rounds of bullets," said Officer-in-Charge of Boalkhali Police Station Himangshu Das Rana. Family members alleged that UK expatriate Sanjoy Das "implicated" Samar

She claimed that Sanjoy became angry at this and warned him against helping Swapan. Refused, Sanjoy implicated her father. Denying the allegation, Sanjoy said

he had no connection with the incident. "I do not even know Samar," he told The Daily Star, adding, "I have been living in London for around 20 years and got citizenship of the country...we had a land dispute with our cousins and now all the cases are about to be settled."

Asked, why Samar's family members were blaming him, Sanjoy said they were influenced by the local UP member Suresh and a land brokers' syndicate.

Asked why Suresh was involved, Sanjoy said, they wanted to blackmail him and grab his lands. However, Suresh, a member of ward

8, denied the allegations over phone and said he was the local public representative and so he spoke for Samar as his family members came to him.

"I am receiving threats over the phone and being blamed for instigating Samar's family members to organise a press conference and form a human chain on Tuesday," he said, adding, "Police even raided my house in the village on Tuesday night...being frightened, I am now on the run."

OC Himangshu denied the allegation of police's raid at Suresh's house. He also denied the allegation of being influenced to arrest Samar. "Police arrested Samar as he was accused in the yaba recovery case," he said.

THE ESCAPE "They beat him up and then blind-

folded him. On the way, an official told someone over phone he was being taken to Charandwip Canal for the 'operation'...but after a while, he received some phone calls and asked the driver to change the direction towards Samar's house saying that it was not possible to go for the 'operation now as he had received calls from his high officials," said Samar's other daughter Tomalika Chowdhury, quoting Samar who she visited at Chittagong Central Jail yesterday.

ex-deputy managing director of BASIC Bank, and its ex-deputy general manager Shipar Ahmed, seeking bail in loan scam cases.

The court fixed today for passing order on six bail petitions filed by Sobhan and one by Shipar.

Justice Enayetur said it is evident from case documents that the BASIC Bank's credit committee had given negative opinions to the bank's board of directors about granting loans to some applicants. But the board approved the loans ignoring the committee's recommendations.

The board should have sent back the loan applications. Instead, it approved the loans immediately after some loan seekers submitted applications, he

"It has been found that a single person has taken loans in the names of different institutions ... State money has been plundered this way. If the state agencies don't act on this, we have nothing to say," said Justice Enayetur.

He also mentioned that the ACC chairman reportedly said the commission has been trying to trace the embezzled money.

"If the commission is still trying to trace the [embezzled] money, the probe will not end till the doomsday," Justice Enayetur said, adding that the commission is applying "pick and choose" policy in arresting people in the corruption cases.

The judge further said some highprofile graft suspects are seen in the television talk-shows and state programmes, but no action is taken against them.

Justice Shahidul said the commission's intention becomes clear from its delay in investigation in the corruption

Eight IOs and their two team leaders appeared before the HC bench yesterday in line with its May 23 summons.
