Following the assassination of Bangabandhu Sheikh Mujibur Rahman, Maj Gen Ziaur Rahman rehabilitated those who had opposed liberation and formed religionbased parties to enter the political arena of the newly-independent nation.

All that was done in the name of establishing multiparty democracy, said Shahriar at a discussion organised at the Institution of Engineers, Bangladesh to mark the 24th death anniversary of Shaheed Janani Jahanara Imam.

Twenty-seven years ago, a national movement came into being under the leadership of Jahanara Imam demanding trial of war criminals and banning of fundamental and communal politics.

#### Training at primary level needed to identify disability properly

Speakers say at workshop

Primary-level [upazilas] healthcare workers and doctors need to be trained to identify disability properly, to ensure better health services, said speakers at a workshop yesterday.

They also said differently-abled people should be given priority in healthcare.

Non-Communicable Disease Control (NCDC) Programme, Disabled Rehabilitation and Research Association (DRRA) and Directorate General of Health Services (DGHS) jointly organised the workshop at Brac Centre in Dhaka.

Presenting the keynote speech, Dr Khaleda Islam, former director (Primary Health Centre) of DGHS, said, "Primary healthcare system needs to be strong to identify the problem of disability." To identify disabled people properly, it is important to

train healthcare workers at the community level, she said, so that they can primarily detect disabled individuals, refer them to upazila doctors to specify the disability, and subsequently the doctors can send them to a specialised institution for better treatment.

Giving various definitions of disability, Rifat Shahpar Khan, independent consultant and director, Creative Pathways, said that according to WHO, 15 percent of the global population are disabled, and the issue needs to be addressed properly.

She also emphasised on talking to the disabled person directly instead of talking to his or her aide. "Or else, they will feel neglected," she added. Farida Yesmin, executive director of DRRA, said there are

different types of disabilities and they need to be treated differently by specialised doctors. Sometimes, disabled people are unsure of where to get treatment and therefore, they move from one

healthcare centre to another without knowing where to

find proper treatment, which costs them a lot, she alleged. If community clinic workers are trained, they would know where disabled patients should be referred to, she

Dr Abul Kalam Azad, DG of DGHS, said the government

is working to ensure proper healthcare facilities for differently-abled people and is trying its best to address the issue.

Prof AHM Enayet Hussain, ADG (P and D) of DGHS also spoke at the workshop.

## 80pc cholera infections in Dhaka spread within household

Says new research study

Around 80 percent of cholera infections in Dhaka contract through members who share a household, cooking pot and eat together, according to a new study published in US-based science journal Nature Genetics on Monday.

## Submit test report on pasteurised milk

High Court directs food secretary

The High Court yesterday directed the food secretary to get the test report on pasteurised milk from the expert committee and to submit it (report) before the court in a month.

The court passed the order after food secretary's lawyer Barrister Md Faridul Islam informed that the government has formed a 10-member expert committee in order to examine the pasteurised milk available in the market as per its earlier directive.

The lawyer also sought six months' time from the HC for submitting the test report to

the court.

Md Iqbal Kabir, however, gave one months' time to the food secretary to place the test report before it.

Following a writ petition filed by Supreme Court lawyer Tanvir Ahmed on May 21, the HC ordered the food secretary to form an expert committee to test the pasteurised milk available and submit a

report before it in a month. The expert committee would include representatives from the food and health ministries, Bangladesh Standards and Testing Institution (BSTI), and other experts and researchers concerned, the court said.

#### Ecnec approves 14 projects

STAFF CORRESPONDENT The Executive Committee of the National Economic Council (Ecnec) yesterday approved 14 projects, at a total cost of 16,147 crore taka.

The biggest of the projects involves building 560 model mosques in district and upazila towns across the country, spending Tk 8,722 crore from its own resources as the promised funds for the project from Saudi Arabia are not available yet.

Ecnec held a meeting with Prime Minister Sheikh Hasina in the chair at the NEC auditorium

of the planning ministry. Planning minister AHM Mustafa Kamal is, however, still hopeful about getting the previously promised Saudi fund for the project. After the meeting, the planning minister told the reporters they have got around Tk 83 crore for

the project. Replying to reporters' queries, he said after the change of king in Saudi Arabia, getting the fund has been delayed, but they are still hopeful to get

more funds from Saudi Arabia. If the fund is not available the project will continue with own resources, he said.

The government also approved 13 more projects at a cost of Tk 7,425 crore, which include foreign funds of Tk 2,839 crore.

One of the projects is for collecting new engines and compartments for Bangladesh Railway, at a cost of Tk 3,602 crore, of which the Asian Development Bank (ADB) will finance Tk 2,839

Under the project, 40 broad gauge (BG) diesel engines, 75 meter gauge (MG) and 50 BG luggage vans, 400 MG and 300 BG bogey-covered wagons, and 180 MG and 120 BG bogey open wagons will be purchased.

Ecnec also approved a Tk 173-crore project for modernisation of three mills under Bangladesh Jute Mills Corporation (BJMC). The three mills are UMC Jute Mills in Narsingdi, Jessore Jute Industry Ltd in Noapara of Jessore and Gulfra Habib Ltd in Sitakunda of Chittagong.

According to the case statement, Badiur, who has been a director since 1995, set up a company, Ariel Maritime (Pvt) Ltd, in Singapore with three directors.

The authorised capital of the company was SGD 1 million and the paid-up capital was SGD 50,000. Badiur's invested capital was SGD 25,000 in 2003 and he has been operat-

ing the company since then. His investment increased to SGD 0.5 million, equivalent to Tk 1,68,38,800. According to ACC, Badiur could not show of the source of income that he invested in the and decided to meet Jahidur at his office at company.
