KCC aims to tackle city's waterlogging

UNB, Khulna

Khulna City Corporation (KCC) has undertaken a Tk 843.84 crore project, aiming to solve the city's perennial waterlogging crisis.

A project proposal -- "Drainage system development project for resolving waterlogging in KCC" -- was sent to the local government ministry on Tuesday for approval.

The project works include dredging nine rivers, including the Mayur and renovating its banks, reconstructing eight sluice gates, constructing large drains (62km) and small ones (128km) on both sides of nine major city roads.

Under the project, three bridges will be constructed over the Mayur river.

KCC Chief Planning Officer Abirul Jabbar said a Tk 100 crore project was taken earlier to end the waterlogging problem. Later, some additional works were included as per the directives of the newly-elected mayor.

Sources at the KCC said the city dwellers have long been demanding a solution to the waterlogging problem and a project was taken in 2013 to meet their demand.

Under the project, the dredging works of 12 rivers was done. But the Mayur got silted up again within two years for various irregularities in the works, resulting in waterlogging in the city.

Some headlines on the event read: "EWG 46.5% Kendre Oniom Peyechhe" or EWG finds irregularities at 46.5 percent centres; "46.5 Satangsa Kendre Oniom" or irregularities at 46.5 percent centres; "46.5% Kendre Nirbachan Sushthu Hoyni" or election is not fair at 46.5 percent centres; and "Gazipur city polls not fair: EWG". In the release, EWG explains that it visited 129 or

30.4 percent of the total 425 centres. According to its primary statement, EWG found irregularities in 60 centres, which is 46.5 percent of the visited 129 centers. Secondly, EWG claims it never said in the

statement that the election was "not held fairly".

Of the 159 electoral irregularities, 30 incidents involved presence of unauthorised persons at the centres, 28 incidents involved campaigning within 400 yards radius of the centre, and 24 incidents were of providing transportation for voters by candidates, the release added.

Number of 'shootout'

At least 856 children were subjected to torture, which is 227 more than that of last year. Among them, 148 were killed and 58 committed suicide. Meanwhile, bodies of 53 children were recovered after they went missing.

OTHER CASES OF VIOLENCE

In the past six months, six Hindu houses were torched and 28 idols vandalised. Arson attacks and vandalism at temples and altars also took place. In these incidents, 24 persons were injured.

Meanwhile, 90 journalists were tortured, harassed and threatened for performing their professional duties, the report also added.

Along the border, three Bangladeshis were killed and nine other were injured by Indian Border Security Force.

The administration imposed section 144 on 12 occasions across the country. Twenty-two people were killed in mob beating, added the ASK report.

Agood number of suspected drug traders and illegal drug users were also killed during reported gunfights with police and Rab. Contacted, Assistant Inspector General (Admin) of

Prison Headquarters, Abdullah Al Mamun, said they have long been facing lots of problems due to sudden rise in the number of inmates in the country's jails. Usually, he said, the jails hold double inmates than their

capacity, but now those packed up to 300 percent of their capacity. Replying to a question, Mamun said the jails were holding around 88,000 prisoners during the first week of the June which was the highest number of prisoners in the country's history. "Several thousand prisoners were released

on bail before Eid-ul-Fitr." He said, the number of inmates rose four to five times higher than their capacity in some jails, and they have to shift the prisoners to other district jails for accommodation.

As the anti-narcotic drive continues, the jail authorities will have to face a serious problem to accommodate the prisoners, a top official at the Department of Prisons said requesting anonymity.

Contacted, NHRC Chairman Kazi Reazul Hoque said the human rights of prisoners are being seriously violated in the overcrowded jails. "I think the law enforcers should be more careful about arresting people. If we assess the settled cases, we'll find over

out any specific allegation," he said. Besides, Hoque said procrastination in disposing of the cases or backlog of cases is one of the main reasons behind the rise in the number of inmates.

Human Rights Support Society (HRSS) adviser Nur Khan said jails should be turned into correction centres with various facilities to help inmates go back to normal life.
