## Three-year-old dies due to 'wrong treatment'

### Two investigation committees formed

A three-year-old girl who was suffering from cold and sore throat died allegedly due to "wrong treatment" at a private hospital in Chittagong city early yesterday.

The deceased, Raifa Khan, was the daughter of Rubel Khan, a senior reporter of the Bangla daily Samakal.

Family members said the toddler was feeling unwell since she caught cold a few days ago. "She also couldn't eat due to pain in the throat. So, we got her admitted at Max Hospital on Thursday evening," said the father.

The next day, a child specialist from University of Science and Technology Chittagong (USTC), Dr Bidhan Roy Chowdhury, was called in, and after seeing her, he advised some medication.

On Friday night, the duty physician administered her antibiotic but after taking that she started having convulsion, said Raifa's father. "When we asked the duty doctor, he

contacted the consultant over the phone and gave her an injection (around 12:20am)," he said. "Soon afterwards, the condition of my daughter was deteriorating, and she died around 12:30am."

The family members said the death came as a huge shock because the girl was playing around just a day ago -- till Thursday afternoon.

Meanwhile, following information

of the death, journalist leaders rushed to the hospital and urged the authorities to ensure punishment for the doctors concerned.

As the situation heated up, a team from Chawk Bazar Police Station came to the hospital and picked up duty doctor Debashish Sengupta, a duty nurse and a superintendent of the hospital.

On information, leaders of Bangladesh Medical Association (BMA) visited the police station and asked the law enforcers why they "arrested" the three. They also talked to journalists, and a heated exchange followed.

At one point, the detainees were released from police custody on condition that a probe-body would be formed with the civil surgeon of Chittagong as its chief, and punitive action would be taken if "negligence in treatment" or "wrong treatment" is found in investigation, said Hasan Ferdous, general secretary of the Chittagong Union of Journalists (CUJ).

Child specialist Bidhan Roy could not be contacted for his comment as he did not pick up his phone.

He said, "We formed a five-member committee to investigate the incident. Dr Debashish would be off duty till the investigation is finished."

Another investigation committee was formed by the government with Civil Surgeon Dr Azizur Rahaman Siddique as head. The five-member team will start their inquiry today.

Rubel Khan told The Daily Star that he would not get his child back, but he wants a proper investigation and punishment for the persons responsible.

Meanwhile, journalists yesterday formed a human chain in front of Chittagong Press Club, demanding cancellation of the accused physicians' registration, a fair investigation, and punishment for those responsible.

## Safe vegetables at low cost

Pest exclusion net trial in Mymensingh shows promise

Chemical-free fruit and vegetables are just what the doctor ordered. But the advantage of organic produce extends beyond public health. Now in its fourth season, an ongoing study by the Bangladesh Agricultural University in Mymensingh is demonstrating that the use of pest exclusion nets in place of pesticides offers environmentally-friendly, effective crop protection. In addition, as nets are relatively inexpensive farmers save on production costs.

"We first tested the nets on fifty vegetable plots in May 2016, with a variety of crops included such as brinjal, tomato, capsicum, cabbage

and okra," says Prof Dr Md Abdur Rahim who is leading the fivemember research team. "Results thus far have been promising; and for farmers the nets are cheaper than pesticides." "On average, on 10 decimals of

land a farmer would spend around Tk 2,000 on pesticides per season," the scientist explains. "Pest exclusion nets would cost about Tk 250."

Before reaching the marketplace, a basic crop like brinjal would need to be sprayed with pesticide up to 60 times to effectively protect it from pest attack. In alleviating the need for pesticides altogether, the human health and environmental gain from using nets is considerable, Dr Rahim adds.

"Pesticide pollution has already reached a critical level in the environment," says Israt Jahan, another scientist from the team who specialises in capsicum production. "Pest exclusion nets have great potential to prevent future environmental degradation." Currently the team has turned

their attention to fruit, especially mangoes and litchis. They hope suitable nets will be available for orchardists from next summer. At the same time, green, blue, yellow and white nets are being tested to determine which coloured nets best deter insect pests.

The research is being funded by USAID and development organisation Winrock International.

cer-in-charge of Kushtia Model Police Station, said on information that a group of JCD men were holding a "clandestine meeting to plot subversive activities", police raided Ragib's house in Thanapara area around 9:00pm and made the arrest.

The arrestees include JCD Kushtia district unit President Mahfuzur Rahman Mithun; General Secretary SR Shipon, Joint Secretary Rakibul Islam Rabbi and Organising Secretary Rokonuzzaman Russell. Police also recovered 23 crude bombs from a hideout near Ragib's house, the OC said. A case was filed with the police station.

Contacted, Barrister Ragib, who was present at the meeting, said the JCD men came to his house on a courtesy visit after the recent formation of the JCD district committee.

Meanwhile, BNP Secretary General Mirza Fakhrul Islam Alamgir protested the arrest of JCD men. In a statement, he demanded their immediate release.

### Fugitive convict makes himself invisible to police

Dodging arrest for more than two years while roaming freely in Rajshahi city

Despite having a conviction warrant in a cheating case, Ayub Ali Talukdar, a street vendor, has been roaming freely and even running a business openly in Rajshahi city.

Ayub was seen with his food cart near the same old spot in Shaheb Bazar area and was even available over the phone as well as active on Facebook till now but only police could not bother to arrest him, the complainant, Arifuzzaman Nabab, told The Daily Star.

Ayub resumed his food cart business in the beginning of this June, said Nabab, cheat." quoting witnesses.

"I informed Boalia police over the phone on June 14 when I saw Ayub selling street foods in Shaheb Bazar area but the law enforcers did not take any initiative to arrest him," he alleged.

Nabab, a driver of the Roads and Highways Department (RHD), was a regular customer at Ayub's food cart "Mama Halim" and gradually they became friends. In the beginning of 2009, Ayub borrowed Tk 1 lakh from Nabab but he refused to repay the money at the end of 2009, said the complainant.

On March 9, 2010, Nabab filed a case accusing Ayub of breaching trust and not paying his money back.

On July 24, 2011, Rajshahi Chief Metropolitan Magistrate Court sentenced Ayub to two years' imprisonment and fined Tk 20,000 in connection with the first charge. He was also jailed for five more years and fined Tk 30,000 as the second charge, too, was proven against him.

But after serving only 24 days in jail, Ayub managed to secure bail and appealed to the Sessions Judge's Court challenging the verdict. But the verdict was upheld on February 27, 2013.

Ayub was again sent to jail and this time

after 28 days he again secured bail and appealed to the High Court challenging the verdict but the HC dismissed the appeal on January 13, 2016.

According to court documents, Ayub has been absconding since January 7, 2016.

Complainant Nabab alleged that police were dillydallying as Ayub has a connection with a local Awami League leader. But, he could not mention any name.

When contacted, General Secretary of Awami League Rajshahi city unit Dablu Sarker said, "None from the local Awami League leader can support Ayub as he is a

A Jubo League activist was hacked to death allegedly by some youths at Digarkanda area in Mymensingh town on Friday. The victim is Millat Tarashi, 33.

Khandaker Shaker Ahmed, officer-in-charge (investigation) of Kotwali Police Station, said Millat was killed following a feud over a bike. The youths called Millat to Digarkanda to take back the motorbike on Friday afternoon. When he reached the spot, an altercation ensued and at one stage they allegedly hacked him, said the OC.

With injuries in his head and other parts of the body, he was taken to Mymensingh Medical College Hospital from where he was referred to Dhaka as his condition deteriorated. He died on the way.

His wife filed a case against 11 persons yesterday, the OC said Police detained one identified as Rabbi, 22, for his alleged involvement in the murder.
