HC issues show cause order to authorities

The High Court yesterday asked the health ministry and authorities in Chittagong to show causes on their inaction to supply bacteria-free water to CCC residents, why Star. they should not be directed to provide safe water to the residents, and to explain why they should not be directed to give compensation to jaundice-affected people in the port city.

It also ordered the health ministry to form a committee to examine whether there is Hepatitis-E virus in the Wasa water at the jaundice-affected areas of Chittagong, and to submit the test report to this court.

The health secretary has been asked to form the committee comprising two representatives from local administration of Chittagong and three experts within a month, and to submit the test report to the HC in 90 days.

Rohingya repatriation 'most urgent' Says Chinese ambassador

China yesterday said it believes that starting the repatriation of Rohingyas from Bangladesh is the "most urgent" issue right now.

"We have asked Myanmar both bilaterally and multilaterally on various occasions to resolve the crisis peacefully and start the process as soon as possible. We have also urged them to make their steps regarding Rohingya repatriation visible," said Chinese Ambassador Zhang Zuo.

The Chinese embassy organised the "China-Bangladesh workshop on Media Cooperation" where Information Minister Hasanul Haq Inu was the chief guest. The ambassador said, "China will try to promote the

negotiation process... on basis of the Bangladesh-Myanmar agreement to find a common solution." About trials of perpetrators who conducted atrocities

against Rohingyas in Rakhine, the ambassador said both Bangladesh and Myanmar should resolve the situation in a comprehensive manner so that relations between the two neighbours would not be affected.

China wants to play a "constructive" role in resolving the crisis, he said, adding "Both the countries should make full use of their respective advantages to cooperate in the development of border areas and livelihood of locals."

CASES AGAINST KHALEDA

High Court to hear four appeals today

The High Court (HC) deferred till today hearing on the four appeals in Zia Orphanage Trust corruption case filed against BNP Chairperson Khaleda Zia.

The HC bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman yesterday set 2:00pm today for starting the hearing on the appeals.

The deferment order was passed after Khaleda's lawyer Advocate AJ Mohammad Ali sought adjournment of the hearing.

The lawyer requested the adjournment as the apex court will today hear the petitions filed by Khaleda seeking review of its May 16 order that asked HC to hear and dispose of her appeal in Zia Orphanage Trust corruption case by July 31.

Of the four pleas, one was filed by the BNP chief seeking acquittal of the charges, a revision petition was filed by ACC seeking increase in Khaleda's jail term and two others were filed by convicts -- Qazi Saleemul Huq alias Qazi Kamal and Sharfuddin Ahmed -- seeking their acquittal of the charges in the case.

On February 8, the Special Judge's Court-5 of Dhaka sentenced Khaleda to five years' imprisonment after finding her guilty in the graft case filed by the ACC.

The court also jailed Tarique Rahman, now the acting chairman of BNP, and four others to 10 years imprisonment and

fined them Tk 2.1 crore.

The HC on March 12 this year granted four-month bail to Khaleda in this case. The Appellate Division on May 16 upheld the bail order, which will expire on July

The former prime minister filed a peti tion with the HC seeking extension of the bail order. The HC may hold hearing on the exten-

sion petition today, said ACC lawyer Advocate Khurshid Alam Khan.

Meanwhile, HC adjourned till today the hearing on a petition filed by Khaleda seeking stay on the trial against her in the Comilla arson case.

The bench of Justice AKM Asaduzzaman and Justice SM Mozibur Rahman passed the adjournment order after concluding yesterday's hearing, Deputy Attorney General Dr Md Bashir Ullah told The Daily Star.

Seven people were killed and many injured after a bus was torched in Chouddagram upazila in 2015.

The following day police lodged two cases for murder and another for arson in this connection.

On May 28 this year, the HC has granted bail to Khaleda for six months in the murder case. Later, on July 2 the apex court stayed the order and asked the HC to hear and dispose of the rule issued over her permanent bail within four weeks.

Why is NDM not registered? HC asks EC

The High Court yesterday issued a rule asking the Election Commission (EC) to explain in two weeks why it should not be ordered to register National Democratic Movement (NDM), led by Bobby Hajjaj, as a political party.

It also asked respondents to show causes why their decision to reject NDM's registration application should not be declared illegal.

The chief election commissioner, secretary to the EC and its deputy secretary concerned have been made respondents to the rule. The HC bench of Justice

Moyeenul Islam Chowdhury and Justice Md Ashraful Kamal issued the order, following a writ petition filed by Hajjaj challenging the EC's rejection to register NDM as a political party. Petitioner's lawyer

Barrister Rashna Imam told The Daily Star that EC on June 11 rejected NDM's application, saying the party's constitution was not amended with due process.

However, the EC did not mention any guideline in its letter dated June 28, as of how it should be amended, she added.

Rashed shown arrested

The same court also allowed the investigation officer in the ransacking case to remand Rashed for five days separately.

Station by a leader of Bangladesh Chhatra League (BCL). At that time, the ruling Awami League-affiliated student front also cracked down on the quota reform activists, beating them up mercilessly in Dhaka and elsewhere.

Since then, citizens, politicians and organisations have been on the street vocal against the "barbaric acts" of BCI and demanding unconditional release of Rashed.

Later, Mariam gave birth to a stillborn outside the health complex, the lawyer said, adding that the incident of refusing treatment to Mariam is a violation of her rights.

The HC asked Dr Mamun and Chhaya Rani Chowdhury to appear before the bench on July 25, when further a order on this issue will be passed. The health secretary has been asked to take necessary legal action against the duo during the investigation period.
