German investor mood slumps on trade war fears

Confidence among investors in Germany plunged sharply in July, the ZEW economic institute said Tuesday, reaching its lowest level since August 2012 over signs that a trade war was far from abating.

"Above all, fears of an escalation in the international trade war with the United States" drove the institute's barometer based on a survey of financial players down 8.6 points to reach -24.7, ZEW president Achim Wambach said.

President Donald Trump has hit steel and aluminium imports to the US with tariffs and threatened to do the same to European cars, after the European Union retaliated with border taxes of its own on American goods.

Major German firms have also suffered from the White House's trade war with Beijing, the second front in Trump's battle to slash US deficits, as their cars built in America face new tariffs when entering China.

Investors' views of the current situation in both Germany and the 19-nation eurozone worsened, suggesting recent "good news on industrial production, industrial orders and the labour market are more than cancelled out by the expected negative effects on exports" from the trade war, Wambach said.

Investors surveyed by ZEW also saw a bleaker future outlook for the 19-nation eurozone, with that index falling 6.1 points to reach -18.7.

ZEW polled 201 financial analysts and investors to compile its monthly index.

Frito-Lay unit sales

PepsiCo Inc reported second-quarter revenue and profit that topped Wall Street estimates as higher sales in its Frito-Lay unit in North America helped offset sluggish demand for beverages.

Pepsi's beverages unit that makes carbonated soft drinks has been struggling to reverse a four-quarter decline in sales as consumer taste shifts to low-calorie and low-sugar alternatives.

Sales in its North America beverage unit fell about 1 percent to \$5.19 billion in the quarter, the company said, but narrowly beat market expectations.

To overcome weak soda sales, Pepsi has been focusing on growing its snacks business by experimenting with new flavors, healthier methods of preparation and packaging designs.

These efforts led to a 4.3 percent rise in sales at its Frito-Lay division that makes Cheetos and Doritos tortilla chips.

Net income attributable to the company fell to \$1.82 billion, in the second quarter ended June 16, from \$2.11 billion, a year ago, mainly due to higher costs for transportation and raw materials.

Excluding one-time items, the company earned \$1.61 per share, beating analysts' average estimate of \$1.52 per share.

Total revenue rose 2.4 percent to \$16.09 billion, edging past analysts' average estimate of \$16.04 billion, according to Thomson Reuters.

Shares of the beverage and snack company were marginally up about 1 percent in premarket trading on Tuesday.

The company's shares have declined about 10 percent this year, steeper than bigger rival Coca Cola's 3.2 percent drop.

SoftBank tightens grip on Yahoo Japan via \$2b deal with Altaba

SoftBank Group is increasing its stake in Yahoo Japan through a \$2 billion, three-way deal with US firm Altaba to deepen ties with the internet heavyweight ahead of an IPO of its telecoms unit.

The transaction, with just \$9 million net investment by SoftBank, allows it to boost ownership of Yahoo Japan without pressuring its already strained balance sheet. It also leaves SoftBank's domestic telecoms unit with a 12 percent stake in Yahoo Japan, highlighting for investors the two companies' ties ahead of its planned listing.

In the case of Altaba, formerly called Yahoo Inc which also owns about 15 percent of Chinese ecommerce giant Alibaba Group, the deal helps monetize some of its investment in the joint venture it set up with SoftBank in 1996.

And for Yahoo Japan, the deal could strengthen ties with its biggest shareholder SoftBank and help to assuage concerns of investors who have seen its shares tumble this year. Yahoo Japan's shares ended 11.4 percent higher in Tokyo on Tuesday.

SoftBank announced on Tuesday it will buy 221 billion yen (\$2 billion) of Yahoo Japan shares from Altaba. Yahoo Japan will then buy back 220 billion of stock from SoftBank. As a result of the transaction, SoftBank's stake in Yahoo Japan will rise to 48.17 percent from 42.95 percent.

Shell curbs North Sea oil production as strikes bite

Oil major Royal Dutch Shell said Tuesday it had suspended production on its North Sea field of Knarr after staff working the Norwegian continental shelf went on strike, adding to supply worries in the world's oil market.

"Knarr's production has been stopped because of the strike," company spokeswoman Kitty Eide told AFP, adding that the field's output is around 23,000 barrels per day.

The shutdown was prompted by around 100 people at Knarr going on strike as part of a wider stoppage by nearly 670 people working on nine platforms or ships in the region.

They are members of the Safe union and striking over wages and pensions.

Employers association Rederiforbundet said that unions had now also issued a strike call to 900 additional staff who could take action at the weekend, potentially affecting another 20 sites.

That strike could have "huge consequences for the reputation, the economy and employment" in the oil sector, warned Jakob Korsgaard, who is negotiating on behalf of bosses.

The Norwegian strikes are adding to supply worries that have pushed the oil price higher in recent weeks.

Japan's Takeda gains US approval for \$62b Shire buy

Takeda Pharmaceutical Co Ltd on Tuesday said it has received US approval for its \$62 billion acquisition of London-listed Shire Plc, taking the Japanese firm one step closer to its goal of becoming a global top 10 drugmaker.

Takeda in a press release said it received unconditional clearance from the United States Federal Trade Commission.

The Tokyo-listed firm is still awaiting approval from regulators in China, the European Union and elsewhere, as well

from shareholders of both parties.

Chief Executive Christophe Weber has been working to persuade investors about the deal's cost-saving merits. However, concerns of the financial burden the combined company will carry has weighed heavily on Takeda's stock price.

Takeda shares closed flat on Tuesday ahead of the announcement. The stock is down 16 percent since the firm first said at the end of March it was considering bidding for Shire.


