Registration of Rohingyas in Bangladesh completed

Home minister tells JS STAFF CORRESPONDENT

There is no unregistered Rohingya person in Bangladesh at present, Home Minister Asaduzzaman Khan told parliament yesterday.

In reply to lawmakers' queries, the minister informed the House that biometric registration of 11,18,576 Rohingyas, who were forced to enter Bangladesh due to persecution against them, has been completed.

In a scripted answer, the minister also said a workstation is continuing its work in Cox's Bazar, to carry out biometric registration of newborn Rohingya children.

In reply to another query, the minister told the House that a total of 1,596 death row convicts are currently in different jails.

EUNIC Cluster launched in Dhaka

A mother's desperation Quota Reform Movement

Saleha Begum pleads to PM for Rashed's release

As quota reform movement leader Rashed counts his days in a 10-day police remand, his hapless mother is trying to do whatever possible to release her son.

Saleha Begum, 50, yesterday begged to the prime minister to release her only son. "Dear prime minister, you are a mother. I am too. I beg for my son's release. Please cancel his 10-day remand. Please with-

draw the cases." A distressed Saleha struggled to hold back tears at a press conference in Crime Reporters' Association of Bangladesh, in Segunbagicha.

"He took part in a logical movement. His movement was never anti-government. But a vested quarter turned this in a different way... We don't know he would pay

such a price," a sobbing Saleha told journalists.

"My son is a general student. He was not involved in any politics... My husband is a day-labourer and our family ; side and requested Prof Jamal to allow sturuns on his earnings," she added.

Muhammad Rashed Khan, joint convener of quota : mitting an application to the proctor. reformists' platform Bangladesh Sadharan Chhatra: Odhikar Sangrakkhan Parishad, is an MBA (Banking and

Insurance Department) student of Dhaka University. He was detained from the capital's Bhasantek on July 1, as law enforcers took a strong position against quota reform activists.

DU professor threatens to call police on students

· A teacher of Dhaka University yesterday threatened to call police on students pressing for release of a friend, who is in police cus-· tody for involvement in the quota reform

Prof AKM Jamal Uddin, a teacher of the sociology department, threatened the students of his department when the students were demonstrating at around 9:30am.

He took pictures of protesting students, threatened them "with consequences", and calling police if they do not stop boycotting classes, claimed students.

"If I think you are barring my path, then I will call police. I will call the proctorial team. Now it's up to you," he said, according to an audio recording The Daily Star obtained. At that time, another teacher of the depart-

ment, Prof Samina Luthfa took the students' · dents to carry out their programme of sub-

"I will take my classes and I will take steps · as per regularities, if you do not sit in my classes," Prof Jamal said, according to the students.

Earlier, the students took position in front : of the department after boycotting yesterday's scheduled classes. They also padlocked

the gate of the department.

"Boycotting classes cannot be the language of protest. It's not the university's duty to get a student released. You go to the High Court and get a lawyer for him. If you manage to do so then the department will bear the cost," Prof Jamal told the students.

Some Chhatra League activists of DU's Surya Sen Hall handed Moshiur, a quota reform movement leader, over to the law enforcers after beating him up on July 2. He was later shown arrested in the case filed over vandalising DUVC's residence.

TEACHERS, STUDENTS DEMAND SAFE **CAMPUS**

Meanwhile, a group of DU students yesterday formed a human chain in the Mokarram Bhaban area of the campus, demanding immediate release of the detained quota reformists, and a safe campus.

Speaking at the programme, Fahmidul Haq, associate professor of mass communication and journalism department, claimed many students were supposed to join yesterday's programme but could not do so fearing further attack and harassment.

"The administration is working as per government's direction. They are not even eager to bring the attackers under trial; instead they are busy in implementing

a shame to embezzle orphans' money STAFF CORRESPONDENT Prime Minister Sheikh Hasina yesterday said in parliament that despite being a woman and mother, BNP chief Khaleda Zia embezzled orphans' money, which is "shameful and a

stigma" for country's women. While replying to lawmakers' queries, she also said Khaleda was not arrested due to political reasons; she is now in jail following conviction by the court after 10 years of legal battle in the case.

"We didn't arrest her for political reasons. If we wanted to, we could do it in 2015 or 2014. She is in prison due to a court verdict," she said in reply to a question from Awami League lawmaker Nurjahan Begum (women's seat-42).

The prime minister said there are many seasoned lawyers and barristers in BNP, but none of them could prove Khaleda Zia's innocence.

She said BNP amended Section-7 of the party's charter just before the court's verdict against Khaleda Zia as BNP leaders knew that she is guilty.

As per the section, anyone being convicted on corruption charge cannot hold the party's leadership position.

Pointing to the Zia Orphanage Trust graft case, the PM said, "It is a stigma for the country's women... How could a mother steal or misuse the money of an orphan? It is shameful for us, women."

Hasina said her government always wants a democratic process to continue.

About the election system, she said more than 6,000 elections -- local government polls and by-polls -- were held

Govt violating Khaleda's visitation rights: BNP

Mirza Fakhrul Islam Alamgir, secretary general of the party, made the claim during a press briefing at the Nayapaltan headquarters of the

June 30 was the last time when Khaleda's relatives were allowed to visit her at the prison set up on the former central jail premises in Old Dhaka.

"Relatives and friends [BNP leaders] of Khaleda Zia have not been given permission to meet her in the last 11 days. Her relatives, lawyers and we could not meet her despite repeated attempts,"

Fakhrul said. Alleging that the government is violating Khaleda's human and constitutional rights as well as the jail code by barring her from seeing her relatives and party leaders, he speculated whether the government has intentions to "kill Khaleda Zia in solitary confinement in jail".

"Even doctors were not allowed to see her. What's their motive for depriving our leader of medical treatment? Do you [government] want to finish her off in the solitary confinement in jail? History will

not forgive you if you do so." He also said the government resorted to entrapment in order to confine the BNP chief in prison so she cannot take part in politics and elections.
