

# Indian home boss due today

Security issues to top agenda

Indian Home Minister Rajnath Singh arrives in Dhaka this evening on a three-day official tour of Bangladesh to facilitate a comprehensive review of current bilateral relations and sign deals for further liberalising the existing visa regime and cooperation between the two countries' police forces.

During the visit, he will call on Prime Minister Sheikh Hasina and will co-chair the 6th meeting of India-Bangladesh home minister-level talks which is expected to cover wide range of security-related issues.

He is coming at the invitation of his Bangladeshi counterpart Asaduzzaman Khan.

Apart from his meetings with Hasina and Asaduzzaman, Rajnath will tomorrow visit Bangladesh Police Academy in Rajshahi's Sardah where he along with Asaduzzaman will inaugurate India-Bangladesh Friendship IT Building. The four-storey building was built under a joint financing arrangement for providing sophisticated IT facilities.

In Sardah, a Memorandum of Cooperation will also be inked between Sardar Vallabhbhai Patel National Police Academy in Hyderabad and Bangladesh Police Academy to institutionalise and intensify cooperation between the two countries' police forces.

The home minister-level talks on Sunday will be concluded by signing of

Revised Travel Arrangements 2018 to facilitate further easing the visa process to encourage, specially the youth and students, higher studies in India.

The meeting will discuss issues related to security, border management, cooperation in countering illegal activities, counter-terrorism cooperation, and youth being influenced by extremist groups.

As per the programme schedule, Rajnath will arrive in Dhaka at 6:30pm and attend a dinner to be hosted by Indian High Commissioner in Dhaka Harsh Vardhan Shringla and it will be followed by a cultural programme.

The next day, the Indian home minister will call on Hasina at the Gono Bhaban at 10:00am.

He will then go to Jamuna Future Park to inaugurate state-of-the-art Indian Visa Application Centre (IVAC) with Asaduzzaman. This new IVAC will be the largest visa application centre in the country with some 50 application counters.

Rajnath will then fly to Rajshahi and attend the programmes at Bangladesh Police Academy at Sardah.

On the concluding day of his visit on Sunday, he will first visit the Bangabandhu Memorial Museum at Dhanmondi and lay a wreath at the portrait of Father of the Nation Bangabandhu Sheikh Mujibur Rahman. After that, he will go to the Dhakeshwari Temple.

He will join the home minister-level talks held on a regular basis

implementing the projects, officials and experts said.

U-loops on Mirpur Road and Airport Road, and four underpasses on the Kazi Nazrul Islam Avenue, were the shelved projects.

The government did build an overpass at the level crossing on Banani Staff Road and Kuril interchange on Airport Road, both of which hugely benefited commuters.

"... U-loops can greatly ease traffic congestion but, unfortunately, we find one kind of apathy among all governments to go for the low-cost and easily doable initiatives," said Prof Shamsul Hoque, transportation consultant and road safety expert.

He said large projects like flyovers and expansion of roads could not eradicate congestion, be it in the capital or on a highway.

"The glaring example of a low cost but hugely effective initiative is the Kuril intersection," Prof Hoque, who is involved in over a dozen large and small transport network plans in the country, told The Daily Star last night.

**BANGABANDHU CORRIDOR**

In 2010, the government moved to ease congestion on Mirpur Road and Buet experts, after carrying out a study in 2011, suggested building elevated U-turns and underpasses.

They said a drive to Gabtoli from Azimpur would take only 11 minutes instead of the 78 minutes it took then.

All relevant departments of the government and Buet approved the project titled Bangabandhu Corridor in March 2012.

"The move was perhaps one of the finest ideas. Instead of going for a costly flyover or elevated expressway, experts put forward a simple design for

uninterrupted traffic flow on the corridor with an estimated budget of Tk 775 crore," said Prof Moazzem Hossain of Buet's civil engineering department, who was involved in the project.

The project was included in the Public-Private Partnership (PPP) Cell, and the Prime Minister's Office in March of last year asked the Dhaka South City Corporation (DSCC) to implement it.

However, no one came forward to fund the project and experts recommended the government funds it.

The government then shelved the project due to lack of funds.

Another reason behind halting the project was the consideration of building an expensive elevated expressway proposed by ruling Awami League lawmaker Aslamul Haq on the same stretch of road.

Aslam's company submitted a proposal for building a four-lane elevated expressway from Amin Bazar to Azimpur, at an estimated cost of Tk 4,000 crore, well over five times the cost of the Bangabandhu Corridor.

The DSCC moved to appoint a consultant to conduct a feasibility study and prepare a design.

Aslam then said he would go for a joint venture with a Chinese company to implement the project but he could not arrange the funds.

**THE PLAN**

Now vehicles are stopped at the set of lights and have to wait for minutes before making right and U-turns, ultimately causing congestion on the Mirpur Road and the streets connected to it.

Under the plan, two elevated U-turns (loops) were to be built at the heavily congested Gabtoli Bus

Terminal to help buses enter and exit the terminal without getting in the way of other vehicles.

Another loop was planned at Mazar Road intersection for traffic heading towards Mirpur-1, -2 and -10 from the south. Traffic from Mazar Road and Mirpur-1, -2 and -10 would get an elevated U-turn at Technical intersection for a smooth run towards Gabtoli.

One other U-loop was supposed to be constructed over the Kalyanpur canal for easy exit of vehicles coming from Shyamoli Link Road and New Market and heading for Agargaon or Rokeya Sarani. Vehicles en route Gabtoli from Rokeya Sarani and Agargaon were to use a loop near Shishu Mela.

Those driving from Mohammadpur, Lalmatia, and Dhanmondi areas would use another loop to enter Suhrawardi Hospital or to head for Bijoy Sarani and Farmgate using an underpass at the Gono Bhaban intersection.

Vehicles on Crescent Road and Bijoy Sarani could use the underpass to go to Mohammadpur or Gabtoli-Shyamoli areas, while traffic from Manik Mia Avenue would have a loop at Dhanmondi 27-Mirpur Road intersection to go towards Dhanmondi 27 and Lalmatia.

Two underpasses at Nilkhet intersection would ensure a smooth exit of vehicles to and from Azimpur and Science Laboratory ends.

"The project is more cost-effective. Unfortunately, Bangabandhu Corridor did not see the light of day," said Prof Moazzem Hossain, who now heads Buet's Accident Research Institute. He was involved in the planning and designing of Bangabandhu

## Khaleda's HC bail extended till July 19

The High Court yesterday extended till July 19 its earlier order that granted bail to BNP Chairperson Khaleda Zia in the Zia Orphanage Trust corruption case.

The bench of Justice M Enayetur Rahim and Justice Md Mustafizur Rahman passed the order following a petition filed by Khaleda seeking extension of her bail.

The Special Judge's Court-5 of Dhaka on February 8 had sentenced the BNP chief to five years' imprisonment in the case filed by the Anti-Corruption Commission.

## Autism prevalence

Professor Shaheen Akhter, director of the Institute of Pediatric Neurodisorder and Autism (IPNA) at Bangabandhu Sheikh Mujib Medical University (BSMMU).

People should be encouraged to have their babies screened at an early stage if they detect any signs of the disorder, she told The Daily Star.

Autism, a developmental disability, has a wide range of symptoms that include difficulty with social interaction and repetitive behaviour. It is a lifelong condition.

Findings of the recent survey, conducted by IPNA and supported by Directorate General of Health Services and Bangladesh Bureau of Statistics, were presented yesterday in the capital's BSMMU.

The survey has found that maternal illness, including hypertension, diabetes, asthma, fever with rash and urinary tract infections, during pregnancy is related to high prevalence of Autism Spectrum Disorder (ASD).

Jannatara Shefa, research medical officer of IPNA, said, "This study will help us find areas to focus on and know the extent to which autism facilities should be expanded. All autism related services in Bangladesh are in urban areas. There is nothing in rural areas."

She also said the DGHS had an interest in autism and it could take

steps to detect ASD cases and provide some therapies in upazila and union level facilities.

The study has also found premature births associated with higher ASD prevalence.

Babies born through C-section are more than twice as likely to have ASD as the ones born normally. There is also high ASD prevalence in babies, who cry over five minutes after birth, according to the report.

Contacted, Abul Kalam Azad, director general of the DGHS, said, "We found autism prevalence higher in rich, educated and wealthy families. This trend is similar around the world. We will continue to conduct surveys on a regular basis and if we find the same association again, we will do a research on the issue."

In 2013, Dhaka Shishu Hospital conducted a survey that reported autism prevalence to be 15 per 10,000 children aged below nine years.

In 2016, an IPNA survey conducted in rural areas reported autism prevalence to be 7.5 per 10,000 children aged between 18 and 36 months.

The recent study was designed to assess the prevalence of the condition among young children. It was aimed at determining the socio-economic and demographic associations of ASD in Bangladesh, researchers said.

joint convenor of Bangladesh Shadharan Chhatra Odhikar Sangrakkhan Parishad, the platform that spearheaded the quota reform movement.

Yesterday's incident happened at a time when four other central leaders of the platform had already been arrested in different cases and many quota reform protesters had come under attack by Bangladesh Chhatra League (BCL) men across the country.

Suhel, 23, was also beaten up allegedly by some leaders and activists of the pro-Awami League student body near his campus on May 23 for participating in the movement, said his friends and other quota reform leaders.

Later, he filed a general diary with Sutrapur Police Station in this regard, they said.

In a Facebook post, Lucky Akter, a former president of Bangladesh Chhatra Union, wrote that a group of men introduced themselves as detectives and picked up Suhel from her house around 5:45am yesterday.

Throughout the day, detectives, however, kept denying detaining Suhel, said his younger brother Sumon Islam, a college student.

Sumon said he along with some of Suhel's friends stayed in front of the DB office on Mintu Road from 9:00am to 5:00pm. They repeatedly asked those stationed at the gate about Suhel's whereabouts but they said he was not there.

Talking to The Daily Star around noon, Devdas Bhattacharya, additional commissioner (DB) of Dhaka Metropolitan Police, and Najmul Islam, additional deputy commissioner of the cyber security unit of the DMP, also said they did not pick up anyone named Suhel.

"As far as my knowledge goes, no one named Suhel has been detained. The information [regarding Suhel] is probably incorrect," Devdas told this correspondent over the phone around 11:40am.

While speaking, he took a small pause to recheck what he just said and reconfirmed it.

Suhel's arrest was disclosed on DMP's news portal dmpnews.org around 6:30pm. "The Detective Branch of Dhaka Metropolitan Police has arrested one of the members of anti-quota movement. The arrestee is Suhel Islam," the portal said.

In the Facebook post, uploaded at 8:41am, Lucky said, "DB police raided my home around 4:15am. They were a team of eight to 10 men ... at one point, they threatened that they will break open my door. I told them to come in the morning. I opened the door after they arrived along with the landlord uncle around 4:30am."

As the law enforcers came inside, they handcuffed Suhel and took him to another room for interrogation, she said.

"... They seized all our phones. They checked my phone as well ... while they were taking Suhel away, I asked them about the charges against him. They said they were taking him for interrogation over the quota reform protests.

"Before leaving [along with Suhel] they checked the [browsing] history of the computer at the house. They also thoroughly checked the room where Suhel was staying. They did not get anything apart from Suhel's [mobile] phone," added Lucky, also a leader of Gonojagoron Mancha, a platform that spearheaded the Shahbagh Movement in 2013.

She said Suhel requested her not to disclose anything about the incident to his mother as the death of his father took a toll on her health.

As the news spread, Sumon along with four of Suhel's friends went to the DB office. One of the four, who wished to remain unnamed fearing police repression, told this correspondent, "When Rashed [joint convenor of the reform movement platform] got arrested, Suhel was afraid that he would be arrested as well. That's why he started staying outside his home."

He said Suhel was appearing in his third-year final exams and the next test would be held on Sunday.

Hailing from Atowari of Panchagarh, Suhel is third among his five siblings. His father was a farmer,

who died last year.

One of Suhel's elder brothers runs a grocery shop in Panchagarh while the other is currently unemployed. Around four months ago, Suhel brought his mother and Sumon to the capital and started living together in a rented house.

He runs the family and bears his educational expenses by tutoring other students, added his friend.

Among other leaders of Bangladesh Shadharan Chhatra Odhikar Sangrakkhan Parishad, joint conveners Muhammad Rashed Khan has been placed on 10-day remand while Jashim Uddin Akash, Moshir Rahman and Faruk Hassan on two-day remand each. Later, they were shown arrested in different cases filed in April.

On June 30, Nurul Haq Nur, a joint convenor of the platform, was beaten up mercilessly by some Chhatra League men. Later, he was taken to Dhaka Medical College Hospital where he was allegedly denied treatment.

While under treatment at a private hospital, he was allegedly forced to leave the hospital in the dead of night on July 2.

Four quota protesters were beaten up in front of the National Museum in Shahbagh on July 1.

The next day, the BCL men appeared more aggressive when they beat up some protesters who had gathered on the Central Shaheed Minar premises to form a human chain.

They beat and picked up Faruk and handed him over to Shahbagh Police Station. Moments before the attack, three on-duty police members were seen leaving the Shaheed Minar premises, said witnesses.

Later at a press conference, a female protester, Moriom Mannan Farah, alleged she was also assaulted by a group of youths who picked her up from the Shaheed Minar area on that day and handed her over to Shahbagh Police Station. She alleged she faced harassment at the police station as well.

On July 2, Chhatra League men attacked Torikul Islam, another quota reform leader, with a hammer and

sticks near the Rajshahi University campus. Later, Torikul was allegedly forced out of Rajshahi Medical College Hospital.

All the attackers, meanwhile, roam freely.

physical, psychological, legal and digital aspects constitute safety issues for newsmen.

The dialogue, held at the Brac Centre in the capital, was attended by journalists from local and national news outlets, journalist union leaders, academics, civil society representatives and experts.

They said the guideline for journalists' safety protocol should be a product of a joint exercise of all stakeholders, including the Editors' Council, Newspaper Owners' Association, Press Institute of Bangladesh, journalists' unions, Jatiya Press Club, the Dhaka Reporters Unity and all such bodies.

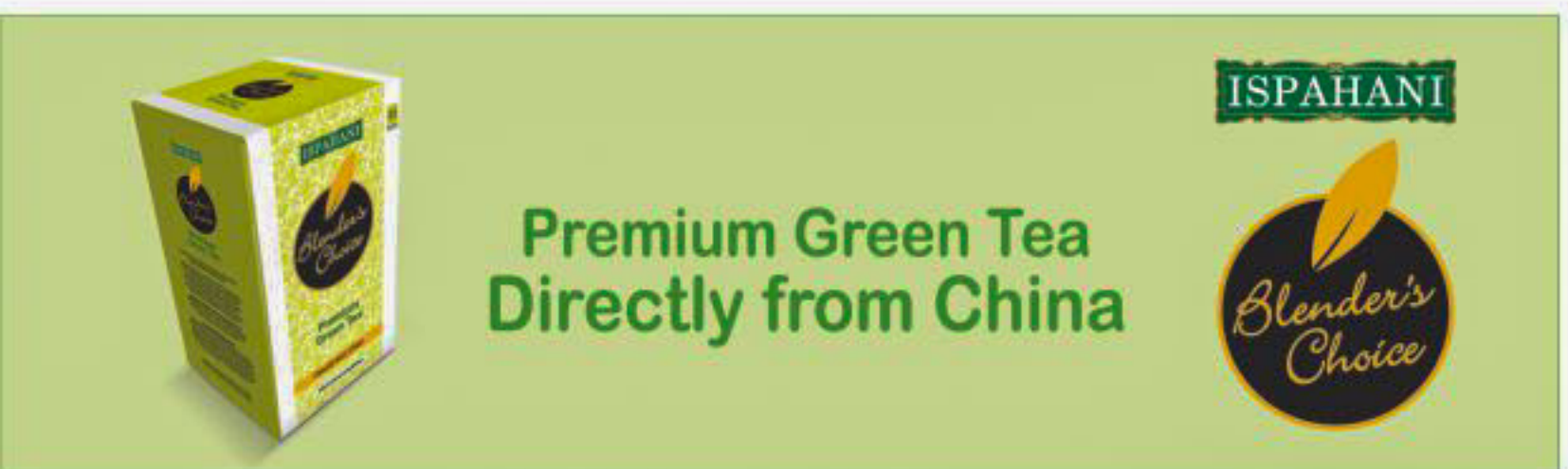
The editors stressed that the existing international best practices should form the basis of the safety protocol, which would hopefully be adopted and practised by media outlets.

They also called on the government and its agencies to do as much as possible to ensure safety and security of journalists and remove various hurdles that threaten press freedom.

Ranga Kalansooriya, regional advisor for Asia, International Media Support; Rana Ayub, investigative journalist and writer; and Lucy Freeman, chief executive of Media Legal Defence Initiative, also spoke on the occasion.

Reazuddin Ahmed, a veteran journalist, editor, union leader and also a member of the Editors' Council, chaired and moderated the programme.

Mahfuz Anam, editor and publisher of The Daily Star, also the Editors' Council general secretary, welcomed the participants and highlighted the safety and security issues of journalists for discussion.
