BNP blames AL for rifts in alliance

DWOHA CHOWDHURY, Sylhet

It's a tough road ahead for the BNP mayoral candidate. Not only Ariful Haque Chowdhury has to face a rebel BNP candidate, but also a Jamaat-e-Islami-backed independent candidate in the July 30 Sylhet city polls.

BNP leaders blamed Awami League for mechanising the rift inside the 20-party alliance and alleged that the two other candidates shared "close ties" with the ruling party.

The candidates (ruling party, rebel and Jamaat-backed ones), however, denied the allegation.

Meanwhile, many voters are bothered about the issue. Dulal Miah, a rickshaw-puller in Akhalia area, said, "If BNP continues to quarrel among themselves, Awami League

will win easily." Sharif Ahmed, a businessman in Rikabibazar area, said the BNP candidate's votes would be split in three ways,

which would eventually benefit the AL candidate. Ali Ahmed, general secretary of Sylhet district unit BNP and a member of Ariful's election management committee, alleged that rebel candidate Badruzzaman Selim and

Ehsanul Mahbub Jubayer, ameer of city unit of Jamaat-e-Islami, have close ties with AL's Badar Uddin Ahmed Kamran. "Jamaat leaders are facing hurdles everywhere except for Sylhet as AL leaders are involved in business with them. We saw how Jamaat's candidate started campaigning months

before the election without any problem," he alleged. He said Badruzzaman Selim has been suspended from the party as "we are sure he is working in favour of the ruling

party candidate". AL leaders in Sylhet Selim and Jubayer denied the allegation.

Serniabat skips 'face to face with citizens'

The "face to face with citizens" programme was organised by the Barisal chapter of Shushashoner Jonno Nagorik (Shujan) at Ashwini Kumar Hall in Sadar Road area of the

Six mayoral candidates out of seven -- Mojibor Rahman Sarwar (BNP), Iqbal Hossain Taposh (Jatiya Party), Abul Kalam Azad (CPB), Obaidur Rahman Mahabub (Islami Andolon Bangladesh), Dr Manisha Chakrabarty (BSD) Bashir Uddin Junu (Independent/rebel Japa) -- attended the programme. They signed a written oath to make the city free from corruption, drug addiction and terrorist activities. They also promised to make Barisal a beautiful and clean model city, raising their hands together to seek co-operation from citizens.

Shujan secretary Dr Badiul Alam Majumdar coordinated the event, while Saha Sajeda, president of the organisation's Barisal City chapter, presided over the meeting that saw an attendance of about a thousand people.

Shujan was told Serniabat's absence was a decision from his party, said Akkas Hossain, district general secretary of Shujan. His absence at the event, however, was met with mixed reactions.

Dispute over money led to the killing of Prabir Ghosh,

office of the superintendent of police (SP) in Narayanganj.

SP Moinul Haque, additional SP of detective branch (DB) Nur-e-Alam and a number of high officials of police were present during the briefing. Police recovered the body of Prabir, owner of Bholanath

Jewellers in the city's Kalirbazar area, after gleaning information from two suspected killers -- Prabir's friend Pintu Devnath, who also owns a jewellery store; and Pintu's employee Bapen Bhowmik Babu. According to the evidence found during primary investi-

gation, Pintu and Bapen killed Prabir at Pintu's flat in Amalpara area and dismembered the body before hiding it in an abandoned water reservoir in the same building, the police officials said.

Before going missing on June 18, Prabir used to loan his friend, Pintu, money that he received from his brother Soumik Ghosh, who lives in Italy, police said.

Pintu planned and killed Prabir in his flat as the victim wanted his money back. Police tracked down and arrested Bapen on Monday using mobile phone technology. They arrested Pintu the same day.

Prabir's elder brother Biplob Ghosh however said money cannot be the only motive for his brother's

Further details will be available once a thorough investigation into the killing is complete, police officials said during the briefing.

Vast swathes of Tangail town as well as the sadar upazila are under threat of getting washed away as portions of the town's embankment has been devoured by the Jhinai river.

Although the river, a distributary that branched off the Jamuna, has already eroded a significant width of the embankment at Ranagachha village under Gharinda union over the last two days, the authorities concerned did not take any step to check the erosion.

The road on the embankment has also been damaged partially due the erosion, raising con-

cerns of imminent accident, locals said. While visiting the area on Wednesday and

eral villagers who said they were living in fear as a number of dwellings and croplands have already gone under the rising water of the Jhinai river.

Tula Miah, a resident of Ranagachha village, said, "Nearly half of the levee's width along with the road has already gone in the river over the last couple of days and the rest of it may go in it any moment now."

"Even though the authorities should've taken preventive measures to stop the erosion before the water level rose, they are yet to do so."

Another villager, Shahadat Ali, blamed indiscriminate sand lifting for the river's erosion. "The erosion has turned for the worse in the area

mob beating after failing to frame man OUR CORRESPONDENT, Manikganj

Two policemen were rescued from an angry mob after failing to frame an innocent villager by planting drugs in Manikganj's Singair upazila on Thursday evening.

The incident took place in Chhoto Kaliakoir Bazar area. Around 7:30pm, Sub-inspector Manik and constable Zahid of Singair Police Station went to the area and caught day labourer Hashem Ali, 22, when the latter was chatting with villagers. While grabbing Hashem, one of the policemen planted

two Yaba tablets in the pocket of his shirt, accused him of being a drug peddler, and handcuffed him, said locals. Hashem protested the incident right away and so did the onlookers. The villagers also surrounded the cops and

started preparing to give them a beating. On information, Officer-in-Charge of Singair Police Station Khandaker Imam Hossain and local ward councillor Idris Ali came there and rescued the two after two hours of discussion.

Seeking anonymity, locals said Hashem went to the market to buy some medicines. On his way back, he was having a conversation with some people on a bridge near the bazar. The two policemen showed up at that time on a motorcycle. Locals also said police had arrested several people by

falsely implicating them in drugs cases recently and squeezed a huge amount of money from them. The informers get a share of the money. Day labourer Hashem of Chhoto Kaliakoir village said, "I

was talking to some villagers at the time. The policemen arrived suddenly and grabbed me by the lungi and shirt I was wearing. One of them quickly put something in my pocket and said 'Yaba pills were found in your pocket'."

Talking to The Daily Star, OC Imam Hossain said the policemen went to the place and made the arrest on the basis of secret information. "But we found him innocent after I went there and talked to the man. The situation arose

because the informer gave us false information about him." When asked, the OC however declined to say anything about planting the drug.
