









Students and teachers of Dhaka University congregated once again at the Shaheed Minar premises yesterday, demanding release of arrested quota reform protesters and a safe campus, when a group of Bangladesh Chhatra League (BCL) activists took position in the vicinity, hurled abuses and intimidated them. Later, as the demonstrators marched towards the Raju Sculpture, the BCL men swooped in on them in the Shibbari area and assaulted the students. Meanwhile, a procession of Progotishil Chhatra Jote demanding a reform to the quota system instead of scrapping it, was blockaded by police near Shahbag.

# Don't isolate me from people: PM to SSF

## DESTINY GROUP Dispose of graft case by April 18

HC directs trial court

The High Court yesterday ordered the trial court concerned with finishing the proceedings of money laundering cases filed against Destiny Group officials, by April 18 next year.

Anti-Corruption Commission (ACC) filed the graft cases with Kalabagan Police Station in July 2012, accusing 22 top officials of Destiny Group, including its Managing Director Mohammad Rafiqul Amin.

According to the cases' charge-sheet, top officials of Destiny misappropriated some Tk 4,200 crore through its tree plantation project and cooperative firm, and laundered the money abroad.

The bench of Justice Md Nazrul Islam Talukder and Justice KM Hafizul Alam passed the order following a prayer from the lower court seeking more time to conclude the trial. Earlier in August 2016, HC ordered the trial court to finish

the proceedings in the case within 12 months, said Advocate Khurshid Alam Khan. On June 24 this year, Judge Md Akhtaruzzaman of the trial

court concerned sent a letter to Supreme Court registrar general, praying for more time.

The SC Registrar General Dr Md Zakir Hossain placed the letter to the chief justice for a decision, who later sent it to

The murder suspect, his roommate Alamgir, 22, is on the run.

## **Journalists** need to be sceptical

Journalists need to have training and professional scepticism to be able to serve the community better, speakers said at the closing session of a two-day workshop yesterday.

Journalists must be allowed to act independently and not serve anyone's

interests, they said. "A journalist must be professional and honest while checking facts for credible news, and be responsible while publishing news to earn public trust," said Shah Alamgir, director general of Press Institute of Bangladesh, in his conclud-

ing remarks. Bangladesh NGOs Network for Radio and Communication (BNNRC) with support from Internews Network organised the training session on "Fact checking and verification techniques in news reporting", attended by 26 journalists at The Daily Star Centre.

Syed Zain Al Mahmood, country director of Internews, said, "Scepticism is a safeguard for a professional journalist." Trained journalists empower people with accurate information and make democracy more meaningful, he added.

The training session focused on topics like fighting fake news and circular reporting (where a piece of information appears to come from multiple sources, but in reality, comes from only one source), verifying images and videos, analysing common mistakes in journalism, ensuring balance, overcoming bias, and using neutral language. British journalist Chris

Stephen from The Guardian, who has reported from eight war zones, conducted the workshop. AHM Bazlur Rahman, chief executive officer of BNNRC, was

present.

# Khaleda denied bail in case for demeaning martyrs

COURT CORRESPONDENT BNP Chairperson Khaleda Zia, who has been in jail for about six months now, was denied bail yesterday in a case

filed over demeaning Liberation War martyrs. Dhaka's Metropolitan Magistrate Abu Sayeed passed the order after Khaleda's lawyer Masud Ahmed Talukder sub-

mitted a petition seeking bail in the case. Earlier, on July 11, the same court issued arrest warrants for the BNP chief and party's senior leader Gayeshwar

Chandra Roy in the case. In January 2016, AB Siddique, president of Bangladesh Jananetri Parishad, a pro-Awami League organisation, filed the case over Khaleda's alleged insulting remarks about martyrs.

Taking cognisance of the allegation, another court directed the officer-in-charge of Shahbagh Police Station to investigate the matter and submit a report.

On December 21, 2015, Khaleda, in her first public address in more than a year, said, "There are controversies over how many were martyred in the Liberation War."

Two days later, a Supreme Court lawyer served a legal notice on Khaleda, asking her to apologise to the nation within seven days or face legal consequences for her comments. On December 25 the same year, in a flurry of outrageous

remarks, Gayeshwar described the 1971 martyred intellectuals as "anti-liberation elements" who "died like fools" and drew salaries and allowances from Pakistan till the end of the war.

Different newspapers published the news items citing their comments. which defamed the image of freedom fighters who sacrificed themselves for liberating the country in 1971, said the complainant.

Meanwhile, the High Court yesterday heard for the second day the appeal filed by Khaleda challenging the trial court verdict that sentenced her to five years' jail in the Zia Orphanage Trust Corruption case.
