CVASU student suspended over pro-quota reform Facebook posts CU CORRESPONDENT

The authorities of Chittagong Veterinary and Animal Sciences University (CVASU) yesterday in a disciplinary meeting suspended one of its students for posting on social media in favour of quota reform.

The suspension was called against Mir Mohammad Junayed, a 2013-14 session student of medicine faculty.

Prof Gautam Dev Nath, proctor of CVASU, said Junayed posted two status updates on Facebook on July 9 and 12 respectively, which were provocative and went against the discipline of the university.

The posts were clear violation of section 16 of university's rules regarding general discipline, he said.

The authorities also formed a three-member probe committee headed by CVASU Assistant Proctor Ashraful Islam, and asked it to submit a report within seven working days.

Electoral promises target AL, BNP candidates accuse police of harassment

It was BNP's mayoral candidate, who has been complaining of arrest of his men and frequent police visits to homes of the party leaders and activists since the beginning of election campaign on July 9.

Now, Awami League candidate AHM Khairuzzaman Liton has brought similar allegations against the police.

BNP candidate Mosaddek Hossain Bulbul attributed the police visits to "intimidation" aimed at discouraging BNP activists from working for him.

In a complaint submitted to the returning officer yesterday, the AL candidate alleged that police went to homes of different AL leaders and activists without any warrant against them and misbehaved with their family members.

Liton, in his complaint, said that police visits have "sparked panic" among his workers who were given certain responsibilities for his election campaign.

City AL organising secretary Nurul Islam Sarker Aslam said police went to the houses of several AL leaders including Raja of Seroil Colony and Rabiul of Malda Colony areas. Police arrested a Sainik League leader Apel, but released him later, he said.

In another complaint, Liton brought an allegation of biased conduct against the deputy commissioner of Rajshahi who, according to him, would allow BNP men to meet him at his office while denying AL men.

Returning Officer Sayed Amirul Islam told The Daily Star that he talked to the DC after receiving Liton's complaint and asked him to behave impartially. Bulbul, during his campaign yesterday, said that AL men are hamper-

ing his campaign by attacking his men. Complaining to the returning officer is not helping, he added. The returning officer said he has so far received at least 12 complaints,

of which BNP candidate has made six while AL candidate has filed the He said, most of the complaints were related to law and order, and

were forwarded to the police commissioner. Rajshahi Metropolitan Police Commissioner AKM Hafiz Akhter said, police visited some AL men's homes to warn them for removing posters

Metropolitan Magistrate Safi Uddin passed the order after police produced accused Asif Mizan, 23, with a seven-day remand prayer, said Assistant Commissioner (prosecution) Kazi Shahabuddin of Chittagong Metropolitan

Charges framed against nine Mymensingh men

The International Crimes Tribunal-1 (ICT) yesterday framed eight charges against nine men from Mymensingh in a case filed over crimes against humanity committed during the Liberation War in 1971.

The three-member tribunal led by Justice Md Shahinur Islam fixed September 11 for beginning the trial. It also asked the prosecution to produce their witness on that day. According to the prosecution, the accused were involved in killing at least 101 persons and injuring 10 to

In addition, they were also involved in the rape of a woman and torching of 110 to 112 houses in Muktagachha and Mymensingh Sadar upazila, they added.

Of the accused, Abdus Salam, Suruj Ali Fakir, Joyen Uddin Faruki alias Joynal Abedin, Abdur Rahim alias Abdur Rahim Master, Jalal Uddin, Shamsher Fakir, and Rustam Ali, are now in jail. Fazlul Haque and Shamsul Haque are absconding.

The tribunal's investigation agency on March 29 last year completed the probe and found evidence against the

nine accused. Abdus Salam was allegedly involved with Al-Badr force, while the rest were alleged Razakar men, the agency said.

The prosecution on June 19 last year pressed eight charges against the nine.

Woman, daughter found dead inside water tank

A mother and daughter were found dead inside the water reserve tank of a building they used to live in, in Ambagan area of Chittagong yesterday.

The deceased are Monwara Begum, 94, and her daughter Meherunnesa, 64, a retired banker.

Police suspect the bodies were dumped into the water tank on the ground floor of the four-storey building after the two were killed.

Construction works for the building, which belonged to Meherunnesa, were not completed. She bought the sixdecimal land in 2000. The construction began a few years back. The mother and daughter used to live on the ground

floor by themselves. At the moment of the incident, no construction work was going on. Except for Meherunnesa, all of Monwara's four daughters

and five sons live abroad.

Belal Uddin, a grandson of Monwara, told The Daily Star that one of his uncles was trying to reach her over the phone since morning. "Her three cell phones were found switched off, so my uncle called and asked me to go to her house to check," said the 50-year-old local businessman. He said when he reached there he found that the front

gate of the house was locked from outside while the one in the back was open. "Once I stepped inside, I saw blood on the kitchen floor. Many of the furniture were ransacked. So, I called police right away." Sheikh Md Nasir Uddin, officer-in-charge of Khulshi Police

Station, said after searching the building they found the bodies inside the reserve tank. The bodies were tied with ropes. Fire service officials recovered the bodies and sent those

to Chittagong Medical College morgue for autopsies. SEE PAGE 4 COL 4
