Lafontant had faced a potential vote of no confidence had he not resigned -- something he had previously insisted he would not do.

Netanyahu, Trump discuss Syria, Iran

Israeli Prime Minister Benjamin Netanyahu yesterday said that he discussed Syria and Iran with US President Donald Trump ahead of the latter's meeting in Helsinki with Russian President Vladimir Putin. In remarks to the Israeli cabinet, Netanyahu said that in a phone conversation on Saturday he thanked Trump for his tough stance against Iran.

Police killing sparks protests in Chicago

A violent clash broke out late Saturday in Chicago's predominately black South Side neighborhood after police shot and killed a man whom they suspected was carrying a firearm. A crowd of about 150 residents shouted "murderers" and obscenities, local media reports said. Officials said three or four officers suffered minor injuries and one patrol car was damaged, and four protestors were arrested.

Trump says he will run for re-election in 2020

US President Donald Trump said he intends to run for reelection in 2020 because "everybody wants me to" and there are no Democratic candidates who could defeat him, the Mail on Sunday newspaper reported. Asked by British journalist Piers Morgan in an interview given on Friday whether he was going to run in 2020, Trump was quoted by the Mail on Sunday as saying: "Well I fully intend to."

AFP, Kabul The number of Afghan civilians killed in the country's longrunning conflict hit a record high in the first six months of 2018, UN figures showed yesterday, with militant attacks

and suicide bombs the leading causes of death. The toll of 1,692 fatalities was one percent more than a year earlier and the highest for the period since the United Nations Assistance Mission in Afghanistan (UNAMA) began keeping records in 2009.

Another 3,430 people were wounded in the war, down five percent from the same period last year, the report said.

The record high death toll came despite an unprecedented ceasefire by Afghan security forces and the Taliban last month that was largely respected by both sides, UNAMA said.

The ceasefire for the first three days of Eid was marked by scenes of jubilation as security forces and Taliban fighters celebrated the Islamic holiday, raising hopes that peace was possible after nearly 17 years of conflict. The Taliban refused a government request to extend the truce.

But the suspension of hostilities was marred by two suicide attacks in the eastern province of Nangarhar that killed dozens of people and were claimed by the Islamic State group, which was not part of the ceasefire.

UNAMA attributed 52 percent of suicide and complex attacks to IS, mainly in Kabul and Nangarhar where the group established a stronghold after emerging in Afghanistan in 2014. The Taliban was responsible for 40 percent of such attacks.

The latest report comes almost a year after US President Donald Trump announced his new South Asia strategy that involved ramping up American air strikes against militants.

Family meets Sharifs at jail

Muslim League-Nawaz president Shahbaz Sharif along with his mother and other family members on Saturday night visited ousted premier Nawaz Sharif, his daughter Maryam Nawaz and son-in-law retired Capt Mohammad Safdar, who began serving their prison terms in the Avenfield properties reference, at Adiala jail. The family members, including Maryam

Nawaz's daughter Meharun Nisa and Shahbaz's son Hamza Shahbaz, were earlier flown to Islamabad from Lahore on a special plane for the meeting, which took place in the jail superintendent's room and continued for more than two hours.

No other party leader or worker visited Nawaz Sharif and Maryam Nawaz on their first day in jail. The meeting of the family members, however, had been arranged on a special permission of the government, a senior official of the district administration told Dawn.

Hours before the visit, Shahbaz told a press conference in Lahore that the party would use all available options, legal and political, to challenge the caretaker government's decision about the jail trial of the former premier. He expressed the hope that the Sharif family would get relief in the London properties case from the high court.

Nawaz Sharif and Maryam Nawaz were handed down 10 and seven years' imprisonment, respectively, in the London properties case last week.



25 arrested in

India after latest lynching

Police in India have arrested more than two dozen men who were part of a mob that lynched a 32year-old man after rumours spread over WhatsApp that he was a child-kidnapper, police said yesterday.

The killing of Mohammed Azam, who police said was a call centre employee, in the southern state of Karnataka on Friday, was the latest in a series of assaults in India triggered by false messages about child abductors spread through Facebook Inc -owned WhatsApp.

At least three people have been killed and more than a dozen assaulted over such rumours this year, according to media reports.

Dileep Sagar, a police inspector in Karnataka, said a mob of at least 50 people attacked Azam and a relative after they were spotted offering chocolates to children in a remote village.

Blast at Afghan ministry kills 7

AFP, Kabul

A suicide attacker blew himself up in front of a government ministry in Kabul yesterday as workers were leaving their offices, killing at least seven people and wounding more than 15, officials said, in the latest deadly violence in Afghanistan.

There was no immediate claim of responsibility for the explosion that police spokesman Hashmat Stanikzai said happened at the rural rehabilitation and development ministry around 4:30pm.

Civilians and security forces were among the seven dead, Stanikzai said.

Ministry spokesman Fraidoon Azhand said the bomber struck at a security gate as employees were exiting the compound during rush hour. But it was not clear if the ministry was the target of the attack.

Stanikzai said security forces and a vehicle belonging to foreign advisers to the ministry were in the vicinity at the time of the attack.

There were no foreign casualties, he added. It is the second time in just over a month that the ministry has been caught up in a suicide attack.

On June 11 a bomber blew himself up as ministry workers queued for an early bus home during the holy month o f Ramadan, killing at least 13 people and wounding 31.

The Islamic State group claimed responsibility for that

attack. While the Taliban is Afghanistan's largest

militant group and holds or contests more territory than any other, IS has repeatedly demonstrated its ability to carry out devastating attacks in urban areas.



CONTROVERSIAL SEDITION LAW

Myanmar arrests government critic

Myanmar police have arrested a prominent government critic on suspicion of violating sedition laws, an offence that carries a maximum penalty of life imprisonment.

Ngar Min Swe was arrested at his home late on Thursday, news website Eleven Media, which belongs to one of Myanmar's largest media groups, said. Reuters was unable to determine what prompted his arrest or his current whereabouts.

A police officer at the station in Hlaing township, where

the arrest took place, said Ngar Min Swe was taken to Yangon's

Western District court on Friday. The officer declined to be identified and did not elaborate on what triggered the detention or on the identity of the complainant. Human rights activists say such arrests show room for free expression is shrinking under Nobel Laureate Aung San

Suu Kyi's government and the gains made in securing such freedoms since the end of military rule in 2011 risk being reversed. Myanmar has detained at least 38 journalists since Suu

Kyi came to power in 2016, according to Athan, a freedom of expression activist organisation. Ngar Min Swe has been arrested under section 124A of the penal code, which says anyone who incites disaffection towards government "shall be punished with life imprisonment", according to the Facebook post.

Saudi woman faces jail for hugging pop star

A woman may face charges under a new harassment law in Saudi Arabia after storming a stage to hug a pop star, authorities and local media said yesterday.

The woman could face two years in prison and a fine of up to 100,000 Saudi riyals (\$27,000, 23,000 euros), attorney Abdulkarim al-Qadi told the Okaz news site.

The woman, who has not been identified, was dressed in a full-length abaya and niqab face cover when she jumped on stage to hug Iraqi singer Majid al-Muhandis, whose love songs are hugely popular in the Gulf. A police statement said the woman had been arrested on
