ASSAULT ON TEACHERS AT QUOTA DEMO

Teachers, students stage protests

Teachers and students of different public universities yesterday staged demonstrations on their campuses protesting Sunday's assault on teachers and students of Dhaka University over the quota reform movement.

At a human chain at Dhaka University, protesters demanded resignation of the proctor over his "failure" to provide security to teachers and students.

Under the banner of "Students against Repression", around 100 students of different departments formed the human chain at the foot of Raju Memorial Sculpture.

Speaking at the programme, students highlighted the recent incidents of violence on the campus over the quota reform movement and held DU Proctor AKM Golam Rabbani responsible for the recent "spate of attacks"

on students. "Several incidents have taken place out a legitimate protest. after this proctor took office. But he

failed to act on any of those incidents," said Zakaria Hossain, an organiser of the platform.

"How many incidents will have to happen? What needs to occur for you to admit your failure?"

"Did these goons [Chhatra League men] take over the role of the proctorial team? If so, then give them the responsibility of carrying out proctorial duties and you join the organisation [Chhatra League]," Zakaria said addressing the proctor.

Another speaker, Ety Jahan, held pro-Awami League student front Chhatra League responsible for assaulting teachers near the Central Shaheed Minar and condemned the proctor's inaction over the incident.

Expressing solidarity with the protestors, Mujibor Rhaman, associate professor of the Institute of Education and Research of DU, said the students were being attacked when they carried

CU teacher leaves campus upon 'BCL activists' threat'

An assistant professor of Chittagong University has said he left the campus after getting continuous threat from Bangladesh Chhatra League activists over his Facebook remarks on quota reform.

Talking to this correspondent, Assistant Prof Maidul Islam of sociology department said he along with his wife went to a safer place yesterday morning as he felt insecure on the campus.

The teacher added that he had protested the attacks on quota reformists as it was his political right.

"Considering the inhumane attacks on quota reformists], I wrote some lines on Facebook. It is my decision what I will write on Facebook and they [BCL men] have no right to obstruct me," he added.

Prof SM Monirul Hasan, chairper-

son of sociology department, said, "A group of BCL men came to my office on Sunday with a complaint against my colleague Maidul.

"They demanded necessary steps against him, claiming that he is supporting the quota reform movement and instigating students and teachers and spreading hate speeches against the government on Facebook.

"The BCL men threatened that Maidul will have to face dire consequences, if we do not take any steps against him," Monirul said.

According to witnesses, around 25-30 activists of CU BCL, led by its former vice-president Mansur Alam, went to the chairperson's room on Sunday around 12:30pm and started shouting.

When Prof Monirul assured them of looking into the matter, the angry BCL men left the room, said an office assistant of the department.

Around 9:45pm, Omar Faruk, officer-in-charge of Motijheel Police Station, said, "The family members didn't come to this police station. You better contact Paltan Police Station. Fakirapool comes under both the police stations."

Paltan Police Station's OC Mahmudul Haque said he was not aware of the incident.

Contacted, Devdas Bhattacharya, additional commissioner of Dhaka Metropolitan Police, said they didn't detain Tarek. "But we are looking for him," he said, without going into details.

According to police, some 18 people, including several quota reform leaders, have been arrested so far and they are accused in different cases filed in April in connection with the



non-submission involving around \$1 billion, and a number of cases relate to one company -- Beximco Fashions.

This major foreign exchange violation has made the BB worried, and it served five warning notices on Janata Bank from January last year to April this year. But the state-run bank did not pay

heed to the central bank's warnings and continued to give LC facilities to Beximco Fashions, violating the rules. Janata Bank even showed callousness in replying to the BB's warning

notices. For instance, it replied to the first notice 61 days after it was served, and took 56 days to respond to the second warning. In its every reply, the state-run

lender said the violation had occurred because their officers were not well-trained about the foreign exchange rules. On January 25, the central bank

served a show-cause notice on Janata state-run bank's authorised dealer licence and impose a penalty of Tk 10

Later, Janata Bank was penalised Tk 10 lakh on May 28 as its reply could not satisfy the central bank. "The bank has been fined Tk 10

lakh for not following the central bank's instructions and for repetition of the same irregularities," the BB said in its letter to the state-run bank on May 28.

Beximco Fashions, an exportoriented garment company of Beximco Group, opened LCs for imports but could not submit bills of entry to the bank against the imported goods, according to BB findings.

Janata Bank continued to make advance payments against the LCs of the firm despite having overdue bills of entry which is strictly prohibited as per the BB's foreign exchange guidelines.

According to the guidelines, banks will have to ensure that importers don't have bills of entry pending for submission beyond the stipulated period of four months against any advance remittance for imports. If an importer fails to submit its certified invoice of imported goods, it will not be allowed to open any new LCs through banks.

Contacted, Janata Bank Managing Director Md Abdus Salam Azad said Beximco Group made delays in sub-Bank, threatening to cancel the mitting the bills of entry to the bank against its imported goods. The BB has extended time till

> September 30 for the Group to match the pending invoice, he said. According to the BB findings, the overdue bills of Beximco Group with

Janata Bank involved about \$3.5 million as of April. Of the amount, Beximco Fashions accounted for a significant portion. Moreover, the bank opened new Bank's record," it said in an email to

LCs of \$3.6 million against Beximco

Fashions from January last year to April this year though the firm had overdue bills of entry.

An internal audit by the BB raised objection last year against the new LC opening of Beximco Fashions in breach of the rules and asked the department concerned to look into it, according to a source at the BB.

On April 15, Janata Bank sought time extension from the BB to adjust the overdue bills of Beximco Group.

Later, the state-run bank applied to the BB on June 10 for waiving the Tk 10 lakh fine as financial penalty is a serious discredit for its management and board.

Janata Bank's application was

placed at the BB board's meeting on Sunday, and the board decided to waive the penalty. Asked, BB Deputy Governor Abu

Hena Mohd Razee Hassan said the board made the decision on condition that the state-run bank would settle the overdue bills of entry. Contacted, Beximco Group Policy Dialogue, a think-tank,

claimed that it had submitted documents to Janata Bank for each consignment. "The number of part shipments and cotton.

made against individual LCs and the bill of entry against each consignment has to be matched with each LC. Since this matching was not done, there was a discrepancy between Bangladesh Bank records and Janata this newspaper.

Talking to this correspondent, a top executive of a private bank said it is the bank's responsibility to match the bill of entry against each consignment but the client also has an important role to play in this regard.

M Mahfuzur Rahman, a former executive director of the BB and deputy head of the Bangladesh Financial Intelligence Unit (BFIU), said overdue bills of entry is a serious issue, and trade-based money laundering is taking place through imports. Analysts have long been demand-

ing probes into whether money laundering is going on in the name of imports, said Khondkar Ibrahim Khaled, an ex-BB deputy governor. As the central bank has finally detected suspicious imports through

Janata Bank, it should go for a detailed investigation in collaboration with the BFIU and the customs department to unearth this type of cases, he said. In January this year, the Centre for

advised the government to investigate whether capital flight has taken place through imports of sugar, edible oil "Despite global price stability of
