

Broken bridges woe for commuters

People of different areas in Chittagong, Magura, Lalmonirhat and Netrakona are suffering as a few bridges are lying broken or without approach roads.

A 50-year-old concrete bridge on Hangarkul canal in Satkania upazila of Chittagong remains in an awful condition for over a year, reports our correspondent Arun Bikash Dey.

Locals said the 40-foot-long concrete bridge became vulnerable due to lack of renovation for long and it developed a large hole in the middle a year ago, making it difficult for vehicles and pedestrians to pass.

Hundreds of residents of nearby Hangarkul, Patiyakhali and Dhemsha villages use the bridge that connects the upazila headquarters and a few local markets.

Besides, students of two primary schools, a high school and a girls' madrasa use the bridge to go to and from the institutions.

"My friend fell off a rickshaw while we were crossing the bridge. However, she was lucky enough not to fall into the canal through the big hole," said Tasfia Binte Rashid, a student of Daimar Khil Mahila Dakhil Madrasa.

The bridge has turned too risky for users, especially during the night, Md Mostak, an advocate's clerk, said, adding that they submitted an application to the local union parishad (UP) chairman in this regard over six been taken yet.

Dakkhin Dhemsha UP Chairman Ridwan Uddin said, "After receiving the application, I informed Satkania upazila nirbahi officer (UNO) and the local lawmaker of the matter and asked for fund to reconstruct the bridge."

reports: People of 25 villages including Bannadul, Parnanduali, Barashia, Belnagar, Ramnagar, Tagorbari and Kushundia in Magura Sadar upazila are badly suffering as the newly constructed bridge over the Nabaganga river is lying unused due to not having approach roads on both sides.

Magura Local Government Engineering Department (LGED) built the 570-foot-long bridge over the river about seven months ago at a cost of Tk

10.67 crore.

Islam, owner of Islam Traders of Jessore, was awarded the work order.

The construction of the bridge was completed in December last year, but the approach roads are yet to be built.

Six motorcyclists met accidents while months ago, but no initiative has crossing the bridge recently, said trader Sumon Sarkar.

Contractor Tarikul Islam said construction of the approach roads was hampered due to heavy rain but it will be completed soon.

There are some 10 educational institutions including primary and high schools and a college on both sides of the river and the students have to cross the river by boat for attending their classes, said Hafizur Rahman Ansari, headmaster of Borodal Government Primary School.

Local farmers and fishermen said they are facing problem to carry their produces to market due to poor communication system.

A teenage girl was gangraped allegedly by a group of youths in Madhabpur upazila of Habiganj on Sunday night.

'Man killed daughter to trap own brother'

Investigation into the case for the killing of Class II student Naima Akhter in Bahubol upazila of Habiganj last year has finally revealed that her father Farid Mia, not main accused Shukur Mia, committed the gruesome murder, police said.

Farid on Saturday gave a statement under Section 164 before the Court of Habiganj Additional Chief Judicial Magistrate Shahinur Akhter, confessing to the murder of his daughter Naima, Senior Assistant Police Superintendent (Bahubal-Nabiganj Circle) Parvez Alam Chowdhury told a press briefing on Monday evening. Earlier, police arrested Farid on Friday.

Against the backdrop of a land dispute with his elder brother Shukur Mia, 52, Farid Mia, 40, of Swaiya village in Bahubol, planned to kill his own daughter to trap Shukur, said Bahubal Model Police Station OC Md Masuk Ali.

"On August 9, 2017, Farid with the help of neighbour Sajon Mia, 20, strangled Naima.

"Farid filed a murder case against Shukur and the latter's six sons on September 6. After a 10-month-long investigation, the fact came out," the OC said.

Rural women's savings at odds

Many banks reluctant to receive coins defying Bangladesh Bank order EAM ASADUZZAMAN, Nilphamari

Sharmin Akhtar, 26, a housewife from a lower middle class family in Sadar upazila, who prefers to deposit coins in earthen banks, a traditional method of storing surplus income or savings, desired to buy new dresses for her children during Eid.

She, however, could not fulfil her wish during the Eid shopping this year as shop owners refused to receive the payment when she tried to make the payment with coins, saying banks don't receive coins for want of adequate storage facilities.

Many women in rural area still prefer to save coins as paper notes become damp, discoloured and sometimes face fungal attack when kept in earthen banks

Like Sharmin, many rural women in the district had to face such unwanted situation during the Eid shopping as shopkeepers were not interested to sell products to them in exchange of coins.

Akhtar Siddiquee Pappu, owner of a confectionary in Saidpur municipal area, said, "A good number customers in rural areas are women and children and they buy bread, biscuits, or chocolates with coins."

"I went to the local branch of National Bank Limited to deposit huge amount of stored coins recently. But the bank manager received a small portion of the coins and returned the major portion saying that there is not enough room in

his bank to keep those," he said.

Nilphamari Chamber of Commerce and Industries (NCCI) Vice-president Md Farhanul Huque said, "Coins amounting to crores of taka remain as idle money in the hands of individuals, especially women, creating a deadlock in rural savings.

Bangladesh Bank (BB) through a circular, issued on March 29, 2017, directed all commercial banks to pay and receive coins otherwise they

would face stern action, Farhanul said, adding that the banks receive only a small amount of the coins.

Ariful Islam, manager of Agrani Bank's local branch, said, "We tried to follow Bangladesh Bank's order which directed us to receive coins amounting up to Tk 30,000. But we've stopped receiving coins as we can't transfer those to BB which has a shortage of space."
