#### 'Pro-BNP' JU teachers to skip work today

Protesting BCL attacks on teachers, students JU CORRESPONDENT

A section of Jahangirnagar University teachers will go for a daylong work stoppage today, protesting the spate of BCL attacks on teachers and students involved in quota reform movement.

"Jatiyatabadi Shikkhak Forum", which claims to be pro-BNP, also demanded reformation of the existing quota in civil service.

Pre-scheduled examinations will be beyond the purview of their strike, said a press release of the forum yesterday.

The teachers also criticized JU Teachers' Association for keeping mum about such oppression on teachers and students. Such silence contradicts its constitution and tradition, they said.

# loot 3 shops

A group of armed robbers yesterday killed two night guards and looted valuables worth Tk 27 lakh from three shops at a market in Bandar upazila in Narayanganj, police said.

The victims Raihan Miah, 65, and Motaleb Hossain, 55, were killed in Lakshmankhola Madrasa market area. Police recovered the bodies and sent them to Narayanganj General Hospital for autopsy.

Shahin Mondal, officer-incharge (OC) of Bandar Police Station, said the two were killed for

resisting the robbery.

They were attacked with locally made weapons. One of the victims died on the spot and the other was injured critically, the OC added. The latter succumbed to his injuries at the Dhaka Medical College Hospital (DMCH).

The robbers broke into Bismillah Battery Store, Satata Mela Battery, and Satata Battery Servicing Centre and looted cash and valuables worth Tk 27 lakh, the OC said quoting the owners.

No case was lodged till filing of this report yesterday. However, police are trying to arrest the robbers.

## Robbers kill night guards, DU running too many evening programmes

Students, teachers fear of falling education quality

UNB, Dhaka

What began in 2001 as an evening course under Dhaka University's (DU) business studies faculty for developing skills of professionals, has witnessed an exponential growth over the past 17 years.

DU now offers dozens of evening postgraduate, certificate, diploma and other professional courses, at times jeopardising its core and regular academic activities. Currently, as many as 40

departments and institutions of the university are running such evening courses, while more are in the offing.

Such phenomenal growth in mostly short-term evening courses is now testing the capacity of the university, as DU is running short of additional human resources to run so many evening programmes.

Noting that a large number of evening courses is hampering regular academic activities of DU,

many studies and teachers fear that unless the situation is brought under control, the university's regular academic curriculum will be compromised.

The DU authorities first approved evening master's courses of business faculty in October 2001, when Vice Chancellor Prof Dr AK Azad Chowdhury was at the helm of the affairs.

The logic employed to rationalise the move was to spread

who dragged her to an isolated place and gang-raped her, said the DC.

The victim then returned home and told her husband about the incident.

Her husband filed a case in the morning with Karnaphuli Police Station accusing the four youths.

Police conducted drives and arrested three out of the four accused, the DC said, adding, another accused Nurul Amin, 27, is absconding.

Meanwhile, the victim has been sent to One Stop Crisis Centre at Chittagong Medical College Hospital.

## BNP conspiring to foil city election

Says AL mayor candidate

Awami League's mayor candidate yesterday alleged that BNP was conspiring to foil the city election.

According to a complaint filed by BNP candidate Mosaddek Hossain Bulbul with the returning officer, at least three AL lawmakers -- Ayen Uddin, Abdul Wadud Dara and

Shafiqul Islam Shimul -- violated the electoral laws by taking part in Liton's campaign on Thursday.

the employees of Rajshahi City Corporation to vote for AL, armed miscreants were threatening BNP men and damaging election offices.

The complaint mentions that AL workers were pressing

The complaint also says that none of BNP's complaints made with the returning officer were attended to.

AL mayor candidate AHM Khairuzzaman Liton, while campaigning in Beldarpara area, told reporters that BNP started making complaints intentionally from the very beginning of the campaign.

"They failed to run the city corporation in the last five years and they are not being able to face the people during campaign. Now, they want to foil the election and are trying to find ways to withdraw from it," Liton said.

Meanwhile, independent candidate Murad Morshed published his election manifesto at Moonlight Garden Hall, making a 16-point promise.

Supported by Gana Samhati Andolan and Rajshahi Ganamancha, Murad said that if elected, he would turn the city corporation's focus on improving the citizen's status

and ensure providing services without harassment. His other promises include stopping toll collection from vehicles and footpaths, preserving nature and environment, developing the education, recreation and cultural sectors.

#### MC COLLEGE HOSTEL ARSON Investigation took five years. How long to start the trial?

After the arson attack at the lone hostel of MC College, different units of police investigated and reinvestigated the case for almost five years. But none of them could specify

who might be behind the torching.

Finally, the court handed the case over to a magistrate to run a judicial investigation. After five months, the one-person committee filed the investigation report late last year, implicating 29 student leaders and activists -- 10 from Bangladesh Chhatra League (BCL), Shwechchhasebak League (SL) and Jubo League (JL) and 19 from Islami Chhatra Shibir. Accordingly, police also filed a charge sheet against the 29 accused. But the case is yet to go to trial.

On the evening of July 8, 2012, a clash broke out between BCL and Shibir activists. In the middle of the clash, a fire was seen engulfing three blocks of the hostel. The blaze left 42 rooms gutted and 70 others partially burnt. The one-storey tin-roof hostel has 252 rooms in six blocks and

houses more than 1,000 students. Five days after the arson, on July 13, then hostel supervisor Bashir Ahmed filed an arson case with Shahporan Police Station, accusing a group of unnamed miscreants. Later, police filed two more cases -- for the arson and the clash.

Initially, the police station conducted an investigation but found no one behind the arson and their inquiries remained inconclusive. The court then assigned the Criminal Investigation Department. On October 31, 2013, CID filed a report citing that three Shibir activists were involved in the torching. However, the court rejected it,

and ordered reinvestigation.

Later, on August 9, 2015, CID submitted a revised investigation report, which was also turned down by the court as it did not add any new information or any other names as accused. The court then gave the task to the Police Bureau of Investigation, but PBI too failed to find new details and the case apparently hit a snag. The PBI investigators could

not turn in a report up until May 2017. Eventually, the court settled on a judicial investigation and assigned Additional Chief Metropolitan Magistrate Umme Sharaban

Tahura on May 31 last year. She filed the probe report on November 15 last year, accusing the 29 activists. After hearing the case next day, the court ordered

arrest of all 29. The main accused were Debangshu Das Mithu, general secretary of Sylhet city unit of Shwechchhasebak League and then president of BCL Sylhet Government College unit; Pankaj Purkayastha, former president of Sylhet district unit of BCL; Jahangir Alam, former organising secretary of the same unit; and Abu Sarkar, former

president of Sramik League. Among the accused, 10 BCL, JL and SL leaders and activists, including the above mentioned four, got bail after surrendering on January 15 this year. The rest 19 Shibir activists remained absconding.

Talking to The Daily Star, Mahfuzur Rahman, additional public prosecutor of the Sylhet Metropolitan Magistrate's Court, said police filed the charge sheet against the 29 men, but the trial was getting delayed due to the fugitives.

He, however, said the case can go to trial SEE PAGE 4 COL 1
