Fire guts stage for BAU anniversary celebrations

The stage built for the celebration of 57th founding anniversary of Bangladesh Agricultural University (BAU) in Mymensingh caught fire last night.

President Abdul Hamid is scheduled to attend the programme today as the chief guest.

Seven fire engines brought the fire under control around 12:15am, said Shahidur Rahman, deputy director (in charge) of Mymensingh Fire Service and Civil Defence. The fire had broken out around 11:15pm.

The cause of the fire could not be known immediately.

The president is also supposed to inaugurate "Haor and Chor Development Institute" at the university following today's programme.

BAU Proctor Atikur Rahman Khokon said they had handed over the charge of

the stage to Special Security Force members in the evening.

He added that they would try their best to hold the programme if the president

agreed to join.

trade, he said none of them would be spared. "There are a lot of questions regarding godfathers... there is no scope for sparing anyone."

all interested in this matter." In Kushtia, Shamsuddin alias Sham, 38, an accused in eight cases, was killed in a "gunfight" with police in

Bheramara upazila, reports our

Kushtia correspondent. The incident occurred around 3:30am when a police team raided Bankapul area after a tip-off that a group of drug peddlers were having a meeting there, said Aminul Islam, officer-in-charge of Bheramara Police

Station. Police also recovered 500 pieces of yaba, a gun and two bullets from the spot, he added.

Earlier, Sham was arrested twice in drug-related cases filed with Bheramara Police Station but got released on bail. He was last arrested on July 12, 2017, said the OC.

In Chapainawabganj, Khairul Islam, 42, an accused in eleven cases including seven on narcotics charges, was killed in a "gunfight" with Rab in Sadar upazila.

Abu Khayer, deputy commander of Chapainawabganj Camp of Rab-5, said an elite force team raided a mango orchard in Mollan village around 1:30am following information that a gang was engaged in drug peddling there, reports our correspondent from

the district. After the gunfight, Khairul was found with bullet injuries but others managed to flee. He was taken to

Chapainawabganj Sadar Hospital where doctors declared him dead. The Rab official also said they recov-

ered one pistol, one magazine, four bullets and 117 bottles of Phensedyl from the spot.

In Dinajpur, Md Abdur Rahim, 45, an alleged drug peddler, was killed in a "gunfight" with police in Parbatipur upazila early today, reports our district correspondent.

Two narcotics gangs were meeting in Bannirghat village and they opened fire when police raided the area around 3:00am, said Habibiul Haq Prodhan, the OC of Parbatipur Police

Station. Later, police found bullet-hit Rahim and took him to Parbatipur Upazila

Health Complex where he died of injuries, the OC said, adding they recovered 100 yaba pills, 50 bottles of Phensedyl and a gun from the spot.

In Cox's Bazar, Md Ismail, 42, an alleged drug dealer, was killed in a "gunfight" between two groups of drug dealers in Chakaria around 2:30am, reports our correspondent in the dis-

On information that two gangs of drug peddlers were locked in a gunfight, a police team raided the area. But the feuding groups fled sensing presence of law enforcers, said Bakhtian Uddin Chowdhury, the OC of Chakaria Police Station.

Police later found the body of Ismail and also recovered a local pistol, two bullets and 465 yaba tablets, he added.

In Lalmonirhat, Rabiul Islam, 40, another alleged drug peddler, was injured in police firing at Singimari village of Hatibandha upazila, reports our district correspondent.

Omar Farooque, the OC of Hatibandha Police Station, said after a tip-off that a group of people are involved in drug smuggling, police raided the village and opened fire.

Rabiul was found lying on the ground with injuries while the other smugglers managed to flee. He was later admitted to the Upazila Health Complex and police also recovered 25kg of marijuana from the spot.

Iran overturns ban on religious minority councillor

Iranian authorities ruled Saturday that a member of the minority Zoroastrian religion had been wrongly suspended from his post on a city council.

Sepanta Niknam, a member of Iran's ancient Zoroastrian religion, was the only non-Muslim elected to the council in the central city of Yazd in May 2017, but he was suspended later in the year following a complaint by

one of his fellow councillors. It had followed a ruling by the ultra-conservative head of Iran's Guardian Council, which oversees elections, barring religious minorities from standing in municipal polls.

Because the Guardian Council has power only over national elections, the ruling was rejected by parliament, but that did not prevent Niknam's suspension.

On Saturday, Majid Ansari, a member of the Expediency Council which is charged with resolving disputes between Iran's multiple centres of authority, said they had finally ruled in favour of Niknam.

"Today, the Expediency Council ruled that the 1996 law on religious minorities is applicable and they can participate in council elections in their town," Ansari told the reformist ILNA news agency.

He added that Niknam was now free to retake his post on Yazd city council.

Iran officially recognises "Iranian Zoroastrians, Jews and Christians" as religious minorities.

The national parliament has several religious minority members, including three Christians, a Zoroastrian and a Jew among its 290 deputies.

Rebels reach north Syria after south evacuations

Hundreds of rebels and their families evacuated from southern Syria after a deal was struck with the regime arrived yesterday in the country's northwest, an AFP correspondent said.

The evacuations from Quneitra

province, which borders the Israeliannexed Golan Heights, came after a Russia-brokered agreement was reached earlier this week to see rebels hand over the territory to the Syrian regime. Around 50 buses transporting

fighters and their families reached the Morek transit route in the north of Hama province, which links regime and rebel-held territories, an AFP correspondent at the scene said.

The Syrian Observatory for Human Rights monitor said the first convoy to reach Morek transported around 2,800 people.

They were to be transferred to other buses run by local NGOs, before travelling further north to temporary camps in rebel-held areas in Idlib and Aleppo provinces, the Britain-based monitor said.

"More than half of the evacuees are women and children," said Observatory head Rami Abdel Rahman.

"A second wave of departures is expected from Quneitra," he added.

Near the parked buses in Morek, a woman and five children waited by a cluster of small suitcases, the eldest among them carrying bottles of water and a blanket. Men with light weapons slung on

their backs shared a bite to eat and some water as they stood around waiting. Several wearing scarves wrapped around their faces.

The evacuations follow a deadly regime offensive on Quneitra, a thin, crescent-shaped province that lies along the buffer zone with the Israeloccupied Golan to the west.

Thousands protest Australia's refugee detention policy

Thousands of people marched across major Australian cities yesterday calling for an end to Canberra's offshore detention of asylum-seekers.

The government sends anyone who tries to enter the country by sea to camps on Papua New Guinea's Manus Island or on Nauru in the Pacific for processing. Protestors took to the streets to

mark the fifth anniversary of the policy's reintroduction, when in 2013 Canberra significantly toughened its stance, signing deals with the Pacific nations and declaring anyone arriving by boat had "no chance" of being settled in Australia.

"The policy that was introduced in 2013, to expel people -- the 'Fortress Australia' policy that they (the government) put in place -- that has to go," rally organiser Ian Rintoul from the Refugee Action Coalition told Sydney protestors.

"So we fight to close the detention centres on Manus and Nauru, but we fight in that process to bring them here."

Hundreds marched through Sydney shouting, "Free, free the refugees", with banners stating, "Five years too long, evacuate Manus and Nauru". Joint rallies were held in Melbourne, Adelaide, Brisbane, Canberra and Perth.

"Around 1.42 lakh tonnes of coal was not there," said one of the visiting officials.

BCMCL officials said around 2.50 lakh tonnes of coal were on their yard until March 30 and the mine produced over 1.85 lakh tonnes between then and June 29. The plant burnt around 2.50 lakh tonnes of coal between April 1 and July 10. There was a deficit of

1.42 lakh tonnes. Meanwhile, coal production has been suspended since June 29 to relocate equipment to a new coalface. Production is expected to resume at the end of next month, said a general manager of the mine.

The acute shortage could have been averted if the officials of BCMCL, the only supplier of coal to the plant, informed the plant authorities about eral manager were also suspended.

Power generation would continue at the plant if PDB, which operates the plant, gets enough coal.

"Hamas works relentlessly to destroy Israeli lives (& Gazans suffer as a result of Hamas)," he tweeted, while offering condolences to the soldier's family.
