Candidates all for idea of city government

Four mayor candidates at a dialogue in Rajshahi yesterday gave a unanimous opinion for introducing city government, an idea to bring all civic service providers under one authority and ensure coordinated development activities.

They also said there is a need for agreement of political parties on local issues, while the privileged section of the society has to come forward to help those lagging behind.

The candidates pointed out that the city needs a sufficient number of public toilets, conservation of its ponds and planned infrastructural development.

Awami League's mayor aspirant AHM Khairuzzaman Liton, BNP's Mosaddek Hossain Bulbul, independent candidate Murad Morshed and Jatiya Party's Habibur Rahman spoke at the dialogue. Of the five mayoral candidates, only Islami Andolon Bangladesh's Shafikul Islam skipped the discussion.

Rajshahi Divisional Journalists' Association in Dhaka organised the dialogue on "The Rajshahi we want", in the auditorium of the Rajshahi Chamber of Commerce and Industries (RCCI). The association's president Khairuzzaman Kamal was in the chair, and its vice president Anwarul Haque moderated the dialogue.

Singer Andrew Kishore, cricketer Khaled Masud Pilot, actors Abdul Aziz, Arman Parvez Murad, eminent local people Ahmed Shafiuddin, Kolpona Roy and Zamat Khan also spoke, among others.

The speakers said they want a long-term development plan regarding construction of infrastructure, tree plantation, controlled use of underground water, beautification of the Padma river bank, and protection of the city ponds.

AL candidate's electoral camp set on fire

Mayoral candidates file complaints against each other

Miscreants set fire to AL candidate Badar Uddin Ahmed Kamran's electoral camp in Sylhet city's Tultikor area late at night on Saturday. Akther Hossain, officer-in-charge of Shahporan Police

Station, said that the fire broke out around 3:00am but no one can identify the culprits.

Filing of a case against unidentified miscreants was under prosess till last night, the OC said. While visiting the camp yesterday morning, Kamran

urged police to find the people behind the arson who are trying to instigate violence before the election. While AL and BNP candidates are being cooperated by differ-

ent groups of peoples, CPB-BSD candidate Abu Jafor is visiting mostly disadvantaged groups and using the classic method of communism by asking for "One vote, one note". He ran his campaign at Subidbazar, Mirer Moydan,

Kalapara, Hajipara and Londoni Road yesterday and asked voters to cast vote for "ladder" and support with a note (cash). Abu Jafor also said that the city demands an election

without any influence of power or black money. Meanwhile, AL candidate Kamran and BNP candidate Ariful Haque Chowdhury are continuing their campaigns

AL, BNP, IAB candidates STAR REPORT served show-cause notices

The Election Commission has served show cause notices on Awami League mayoral candidate Serniabat Sadiq Abdullah, BNP-led 20-party alliance's Mojibor Rahman Sarwar and Islami Andolon Bangladesh's (IAB) Obaydur Rahaman Mahabub for violating electoral code of conduct.

Mujibur Rahman, returning officer of Barisal City Corporation polls, said a notice was served on AL hopeful Serniabat on Saturday night for using government premises for electioneering. The same night, notices were also issued against Dr

Bhaskar Saha, principal of Sher-e- Bangla Medical College

(SBMC), and Dr Baqir Hossain, director of Barisal Sher-e-Bangla Medical College Hospital, for participating in an election campaign of Serniabat. The AL candidate used the SMBC auditorium as a venue

for campaigning, said the returning officer. Also as government employees, the principal and director cannot take part in any sort of campaign, he added.

Dr Bhaskar Saha, principal of SBMC, said, "I was not aware of it. I will apologise to the Election Commission."

A show cause notice was served on IAB's Obaydur yesterday morning for using religion as a tool for campaigning, said Md Helaluddin, assistant returning officer. "Seeking vote using religion is a violation of electoral code of conduct," he added.

During his election campaign, IAB's candidate said casting vote for "hatpakha" (hand-fan), IAB's electoral

ROAD ACCIDENTS

10 killed, 29 hurt in a day

Three of a family among the deceased

Ten people were killed and around 29 others injured in road accidents in three districts yesterday, according to reports from our correspondents.

In Rajshahi, a microbus collided head-on with a goodsladen truck on Rajshahi-Chapainawabganj highway in Godagari upazila, killing three members of a family, said police. The deceased -- Khadizatul Kubra, wife of Narcotics

Control Department Assistant Director in Chapainawabganj Alamgir Hossain, her daughter Raisa and son whose name could not be known immediately -- were in the microbus.

Alamgir, his domestic help and the microbus driver were injured.

In another accident, a bus fell into a roadside ditch in the

upazila's Rajabari area, injuring about 20 people.

In yet another incident in the district, two trucks collided headon and rammed an auto-rickshaw, injuring four persons in Kadipur.

In Rajabari, a truck ran over two motorcyclists -- Emdad Hossain, 50, and Khasbu Tanjim, 14, -- killing them instantly. Meanwhile, a truck crashed into a roadside shop, killing

one Jashim Uddin, in Railgate area. Two others -- Babu and Selim -- were also injured, said police. In Rangpur, three passengers of a battery-run auto-rickshaw

were killed as a bus hit it on Dinajpur-Rangpur highway in Hajirhat area of Sadar upazila. The identities of the deceased could not be known imme-

diately. The victims were going to Paglapir area in the upazila. Police recovered the bodies and sent those to Rangpur Medical College Hospital morgue for autopsies.

BAU celebrates anniversary at alternative venue

Three committees formed to probe fire

Bangladesh Agricultural University (BAU) held its 57th anniversary celebrations at an alternative venue yesterday after a fire gutted the stage of the planned event. Initially, the stage was set up at Bangabandhu Chattar on

the campus but a fire broke out the night before the programme on Saturday. The blaze left all the tables, chairs and equipment burned. "We prepared the venue for 5,000 guests including 4,300

alumni, but the fire burnt the entire stage," said Proctor Atikur Rahman Khokon. The university authorities shifted the programme to

Shilpacharya Zainul Abedin Auditorium and a pole tent

built on the campus. Alumni and guests appreciated the effort. "We are pleased that the university authorities went on to hold today's programme," said Dr Md Matlebur Rahman, a grad-

uate of the mid-1980s. President Md Abdul Hamid also attended the celebrations around noon yesterday.

Meanwhile, three committees were formed to investigate the fire. Dr MAM Yahia Khandaker, a professor of animal husbandry, heads a five-member team formed by the university, which was asked to submit the report within seven working days, said BAU registrar (in-charge) Md Saiful Islam. The Mymensingh district administration and police also formed two separate probe committees.

After the fire broke out around 11:15pm on Saturday, and it was doused one hour later, at 1:15am yesterday. Fire offiicals said it might have originated from an electric short circuit.

'DEFAMING PM ON FACEBOOK'

CU forms probe committee against two teachers

The Chittagong University (CU) authorities have formed a three-member committee to probe into allegations against two of its teachers over making derogatory remarks about Prime Minister Sheikh Hasina on Facebook.

The committee was formed on Thursday. The teachers are Khandakar Ali Ar Raji, an assistant professor of communication and journalism department, and Maidu Islam, an assistant professor of sociology department. Acting registrar of the university KM Nur Ahmed in a

letter asked the committee, headed by law faculty Dean Prof ABM Abu Noman, to submit the report within seven working days. Deputy Registrar Md Hasan Mia and Assistant Proctor Mizanur Rahman are member secretary and member of the committee respectively, said Nur Ahmed. On July 17, a group of BCL men submitted a memoran-

dum to the university's vice-chancellor against the two teachers accusing that they had posted defamatory remarks against the PM and urged the students to create anarchy on the campus. Asked about the allegations, Khandakar Ali Ar Raji told

The Daily Star, "I have never said anything about the prime

minister. Why and how these allegations have been raised, I don't understand myself." The BCL men have also announced the teachers "unwelcome" on the campus, forcing them to stay away from the

Factory worker 'gang-raped'

A female factory worker was allegedly gang-raped by four youths in Fatullah area of Narayanganj on Saturday night, police said.

The girl filed a case in this connection with Fatullah Police Station yesterday, accusing four persons. According to the case

statement, the 19-year-old hosiery factory worker went to Nabiganj Kheya Ghat area after finishing work, said Mojibur Rahman, inspector (operations) of the police station. There she met four of

her friends -- Arif, Moktadir, Milon and Hridoy. They invited her to join a birthday party at another friend's house. The youths took her to a house on Allama Iqbal

road. The men raped her in the empty house, Mojibur added, quoting the girl. She was sent to

Narayanganj General Hospital for a medical test, the inspector also said.

Nobody was arrested till filing of this report yesterday.

hanging from the ceiling of the room by his two other roommates. They rescued and admitted him to a hospital. After the incident, police arrested Gangmei Niraj, while Ateef's father Abdul Malek filed a murder case against eight persons including Winson, Niraj and Jyostana on July 18

with Akbar Shah Police Station. PBI took the charge of the case later on July 20, 2017 and the IO later arrested Winson for interrogation. As Winson

pretended to have lost memory of the incident, a medical board was formed to check his mental condition, which certified him as mentally healthy. After the incident, PBI sent the blood-stained bed-sheet,

blood, knife and its handle to CID's forensic lab for DNA profiling, to confirm the killer's identity.
