An unpopular choice Passengers dwindling on

Khulna-Kolkata train service

After eight months since its launch, the Khulna-Kolkata passenger train service has not caught on as a route of choice among India-bound passengers.

Bandhan Express, with 456 seats, was launched on

November 16, 2017, the inaugural run to Kolkata carrying 253 passengers. Since then, the highest number of passengers it has had on a single journey so far was 184 the next day, November 17. The number has been on the decline since. Nowadays, only some 130 passengers on an average

travel by the eight-coach train, whereas some 5,000 Bangladeshi people use the Benapole border to enter India on a daily basis. Passengers attribute poor show of the Bandhan

Express service, long stops at Indian border station

Chitpur for immigration and customs formalities, once-

a-week only (Thursday) schedule, high ticket price, and hassles in ticket purchase both in Khulna and Kolkata to the situation. Mahmudul Hassan, a businessman from Khulna who frequently travels to India, said the train runs only on

Thursdays. So, those who have emergency have to take a bus or flight.

Moreover, train tickets are only available for spot purchase, that too only at Khulna Railway Station. There is no online purchase option which is another drawback, he added.

"Khulna is a small city. Logically, it will not have many passengers for India. And there is no railway stop between Khulna and Chitpur," said Riadul Hassan, a government employee and resident of Jessore.

With a promise to reduce holding tax and cooperate with the ongoing quota reform movement, BNP-backed mayoral candidate Mosaddek Hossain Bulbul yesterday announced his election manifesto.

He announced the manifesto at a community centre in Saheb Bazar area.

The pledge to reduce holding tax is on top of Bulbul's 18-

point manifesto while it is at the bottom of Awami League

candidate AHM Khairuzzaman Liton's 16-point electoral promises placed on July 10. Bulbul said though the holding tax was raised during his

by her father in Tongi of Gazipur city yesterday. The child's mother, Sufia Khatun, claimed that her husband, Dulal Hossain from

Gopalpur of Tongi, killed their daughter Fatema with poison-induced fruit drink. She said another child of her husband, with a differ-

ent wife, had died of poisoning before. Mohammad Shahin, subinspector (SI) of Tongi Police Station, said there was no injury marks when they recovered the body from Dulal's house. The body was later sent to Gazipur Shaheed

College for an autopsy. The SI confirmed to have received a verbal complaint of poisoning from Sufia, Dulal's fourth wife. He said a case is under trial over death of another child Dulal

Doctors skip BMDC hearing

Despite being notified in advance to be present before a probe committee formed by Bangladesh Medical and Dental Council (BMDC), four doctors sued for their alleged negligence in treatment of Rafida Khan Raifa remained absent during the committee's visit yesterday.

The four-member committee headed by Prof Dr Nurul Amin visited Max Hospital in Chittagong city as part of their investigation.

BMDC formed the committee on July 18 to investigate into the death of Raifa. The threeyear-old died at the hospital on June 29.

Raifa's father Rubel Khan, a senior reporter of Bangla daily Samakal, filed a complaint on July 18 accusing four doctors. Police took two days to record the case as they needed to take permission from higher

authorities, said a police official, but did not explain why they needed the permission for filing a case.

The accused doctors are hospital director Liakot Ali, child specialist Bidhan Roy Chowdhury, medical officer Debasis

Sengupta, and Shuvro Deb. Soon after forming the committee, BMDC issued a notice to Dr Bidhan Roy, Debasis Sengupta and Shuvro Deb, asking them to be present before the committee by 9:00am yesterday.

While talking to journalists at the hospital, Dr Nurul Amin said, "The four accused doctors informed the committee that they could not be present due to personal reasons."

The probe committee also asked hospital Chairman Dr Shib Shankar Shaha, General Manager Ranjan Prashadgupta, nurses and staff members (who were on-duty during the

incident) and Raifa's parents to be present.

"We spoke to Raifa's father, he said he won't come to Max Hospital," said Dr Nurul Amin, adding, "After recording statements from both sides, we will reach a conclusion."

Other members of the committee are Prof Dr Abul Hasnat Joardar, an ENT specialist of Bangabandhu Sheikh Mujib Medical University, Prof Dr Narayan, a neurosurgeon, and the deputy registrar of BMDC.

PROBE COMMITTEE'S ROLE QUESTIONED

While talking to journalists, Rubel Khan, Raifa's father, said, "The committee came to Chittagong to investigate but they didn't record my statement; how will they find out the truth then?"

"They asked me to meet them at Max Hospital, but I refused. How could I go there?" said Rubel.

He said the committee members later asked him to meet at a restaurant. "I told them I can meet them at press club or Chittagong Circuit House or at my home."

Raifa died on June 29 at the hospital after

she was admitted there with pain in her throat. A government investigation led by the Chittagong civil surgeon found negligence of doctors in treating her. The committee also recommended punitive actions against three Max Hospital doctors -- Liakot Ali, Debasis Sengupta and Shuvro Deb.

A week after Raifa's death, Rab raided the hospital and fined it for various irregularities. In response, owners of private clinics, hospitals and diagnostic centres enforced a 20-hour strike in Chittagong.

NGO official, son arrested

Detectives of Chittagong Metropolitan Police yesterday arrested three persons including a father and son along with 5,400 yaba pills in Chittagong city's Firingi

Bazar area. The arrestees are Aftab Mia alias Arif Babu, 59, his son Alamin, 32, of Gazipur and Nihar Ranjan Mallik,

35, of Khulna. Aftab works as an NGO official at a Rohingya camp in Cox's Bazar, said Assistant Commissioner Moinul Islam of DB (west). On information, a DB team intercepted the trio in Bridge Ghat area, he

added. "After searching the bag Aftab was carrying, police recovered 4,000 yaba pills concealed inside. An additional 1,400 pills were recovered frisking Alamin and Nihar," said AC Moinul.

DB officials said Aftab, in guise of an NGO official, had been collecting consignments of yaba tablets from another female NGO worker for a long time.

"He used to peddle yaba from Cox's Bazar to other parts of the country. Police were trying to bust the racket," said the AC.

CU teacher Maidul sued under Section 57

Chittagong University's (CU) Assistant Professor Maidul Islam, who has left the campus due to threats issued by Bangladesh Chhatra League (BCL) men, has now been sued under ICT act yesterday for his alleged remarks defaming Prime Minister Sheikh Hasina. Md Ifterkhar Uddin Ayaz, a former execu-

tive member of CU unit BCL, filed the case under section 57 of ICT Act on Monday night with Hathazari Police Station, said Belal Mohammad Jahangir, officer-incharge (OC) of the police station.

In the case statement, the complainant said Maidul has defamed Prime Minister Sheikh Hasina in a Facebook post, spelling her name as "Hashi Na" on July 13.

Maidul also defamed the PM by posting a superimposed picture where several students were seen sleeping in a small room, and a bowl of distasteful-looking lentil soup, the complainant said.

According to the case statement Maidul gave a caption of the photo which reads "So which of the favours of your mother would

against Maidul to the department chairperson, and submitted a memorandum to the vicechancellor against two teachers including him. Later, the university formed a three mem-

ber probe committee to investigate into these allegations, against Maidul and Khandakar Ali Ar Raji, an assistant professor of mass communication and journalism department.

The BCL men have also announced the teachers "unwelcome" on the campus.
