Court extends Khaleda's bail

A Dhaka court yesterday extended the bail of BNP Chairperson Khaleda Zia until July 31 in the Zia Charitable Trust graft case.

Judge Md Akhtaruzzaman of the Special Judge Court-5 of Dhaka passed the order after Khaleda's lawyer Ziauddin Zia submitted a petition seeking extension of her bail.

The same day was fixed for hearing arguments on behalf of two other accused.

The same court on July 17 extended the bail of Khaleda until

The case was filed by the Anti-Corruption Commission with Tejgaon police in August 2011 accusing Khaleda and three others of abusing power to raise funds for the trust from unknown sources.

The three other accused are: Harris Chowdhury, political secretary of then prime minister Khaleda between 2001 and 2006, Ziaul Islam Munna, assistant private secretary (APS) to Harris, and Monirul Islam Khan, APS to former Dhaka city mayor Sadeque Hossain Khoka.

Of them, Harris is on the run, while Munna and Monirul are now on bail. The two were present in the court yesterday.

Khaleda, accused in more than 34 cases, is currently serving a five-year prison term in the Zia Orphanage Trust graft case.

In another development, the High Court yesterday continued for the seventh day hearing on an appeal filed by Khaleda challenging the lower court's verdict that sentenced her to five years' imprisonment in the

graft case. The HC bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman also fixed today

unified in terms of engagement, but

also on putting pressure, I think we are making progress slowly." This was the fifth UNSC meeting since the previous meetings held on September 28, November 6 and December 12 in 2017, and February 13, 2018. But, the Security Council could not take any action against Myanmar as China, backed by Russia, blocked even any UNSC statement.

"Some members of the council have kept us from taking action for cynical and self-interested reasons," US Ambassador in United Nations Nikki Haley said in Security Council meeting in May. "Some undermined the unity of the council demonstrated during the trip with unhelpful edits that only

weakened the council's message."

China also proposed substantial amendments to a British-drafted Security Council statement on Myanmar on May 9 and the 15member council eventually agreed a weaker statement, which also urged Myanmar to step up its efforts to create conditions conducive to safe, voluntary and dignified return of the Rohingyas. It also urged Myanmar to address the root causes of the crisis through implementation of the Rakhine Advisory Commission recommendations, including those related to human rights, citizenship, poverty alleviation and development.

Apart from the 15 Security Council members' visit, UN Secretary General, World Bank President and UN agencies chief visited the refugees in Cox's Bazar on July 1-2 and their call was identical to them and previous meetings, but there are serious doubts about the conducive conditions in Rakhine for safe, voluntary and sustainable repatriation of the Rohingyas from Bangladesh. "The conditions are simply not

there for a large number of people to return home," Red Cross President Peter Maurer, who recently visited Myanmar, told a press conference in Dhaka on July 3. Dire conditions led more than 300,000 to 500,000 to flee the country

between 2012 and 2016 and the latest crisis in Rakhine began on August 25, 2017 that forcibly displaced over 700,000 Rohingyas, who fled Myanmar and took shelter in Bangladesh. The military crackdown was

accused of widespread human rights violations, including rape, murder, torture and burning of Rohingya villages and thousands are believed to have been killed which the UN, US and international rights bodies said "text book example of ethnic cleansing".

Elections in the three city corporations will be held on July 30. In the last polls in 2013, BNP-backed candidates won all the three mayor posts defeating the AL favourites.

After being elected as Sylhet mayor, Arif was suspended twice over criminal cases. He could serve in the office for only 31 months out of his five-year tenure.

Immediate past Rajshahi mayor Bulbul was also suspected twice over criminal cases and served in the office for only 23 months.

Many voters in Sylhet said Kamran, president of Sylhet city AL, cannot highlight his development works during campaigning as the city residents are aware of what Ariful has done in last five years, and that too being in the opposition party and remaining behind bars for a major period of his tenure.

During electioneering, Kamran has been focusing on the national development works carried out by the government. He is claiming that all the development projects taken up by Ariful are mainly implemented by the ALgovernment.

"Ariful is showing the government's development projects as his personal achievement. But the people are aware of it. They know that electing an Awami League nominee as mayor will speed up the development works," he

On the other hand, Ariful has been highlighting his development works, including development of the drainage system, extension of roads, recovery of canals from grabbers to solve water logging, construction of Nagar Bhaban and digitalisation of the cor-

poration.

Talking to The Daily Star recently, Ariful said, "People know how I worked for the city's development though the government put me in jail for around three years. If a fair election is held, the voters will definitely stand by development."

The erstwhile Sylhet Municipality was upgraded to a city corporation in 2001 and the first city corporation election was held in 2003.

Kamran, also the last chairman of Sylhet Municipality, was elected as the first mayor of the city corporation.

Contesting the mayoral polls in 2008 from behind bars, he was reelected as mayor, beating his nearest rival by 83,339 votes.

But he lost to Ariful, a member of BNP central committee, in 2013 by a margin of 31,157 votes.

After taking office in 2013, Arif

In Barisal, BNP's Mujibur Rahman Sarwar might lose votes to the nominee of Islami Andolon Bangladesh. Besides, the votes of BSD candidate Monisha Chakraborty might have a negative impact on the results of AL nominee Serniabad Sadik Abdullah, said local experts.

Prof Maksudur Rahman Khan, secretary of Barisal Political Science Parishad, said, "The candidate of Islami Andolon Bangladesh might secure around 30,000 votes which would have gone in favour of BNP. The BSD's supporters used to vote for Awami League."

"We do not have any formal information yet about any casualties or how many are missing," an official in Attapeu province, where much of the flooding occurred, told AFP on condition of anonymity, adding that was no phone signal in the flooded region.

The \$1.2 billion dam is part of a project by Vientiane-based Xe Pian Xe Namnoy Power Company, or PNPC, a joint venture formed in 2012 between a Laotian, a Thai and two South Korean companies, according to the project's website.

Ratchaburi Electricity Generating Holding, the Thai company, said it had been told by operators that a 770-metrelong auxiliary dam used to divert river water had failed after heavy rainfall.

"The incident was caused by continuous rainstorm which caused high volume of water to flow into the project's reservoir," it said in a statement.

One of the South Korean compa-

nies, SK Engineering and Construction, said it had sent a crisis team to Laos, according to Yonhap news agency, and was bringing in helicopters from Thailand. South Korea's foreign ministry said

another Korean firm, Korea Western Power, was also involved. The companies and others had sent helicopters, boats and rescue workers. "All of our 53 nationals who were

taking part in this construction evacuated in advance," the ministry said in a statement. Pope Francis said in a Vatican message he had learned with sadness of the

loss of life, and expressed "hertfelt solidarity" with all those affected. The 410 megawatt capacity plant

was supposed to start commercial operations by 2019, according to the venture's website.

suspected to have links with Ansarullah Bangla Team (ABT), were arrested in Lucknow in September last year by the UP ATS. Mohammad Imran, Rajiuddin and Mohammad Firdaus, who were

brothers, were apprehended while boarding the Howrah-Amritsar Express train, officials said. The names of the three came out after an ATS team arrested a suspected Bangladeshi terrorist Abdullah, asso-

ciated with the ABT, from Muzaffarnagar in UP. ABT was implicated in many crimes, including some brutal attacks and murders of bloggers in

Bangladesh. ATS officials had earlier said Abdullah was associated with the ABI and was allegedly involved in preparing false identities for terrorists, especially for those from Bangladesh,
