HOLEY ARTISAN ATTACK Court sets Aug 8 for charge hearing

A special tribunal in Dhaka yesterday fixed August 8 for hearing the charges brought against eight militants in a case filed over the 2016 militant attack on Holey Artisan Bakery, an upscale restaurant in Gulshan.

Judge Mujibur Rahman of the Anti-Terrorism Special

Tribunal in Dhaka set the date and asked the law enforcers to produce all the accused before it on the day. Earlier, on July 26, Chief Metropolitan Magistrate Md

Saifuzzaman Hero transferred the case to the tribunal for disposal.

On July 23, police pressed charges against eight militants in the case. Five of the eight militants were killed inside the restaurant in a commando operation while eight others, including the mastermind, Tamim Ahmed Chowdhury, were killed later in different pre-emptive anti-militancy

Among the eight charge-sheeted accused, six are now in jail while two others -- Shahriful Islam Khaled and Mamunur Rashid Ripon -- have fled the country.

On July 1, 2016, armed militants stormed the Holey Artisan Bakery in the capital's Gulshan and killed 20 hostages, mostly foreign nationals. Two police officials were also killed during the 12-hour standoff.

Hammer attack on student beastly

Advocate AJ Mohammad Ali argued for Khaleda while Attorney General Mahbubey Alam and Advocate Khurshid Alam Khan appeared for the government and the Anti-Corruption Commission respectively.

On May 16, the Appellate Division upheld an HC order that granted fourmonth bail to Khaleda in Zia Orphanage Trust graft case and also ordered the HC bench to hear and dispose of her appeal by July 31.

Earlier on February 8, the Special Judge's Court-5 of Dhaka sentenced Khaleda to five years' imprisonment in connection with the case filed by the ACC.

Meanwhile, the HC bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman yesterday for the 10th day continued hearing Khaleda's appeal challenging the trial court verdict in the case.

The BNP chief filed an appeal with the HC in this regard on February 20 this year. The appeal hearing began on July 12.

COMILLA MURDER CASE

The HC bench of Justice AKM Asaduzzaman and Justice SM Mozibur Rahman fixed

tomorrow (August 1) for delivering its verdict on a bail petition filed by Khaleda in connection with a murder case lodged against her in Comilla in 2015.

The case was filed for torching a bus and killing eight persons and injuring 25-26 others in Comilla's Chouddagram on February 2, 2015, Deputy Attorney General Dr Md Bashir Ullah said.

Trafficking Act-2012. Reading out a written statement, Shohel said 778 human trafficking cases were filed in 2017 with only one successful conviction. In the first six months of 2018, 267 cases were filed with four successful convictions.

He also said 940 complaints were made to the call centre of

Wage Earners Welfare Board in the first half of this year and 95 percent of those were made from the Middle East. Speaking at the discussion, National Human Rights

Commission Chairman Kazi Reazul Hoque said human trafficking has been occurring in Bangladesh due to "negligence in duty" and syndicates of unscrupulous middlemen. Separate tribunals to deal with trafficking cases have not been established yet. Women and children repression pre-

vention tribunals are tasked with additional duty to deal with the cases but they could not provide expected results. He also alleged that the manpower sector has been han

dled by unqualified people who are sending unskilled workers abroad, resulting in frequent incidents of abuse. AKM Masud Ali, executive director of Integrated

Community and Industrial Development Initiative in Bangladesh, said a lack of government initiatives, coordination among institutions and inadequate budget allocations are challenges in fighting trafficking. Currently Bangladesh's position is in the "Tier 2 Watch List" of the US State Department's annual trafficking in

persons report. Further demotion in the list may cause economic sanctions on Bangladesh, he added. Abul Kalam Azad, additional superintendent of police (Dhaka range), said a delay in reporting of trafficking by its

victims makes it difficult for police to aprehend the criminals. Vincent Gule, protection officer of UNHCR in Bangladesh, among others, spoke at the event.


