# Outrage over Shajahan's smile, remarks

alleging a link between one of his relatives and Jabal-e-Noor Paribahan, the company that owned the bus involved in Sunday's accident.

Talking to reporters, the minister, however, claimed that none of his relatives had any links with the bus operator.

On Sunday, a bus ploughed into a crowd waiting for transport near the Airport Road flyover ramp, leaving two students dead on the spot. At least nine others were injured.

Shajahan, also the executive president of Bangladesh Road Transport Workers Federation, apparently tried to downplay the loss of lives that day.

When reporters asked him about the accident, the minister, with a broad smile, threw a counter question at them.

"A road crash has claimed 33 lives in India's Maharashtra; but do they talk about it like the way we do?" he asked.

The remark and the smile caused a furore on social media.

"Weird, horrible smile: an expression of inhumanity and lack of conscience," one Mohammad Anwarul

Haque wrote on Facebook.

Talking to reporters at his secretariat office yesterday, Shajahan said, "Students are demanding my resignation. They can do that. But I want to ask them will my resignation solve the problem? I will resign if it solves the problem. "However, the problems I have

solved in so many days have to be taken into account. He said many of these students did

not "play their due role" in preventing the rise of militancy and arson attacks in 2015, but transport workers kept transport system active even after the death of 92 workers. Queried whether he would apologise

for his comments the previous day, Shajahan said, "I am not supposed to apologise. Those who are responsible for the accident will apologise. However, as I am involved in workers' politics, I am expressing my deep shock."

To another query, he said, "None of my relatives has any links with Jabal-e-

He said his brother-in-law was one

of the 12 directors of the bus operator. There were many more similar However, he is not linked with the company for the last five years.

Contacted, Zakir Hossain, chairman of Jabal-e-Noor Paribahan, said the minister's brother-in-law Nannu Mia severed ties with the company more than a year ago.

The name of the owner of the bus, responsible for the accident, was Jahangir Alam, not Nannu Mia, he added.

Shajahan also claimed the number of accidents has come down due to his repeated meetings with transport owners, reports UNB. He also said a meeting with bus

owners was slated to be held today to further discuss preventive measures against road accidents. Meanwhile, in a statement,

Bangladesh Chhatra Union demanded the minister resign immediately as he "tried to avoid responsibility for Sunday's accident".

In another statement, Janagan-Jukta Front, a platform of politicians, said it rejected the comments made by Shajahan on Sunday.

# Protest rages

Two students of Shaheed Ramiz Uddin Cantonment College, Dia Khanam Mim and Abdul Karim Rajib, were killed as the driver of one of the buses ploughed into a crowd near the ramp of the Banani flyover, adjacent to the Armed Forces Medical College in Kurmitola.

Meanwhile, Khondaker Enayet Ullah, secretary general of Bangladesh Road Transport Owners' Association, termed Sunday's crash a murder and demanded the highest punishment for those responsible.

He said their association would investigate the incident. "If any fault on the owner's part is found, the association will take action," Enayet said.

Any transport company owner appointing unskilled drivers without licences should be punished, he

#### added. ROAD BLOCKED, PEOPLE SUFFER

Several hundred students in uniforms of different schools and colleges gathered near Shewra Bazar around 10:00am and began to march towards the Radisson Blu hotel, chanting slogans and demanding justice for Sunday's victims.

Students of Shaheed Ramiz Uddin Cantonment College, Tejgaon Biggyan College, BAF Shaheen College, Bhashantek Government College, Kurmitola High School and College, among others, joined the procession.

They blocked both sides of the Airport Road around 10:30am. Some

sat on the road while others stopped vehicles in the area. Around 15 minutes later, they van-

dalised at least seven buses near Radisson, witnesses said.

The protesters demanded exemplary punishment for the drivers.

They also slammed Shipping Minister Shahjahan Khan for trying to make the deaths in road crashes seem insignificant.

"The parents who lost their son and daughter can understand their losses. But how can a minister make fun of the matter? With the minister's indulgence, the bus drivers have become reckless. We want the highest punishment for the bus drivers and demand resignation of the minister," said a student of Shaheed Ramiz Uddin Cantonment College.

One of the students was seen hold- a single car was moving there. I ing a placard that read "[Do] we need 33 bodies for justice?"

The minister on Sunday had mentioned that 33 people had died in a road crash in India.

The protesters urged the government to take responsibility of the roadcrash victims and compensate the victim's families.

They also demanded speed-bumps in accident-prone areas and a footbridge in front of Shaheed Ramiz Uddin Cantonment College.

Around 2:00pm, the protesters again vandalised at least seven buses on a flyover in the area.

Around 3:15pm, the head teacher of Shaheed Ramiz Uddin Cantonment College went there and requested the students to leave. But the protesters refused to do so.

As police chased them away around 4:00pm, they vandalised around 50 vehicles in Shewra Bazar, Kuratuli and Khikhet areas.

Demonstrators at Science Lab, Mirpur-10 and Pragati Sarani areas vandalised several buses as well.

The nearly six-hour blockade threw Dhaka's traffic into chaos. Scores of people were seen walking as traffic crawled to a halt and stayed like that for hours.

A flight-operations official at Hazrat Shahjalal International Airport told The Daily Star that at least seven passengers of three flights scheduled to depart between 4:45pm and 7:30pm called and requested the authorities to delay their flights as they were stuck in

All except the three scheduled to fly at 7:20pm might have missed their flights as the planes left on time, the official said wishing anonymity.

Rafiqul Islam, a 55-year-old labourer, was coming from Sirajganj to Mohakhali. As the bus didn't go beyond Tongi fearing vandalism, he had to walk for hours in the afternoon to Cantonment Railway Station.

also got stuck in traffic. Soraiya Malik, 60, missed her flight

to Kolkata after being stuck in traffic for three hours in Banani. "I left my Niketon home at 1:00pm to catch the flight at 5:20pm. After

BRTA SUSPENDS REGISTRATION The BRTA suspended registration of

the two buses, Dhaka Metro Ba-11-7657 and Dhaka Metro Ba-11-9297, for "driving dangerously", Masud Alam, deputy director of the BRTA told The Daily Star, adding that the move was taken as per law.

He said the bus, Ba-11-9297, which ploughed into people had no route permit.

Besides, fitness, route permit and tax token of the other bus had expired, an official said.

"We have written to the bus company [Jabal-e-Noor Paribahan] to appear with all their documents at our office. Further action would be taken after going through the documents," Masud said.

Asked about the allegations, Zakir Hossain, chairman of Jabal-e-Noor Paribahan, said he did not know whether the bus had a route permit. DRIVERS, ASSISTANTS DETAINED

Kabir Hossain Hawlader, inspector (investigation) of Cantonment Police Station, said a victim's father filed a case on Sunday night against an

unnamed driver. Mim's father Jahangir Fakir, however, said, "I was unaware of filing any case, but police took signature on a paper

from me before taking my daughter's body from the police station. "I am not satisfied with the case. I intended to file a murder case for the

killing of my daughter." Rab detained three drivers and two assistants of three buses in separate

Later at around midnight, some locals spotted Kirtika's body in a nearby forest.

After police recovered the body, it was sent for autopsy. It is believed that she was murdered after being raped. Kirtika was a fourth grade student

of Noimile Tripura Guchhagram Government Primary School. The brutal incident sparked protest

rallies and meetings in Khagrachhari district town, where demonstrators demanded that the murderers and rapists be given exemplary punish-Yesterday morning, students of Khagrachhari Government College

boycotted classes and took out a procession that gathered in front of the main gate of Khagrachhari District Judge Court. Members of different student organisations partic ipated in the demonstration under the banner of Bangladesh Marma Students Council and Tripura Students and Youth Front.

Leaders of Greater Chittagong Hill Tracts Hill Students Council, Hill Women's Federation, and the Socialist Students' Front spoke in solidarity with the demonstrators.

Elsewhere, many socio-cultural and student organisations like Bangladesh Tripura Kalyan Sangsad, people from Noimile Guchhagram under the banner of Noimile Guchhagram Residents, Tripura Students' Forum, and Bangladesh Primary Teachers' Association, formed a human chain at Khagrachhari town's Shapla chattar. They too demanded the immediate arrest of the culprits.

Later, Bangladesh Tripura Kalyan Sangsad went to the Khagrachhari Deputy Commissioner's office to hand over a memorandum to be sent to the prime minister in regard to the incident.

With this, at least five girls have been raped in Khagrachhari in the last three months.

the youth and sports ministry, which are interested in taking support for elearning. The BCSCL has also negotiated with

workers following widespread media reports of labour exploitation.

Additional workers were recruited for many name-only Malaysian companies during 2006-09 when private recruiting agents sent works to Malaysia. Workers were charged over Tk 2 lakh each though the government had fixed the migration cost at Tk 84,000 each.

After about four years of freeze, Bangladesh and Malaysia in 2012 signed a G2G deal to reduce migration costs and corruption, but only 10,000 workers could secure jobs in Malaysia under the agreement, thanks to alleged conspiracies of the recruiting agents and brokers. Under the deal, workers could only

have jobs in Malaysia's plantation sector, which raised questions about the sincerity of the authorities. Following the Andaman boat crisis

in 2015, which revealed how

Rohingyas and Bangladeshis were taking the sea route to Malaysia, the Malaysian government and recruiting agents started saying that the G2G system was not working. Amid pressure from private recruiting agents, Bangladesh and Malaysia signed the G2G Plus agreement in 2016, but

migration experts expressed concern that it would drive up the migration costs. The scandal involving the G2G Plus surfaced after the political changeover in Malaysia in May this year when the government launched a campaign against the corruption of the previous

government's ministers. According to The Star report, only 10 out of over 1,000 Bangladeshi recruiting agents got the right to hire workers Bangladeshi workers are now working

under the G2G Plus arrangement. Malaysian Minister Kulasegaran

announced suspending the G2G Plus, in 2009 after it put a freeze on hiring launching a full investigation into the matter and reviewing the recruitment system with Bangladesh and other countries.

given to the victims' families. The expert committee has been asked to submit its assessment report to the HC in two months after receiving the order, writ petitioner Ruhul

Quddus Kazal told The Daily Star. The court ordered the BRTA chairman and the additional commissioner (traffic) of Dhaka Metropolitan Police (DMP) to assist the expert committee to do its task.

An HC bench also issued a rule asking the respondents to explain in four weeks why a directive should not be issued on the owner of Jabale-Noor Paribahan to give Tk 2 crore as compensation to each of the families of the two students killed on Sunday.

That technique has already allowed Kepler to find thousands of possible planets, some of which are key candidates for habitability. Tess is expected to find thousands more.

Its work has already begun and it will send its first set of science data back in August. After that it will send down new findings roughly every fortnight, and the science team will scour through it for signs of planets as soon as it arrives. "I'm thrilled that our planet hunter

is ready to start combing the backyard of our solar system for new worlds," said Paul Hertz, Nasa Astrophysics division director at its headquarters in Washington. "With possibly more planets than stars in our universe, I look forward to the strange, fantastic worlds we're bound to discover."

Tess's mission is scheduled to last for two years. But Kepler and other Nasa projects have lasted much longer than those initial projects, so it could be peeking through our universe for much longer than that.
