Sufferings mount on long routes

Transport owners announce suspension of bus services for an indefinite period

STAR REPORT

Bus operators yesterday declared suspension of long-distance bus service for an indefinite period on "security grounds", which is likely to worsen people's sufferings caused by the "undeclared transport strike".

Like the previous two days, transport owners and workers kept long-haul buses off the roads yesterday, affecting road communication between the capital and the rest of the country.

They ran only a handful of inter-district buses for what they said was fear of vandalism amid the ongoing student agitation for safer roads.

A small number of night coaches plied the highways in the last two days.

Yesterday, transport leaders said they would not run buses "until the situation became normal".

Khondaker Enayet Ullah, secretary general of Bangladesh Road Transport Owners Association, told The Daily Star, "No bus will operate from tonight, as the situation has worsened."

"From now on, bus service will remain suspended for an indefinite period due to lack of security," he said.

Evil political forces infiltrating student protest
Says Obaidul Quader

Awami League General Secretary Obaidul Quader yesterday alleged that evil political forces are infiltrating the students' peaceful movement.

"Vested quarters have extended political support to the student movement, and attempts have been made to transform the student protest into an anti-government movement," he said.

The AL leader was talking to reporters after a meeting with the party's secretary-level leaders at the AL president's Dhamondi office yesterday afternoon.

Intelligence agencies are keeping an eye on some people and closely watching their movements, suspecting their links to the ongoing demonstrations, he mentioned.

Quader, also road, transport and ministers, called upon the agitating students to stay alert so that no vested quarter can take advantage of them capitalising on their non-political movement.

"The students should remain alert about the vested quarters that have extended political support to the movement. They [vested quarters] are trying to fish in troubled waters to create an

Rumour mill goes into overdrive

Actress Nawshaba picked up

Over the last couple of days, some rumours have been spread apparently to undermine the peaceful student movement for road safety or to make it violent.

Some vested quarters are using social media, particularly Facebook, to serve their agenda, said high officials of Dhaka Metropolitan Police.

Showing some photographs at a press conference yesterday, DMP Commissioner Asaduzzaman Mia said the vested quarters have resorted to spreading rumours with photos dating back to 2012 and 2015 depicting police excesses on students.

In one such photo, a police official is seen holding a boy by his collar. The photo is from 2015 but it has been doing the rounds on social media over the past several days with the claim this is a moment of the road safety demo.

The city police boss called upon the people to remain alert to this sort of distorted and misleading items. He said police have launched investigation into the rumours, and those behind it would be identified and brought to book.

Many have been found sharing and posting such contents without verification, leading to confusion.

In one rumour, it was claimed that Dhaka Residential Model College expelled some of its students for joining protests.

However, the school authority later in a clarification said some students were sent home for parental motivation as they violated discipline. They have come back to their dormitories at the college.

Another post read that police picked up Sheikh Raian Ahmed Alif, an HSC student of Khilgaon Government Colony College, from his house in Kajla in Jatrabari. Later, a status from the supposed Facebook page of the youth said he was not detained.

Meanwhile, UNB reports, police filed a case with Ramna Police Station accusing 29 social media users and online news portals on charges of

Mobile net slowed down

Many users say they can't access internet

Mobile internet speed was brought down to minimum level yesterday evening so that picture or video could not be uploaded for next 24 hours following a recommendation of the law-enforcement agencies to limit street agitations.

The Bangladesh Telecommunication Regulatory Commission passed on the order yesterday afternoon to all mobile phone operators and asked them to implement it from 7:30pm, said a top executive of a mobile operator.

"The telecom regulator has directed us to bring down the speed for next 24 hours and after that they will evaluate the situation and give us new directives,"
