

# Attack on Badiul's house condemned

Eminent personalities yesterday strongly condemned the attack on the residence of Badiul Alam Majumdar, secretary of civil society platform Shushashoner Jonno Nagorik (Shujan).

They demanded that the government immediately identify the attackers and bring them to justice. The government will also have to ensure security of Badiul and his family, according to a press statement.

Around 11:00pm on Saturday, unidentified youths attacked Badiul's house in Dhaka's Mohammadpur area. The attack came when some guests, including US Ambassador Marcia Bernicat, were leaving the house.

The attackers smashed windows and tried to storm the house through breaking its main door. They even attacked Badiul's son Mahbub Majumdar, the statement said.

Economist Dr Akbar Ali Khan, Shujan President M Hafizuddin Khan and Vice-President Justice Kazi Ebadul Haque, litterateur Selina Hossain, columnist Syed Abul Maksud, physician Zafrullah Chowdhury, jurist Shahdeen Malik, economist Prof Anu Muhammad, rights activist Sheepa Hafiza, Barrister Sara Hossain, and green activist Syeda Rizwana Hasan were among the signatories of the statement.

# Forced displacement of indigenous people must stop

#### Says Bangladesh Adivasi Forum

Indigenous people have been enduring forced displacement from their ancestral land across the country, and in Chittagong Hill Tracts the situation is particularly worrisome with little progress in implementing the CHT Peace Accord, signed 20 years ago, Bangladesh Adivasi Forum said.

"We call on indigenous people to continue resisting forced migration," said the Forum in a press release yesterday ahead of International Day of the World's Indigenous Peoples (August 9). The theme of the day this year is "Indigenous peoples' migration and movement".

Indigenous people are being deprived of basic human rights. Abduction, torture,

rape, and murder of indigenous women have alarmingly gone up in recent times. Against this backdrop, according to Kapaeeng Foundation, 500 indigenous people migrated to Myanmar from Bandarban due to prevailing insecurity

Since 1947, indigenous people were forced to leave their homeland on several occasions. Forty-seven years have passed since independence but they are still being repressed politically, economically and are facing violence, said the

Under state patronisation, more than 5 lakh Bangalee settlers have been rehabilitated in the CHT so that the indigenous community living there becomes a minority; the conspiracy is on, said the recognition.

"They [indigenous people] are so

neglected by the state that the stories of their displacement remain unheard, said Adivasi Forum President Jyotirindra Bodhipriya Larma while reading out the statement during a press conference at a city hotel.

At yesterday's event, the Forum demanded enactment of "Adivasi Rights Protection Act", an end to forced migration, allocation of separate budget, drawing up a plan of action and roadmap to implement the CHT Accord, and investigation into human rights violations.

Sanjeeb Drong, general secretary of the Forum, said the government does not recognise the existence of indigenous people in the country, which is why the international day is yet to see state POLICE OFFICERS SELLING YABA

## HC questions govt's inaction

The High Court (HC) yesterday issued a rule asking the government to explain in four weeks why it should not be directed to immediately take departmental action against four police officers including the superintendent of Cox's Bazar Police on charges of selling yaba pills to drug traders.

HC bench of Justice Moyeenul Islam Chowdhury and Justice Md Ashraful Kamal issued the rule based on a writ petition filed by Advocate Abul Kalam Azad, seeking necessary orders for departmental action and suspension of the four officials.

Home secretary, inspector general of police, director general of directorate of narcotics control and deputy inspector general of police in Chittagong have been made

respondents to the rule. The four police officers are Cox's Bazar SP AKM Iqbal Hossain, In-charge of Cox's Bazar Police box Monirul Islam, SI of Police Bureau of Investigation Kamal Hossain, and the OC of Teknaf Police Station, writ petitioner's counsel

Advocate Farhad Uddin Ahmed Bhuiyan said. The lawyer said, the police officers have reportedly sold

around 10 lakh yaba pills to drug traders last year. The allegation has been found true in a probe report, but the respondents have not taken any action against the officers, he added.

### Jamaat ex-MP Shahjahan remanded for

'sabotage plan'

STAFF CORRESPONDENT, Ctg A court in Chittagong yesterday remanded eight leaders and activists of Jamaat-e-Islami including its former lawmaker Shahjahan Chowdhury on charge of planning destruc-

tive activities.

Metropolitan Magistrate Safi Uddin passed the order after they were produced before the court with a fiveday remand prayer, said Additional Deputy Commissioner (ADC) (prosecution) Nirmalendu Bikash Chawakrabarty of Chittagong Metropolitan Police (CMP).

"The court granted a two-day remand for Shahjahan and his associate Abu Taher each and a three-day remand for the other six after a remand hearing," he said.

Earlier, detectives of CMP arrested the eight at a house in Chittagong city's Khulshi area while they were holding a "clandestine" meeting on August 3.

After the arrest, the detectives said the arrestees gathered at the place to plot a sabotage plan taking advantage of the ongoing student movement for road safety. Later, police filed a case against them with Khulshi Police Station under the Special Powers Act. According to police,

Shahjahan stands accused in 20 cases filed with different police stations in the district and city.

He was elected a member of parliament (MP) from Lohagara constituency twice and was the former nayeb-e-ameer of Chittagong Jamaat-e-Islami.

# 'Sick' governance prevailing in the country: Dr Kamal

in Dhaka. He also said he is ready to sacrifice his life

to free the country from violent thugs. Praising students for their movement, BNP Secretary General Mirza Fakhrul Islam Alamgir said the children have pointed out

that the country needs reformation. He urged people to unite and wage a movement against the repressive govern-

ment. "When injustice becomes the law, resistance becomes the duty," said AQM Badruddoza Chowdhury, president of Bikalpa Dhara Bangladesh, calling upon the people to continue the movement against
