The United Nations Children's Fund (UNICEF) invites Expression of Interest for the pre-qualification of vendors for supplying goods as part of UNICEF supported programmes and operations in Bangladesh. The vendor for supplying goods include the following categories of goods:

- ICT, Office and AV Equipment;
- Power Generation Equipment (Solar power system, Generators, IPS);
- Transport (Motorcycle, Bicycle, Easy bike, Boats with wooden and fibre, etc.);
- Office supplies, Stationery and Special Items;
- Furniture (Office, Hospital, School/Learning Centre);




