

## Instigating Student Movement Two pro-BNP ward councillors remanded

A Comilla court placed two BNP-backed ward councillors on a one-day remand each in a case filed for "instigating a student movement to tarnish the image of the government".

The court passed the order after the accused -- Golam Kibria and Siddikur Rahman Suruz, councillors of ward 1 and 20 respectively -- were produced before it with a seven-day remand prayer, said police.

On Sunday, detectives arrested Kibria in the city's Palpara area and Suruz in Unaihar. Same day, detectives from Dhaka also arrested Mizanur Rahman Naomi, son of councillor Siddikur Rahman, in Barura upazila of Comilla for his alleged phone conversation with BNP leader Amir Khasru Mahmud Chowdhury, said police.

Later, police filed a case against 14 people including the two on the same charges with Kotwali Model Police Station.

Earlier, on Saturday, Amir Khasru was sued after a recorded phone conversation, presumably between him and Naomi, went viral on the social media.

He was accused of "attempting to create anarchy", said police.

## Dogs unleashed on man over borrowed money

Rickshaw-puller Abdur Razzak was first beaten up, and two dogs were unleashed upon him on Friday night in Narayanganj, only for asking for his money back.

Severely injured Razzak filed a case with the Fatullah police station yesterday, accusing one Mahbubur Rahman, 30, their guard Mahiuddin, 40, and two to three other unnamed people.

Citing the case statement, Manzur Qader, officer in charge of Fatullah Model Police Station, said Mahiuddin, a guard of a house, borrowed Tk 7,000 from Razzak a few months back. Razzak and Mahiuddin locked in an altercation when Razzak asked him to return the loan on Friday. Mahiuddin with the help of his landlord's son Mahbubur Rahman and some others took Razzak to the rooftop of their house. They beat him up and later unleashed their pet dogs upon him, who bit Razzak badly.

Later, family members of Razzak rescued him and admitted him to Narayanganj General Hospital.

OC Manzur Qader said the accused are on the run since the incident.

Abdur Razzak said, after beating him, the accused threatened him not to lodge any complaint against them. Later he filed the case upon assurance from police.

## 300 ferry passengers rescued after 999 call

Around 300 passengers of a ferry on river Padma were saved from drowning yesterday, after a passenger sought help by calling the national emergency helpline following an accident.

The ferry named Ranikhet, carrying nine trucks and six buses on it along with around 300 passengers, was heading towards Kathalbari from Mawa when it had an accident and water started to fill inside it around 10:05am.

A passenger of the ferry named Shohag called 999 and informed them of the ferry's location, Md Sohel Rana, assistant inspector general of police (media and PR), told The Daily Star.

The police official who received the 999 call informed the coastguard, river police and fire service without any delay. Rescuers reached the spot and succeeded in rescuing all 300 passengers of the ferry.

Later, a rescue team of Munshiganj Fire Service Station in Srinagar drained the water from the ferry, the police official added.

## Veranda collapse injures 4 women

Four women were injured as a veranda of a dilapidated three-storey building collapsed on Debendra Nath Das Road in Dhaka's Sutrapur area early yesterday.

The injured -- Lipi Begum, 35, Halima Begum, 35, Kulsum Begum, 50, and Majeda Begum, 45 -- are all from Rangpur and they are domestic workers in the city.

The veranda, rented a couple of years ago on the second floor of the house by the four women, suddenly caved in around 3:30am, said Golam Sarwar, an officer of Fire Service and Civil Defence station in the area.

Locals rescued and took the injured to Mitford Hospital.

The caretaker of the building, Zarina Begum, 75, said house owner Ibrahim Hossain lives elsewhere.

The residents of the building have been asked to evacuate, said KM Ashraf Uddin, officer-in-charge of Sutrapur Police Station.

A youth was stabbed to death, allegedly by his neighbour, over stealing guava in Chittagong yesterday.

Abu Khan, 20, son of Mozaffar Ahmed, allegedly stole guava from the garden of his neighbour Mohammad Akkas in Dakkhin Gunagori village of Banskhalia upazila, said Banskhalia Police Station Officer-in-Charge Salauddin.

Akkas stabbed him over the theft, the OC said quoting the victim's friend Shihab, who claimed to have witnessed the incident.

Abu Khan died at Chittagong Medical College Hospital, said CMCH police.

indigenous people have become extremely marginalised.

They have a lack of resources, means of income and education, he said, adding that their rehabilitation is necessary.

In the absence of legal protection of the indigenous community, the RDC and parliamentary caucus jointly drafted the Bangladesh Indigenous Peoples' Rights Act to ensure their security and rights. However, the bill has not yet been presented in the national parliament sessions.

Lawmaker Khalid Mahmud Chowdhury said consistency is needed to pursue the bill in the parliament.

There should be a movement to ensure the rights of indigenous communities in Chittagong Hill Tracts, said KS Mong, a member of CHT Regional Council.
