Woman 'kills self after stabbing landlady

A woman allegedly committed suicide at home after stabbing her landlady in Chittagong city's Baluchara area on Thursday afternoon.

The deceased was identified as Liza Chowdhury, 24, said police.

Liza lived alone in the tin-roofed house owned by Uttam Barua, said Ataur Rahman

Khondakar, officer-incharge of Bayezid Bostami Police Station.

Liza, who introduced herself as a private job holder to her house owner, had a fight with Uttam's wife Antara Barua, 26, over

a trifling matter. At one stage, Antara asked her to leave the house, said the OC quoting locals. Out of anger, Liza stabbed her indiscriminately around 3:30pm on that day.

Family alleges police didn't receive case, released accused

An eighth grader was allegedly raped by her cousin on August 15 and since then she has been undergoing treatment at Patuakhali General Hospital.

Her family claimed that they went to Mirzaganj Police Station to file a case immediately but police did not record it as FIR (First Information Record) when they brought the accused to the police station.

Police also released the accused later, her family claimed. The victim, daughter of Eunus Bepari from Maida village under Mirzaganj upazila, is a student of a Dakhil madrasa.

The accused, identified as Md Rasel, 25, son of Abdur Razzak Sikder of the same village, is her cousin. He is unemployed.

According to the girl, at about 1:00pm on August 15, her parents were out of the house. Rasel came over to their house and raped her.

Upon hearing her cries for help, neighbours arrived and rescued her; Rasel managed to flee.

In the evening, she was taken to Mirzaganj Upazila Hospital and the on-duty doctor referred her to Patuakhali

Morsheda Begum, a staff nurse, said she is undergoing treatment as a "rape victim".

"The next day we went to Mirzaganj Police Station and submitted a written complaint but they [police] didn't record the case," said Md Sajib, her brother-in-law.

Sub-inspector Bimol Kumar brought the accused to the police station in the evening the next day, he said.

But after several hours, a local influential person took

Rasel away from the police station, Sajib claimed. SI Bimol Kumar denied the claim and said he had visited

the spot and found no evidence of rape. Masumur Rahman Biswas, officer-in-charge (OC) of

Mizaganj Police Station, said during the incident he was on leave and later on learnt that they did not file the case. There has been an ongoing conflict over a piece of land

between both the families, he said, adding that Rasel has been handed over to his father.

Contacted, Md Moinul Hasan, superintendent of police, said he has already asked the OC to take necessary steps regarding the incident.

Conman extraordinaire!

Saiful Islam Rudro is a busy man. The 30-year-old is not only a member of the Detective Branch of police but also a journalist of eight different print and online media houses. The resident of Morjal area in

Narsingdi's Raipura upazila is also a "close acquaintance" of the home minister and carries the minister's "seal" with him. Rudro has been using all of his

identities and connections to deceive people and fleece them with a promise to "solve their problems". The above came to light after the

Detective Branch of police in Narsingdi arrested him at Narsingdi Sadar upazila intersection of the

town on August 20.

Identification cards showing him as a journalist of eight print and online media agencies, a seal with name of the home minister and NID cards of 41 persons were also seized from his possession.

"Impersonating as a DB police or journalist or even claiming that he is close to the minister, Rudro would take money from people," Abdul Gaffar, sub-inspector of Narsingdi DB police, told The Daily Star.

"Also, he used to collect NID cards from people, assuring that he would fix the dates, spelling mistakes or help them get their passports without any hassle," the SI

A week ago, he took Tk 3,000 from

one Ayesha Khatun of Amirganj, assuring that he would help her recover a piece of disputed land, he added.

The 60-year-old widow arranged the money by mortgaging her daughter's ornaments. As Rudro fled the area after taking

the money, Ayesha was devastated. Later, some journalists found the poor woman crying near the Sadar upazila intersection. They took her to the office of DB police.

Hearing her story, police were able to arrest Rudro on Monday, said the SI.

He said Ayesha filed a fraud case against Rudro with Raipura Police Station. A court in Narsingdi sent him to the district jail on Tuesday.


