DEATH OF RAIFA Ctg court grants bail to 4 physicians again

A Chittagong court yesterday granted bail to four doctors who were sued for their alleged negligence during treatment of three-year-old Rafida Khan Raifa, who died at a private hospital in the city on June 29. The court, however also expressed shock at the death.

The court of Chittagong Metropolitan Magistrate Abu Salem Md Noman granted the bail till the completion of investigation, after the doctors surrendered before the court on completion of their four weeks of bail, granted by a bench of High Court (HC).

The accused doctors are managing director of Max Hospital Dr Liakot Ali, child specialist Bidhan Roy Chowdhury and medical officers of the hospital Dr Debasis Sengupta and Dr Shuvro Deb.

Assistant Commissioner (AC) (Prosecution) Kazi Shahbuddin Ahmed of Chittagong Metropolitan Police (CMP) said the four doctors surrendered before the court on completion of their bail and sought bail again in the case.

"After hearing, the court granted bail to the accused on a bond of Tk 10,000 each until police complete their probe in the case," said the AC.

Rafida Khan Raifa, daughter of Rubel Khan, a senior reporter of Bangla Daily Samakal in Chittagong, died of medical negligence on June 29 at Max Hospital after she was admitted there with pain in her throat.

Following the death, Rubel Khan filed a case accusing the four doctors under section 304 (Kha), 201, 109 and 34 of Penal Code with Chawakbazar Police Station on July 18.

DEATH, ILLNESS OF CHILDREN IN HATHAZARI

Report finds measles outbreak at Tripura Para

A report by Institute of Public Health (IPH) revealed that outbreak of measles at Sonai Tripura Para under Hathazari upazila in Chittagong caused illness among children who were hospitalised in a span of a week, right after four children had died in the same area.

Azizur Rahman Siddique, civil surgeon of Chittagong, confirmed the findings to The Daily Star yesterday afternoon.

"The committee, formed to investigate the matter, sent samples of blood, cough and stool collected from six random children to IPH on Sunday. The IPH experts found the

presence of measles virus in all the and rash. samples," said the civil surgeon.

He, however, could not confirm if the same virus caused the death of four children at the beginning of the outbreak. "As the deceased were not

brought to hospital, doctors could not diagnose them. They were also cremated, so we had to rely on the information provided by their parents," he added.

Following the death of four children, including three siblings at Tripura Para, panic broke out in the locality. Meanwhile 22 children, aged between six and seven, were hospitalised last week with the same symptoms of fever, cold

Dr Abu Sayed Mohammed Imtiaz, health officer of Hathazari upazila, said they brought all the ailing children to the health complex as their parents panicked after hearing the rumour of an unknown disease.

"The disease was not 'unknown', it was unidentified. If those four children were brought to the hospital in time, their lives could have

22 children, three from the same family were admitted to Faujdarhat Cholera Hospital on Sunday.

Two of them had viral pneumonia, he said. "The family admitted all three children as they feared the third

child might also catch the disease."

Meanwhile, representatives of World Health Organisation (WHO), Directorate General of Health Services and Hathazari Upazila Health Complex visited the remote locality, around 25 kilometres away from Hathazari municipality, yesterday morning.

Dr Rezaur Rahamn, programme manager of 'Extended Programme on Immunisation' supported by WHO, said, "The locals live in a dismal condition without proper education, sanitation and safe drinking water. Moreover, they are reluctant to receive medical treatment from hospitals because of superstitions."

Amir Khasru gets anticipatory bail

The High Court (HC) yesterday granted anticipatory bail to BNP leader Amir Khasru Mahmud Chowdhury in two separate cases filed in Dhaka and Chittagong.

The bench of Justice Muhammad Abdul Hafiz and Justice Bhishmadev Chakrabortty granted bail to the accused after hearing two separate petitions filed by him.

The cases were filed on August 4 on charges of provoking the recent student movement for safe roads, and also conspiring with a Jatiyatabadi Chhatra Dal leader aiming to destabilise the country. The bench also asked Khasru to surrender before the lower courts concerned after expiry of the bail terms. The HC granted bail on grounds that the cases against him were politically motivated to harass him, said his lawyer Sagir Hossain.

Two killed after falling off trains

Railway police recovered two bodies from rail tracks near Mastan Nagar Railway Station area in Mirsarai upazila of Chittagong early yesterday.

The deceased were Manik, 35, of Comilla, and Hasan, 25, of Barisal. They were crushed under two separate trains. Two other passengers were also injured.

Police said Manik and two other passengers of Dhakabound Karnaphuli Express fell off the train around 6:00pm on Sunday, while Hasan fell off Chandpurbound Sagarika Express in the same area around 6:30pm. The victims were travelling on the roof and stairs of the overcrowded trains.

Chittagong Metropolitan Police (CMP) has formed a cyber crime monitoring cell with an aim to identify virtual troublemakers who spread rumours through instigative posts and videos on different social media platforms to create anarchy, and bring them

to book. The five-member monitoring cell, headed by CMP's Counter Terrorism Additional Deputy Commissioner (ADC) (Operation) Polash Kanti Nath, was formed based on an order by CMP Commissioner Mahmubur Rahman on August 20, following a letter of Police Headquarters (PQ), said police officials.

The other members of the monitoring cell are Inspector Aftab Hossain, Subinspector (SI) Siben Biswas, SI Rashib Khan

and SI Sanjoy Guha. "The members of the cell will monitor they said.

suspected IDs on Facebook and other social

media platforms to identify the troublemakers who share instigative and fake posts and videos as well as spread rumors from Chittagong," ADC Polash Kanti Nath told

PALLABI WATER TANK EXPLOSION

Two more succumb to injuries

Two more members of the family who were burnt in a water tank explosion at a building in Dhaka's Pallabi on the eve of Eid-ul-Azha succumbed to their injuries yesterday.

The deceased are Bedena Begum, 50, and Laboni Begum, 18. They were undergoing treatment at the burn and plastic surgery unit of Dhaka Medical College Hospital (DMCH). Bedena's son and Laboni's husband, Rabbi, is now fight-

ing for his life at DMCH with 38 percent burns. Laboni died at 8:00pm and Bedena breathed her last at

10:00pm, said Dr Partha Shankar Paul, a resident surgeon of the burn unit. Earlier Rabbi's father Surat Ali, 62, sister Aleya Begum, 30,

and Aleya's daughter Mili Akhtar, 4, died after the incident. Rabbi's brother Mohammad Shakil, a tenth grader, and sister Chapa Akhter, a fourth grader, had survived the fatal

accident as they were outside during the explosion. The building's landlord, Mosharraf Hossain, 48, his son Jisan, 18, and relatives Awal Hossain Babu, 32, and Alamgir Hossain, 32, were also injured.

There was a problem in the water line and there had been bad odour in the house for the last three months. The tenants had informed the landlord about it.

Last Tuesday, a cleaner opened the tank and fixed the problem. But that very night, the tank exploded immediately after its lid was opened, which triggered a fire.

Public service law | Scarcity of water to protect honest civil servants:

ACC chairman

Anti-Corruption Commission (ACC) Chairman Iqbal Mahmood yesterday said the proposed Public Service Act 2018 would not be meant for protecting dishonest public servants, rather for defending honest

"I believe the government cannot enact any law to protect corrupt elements. I rather see the proposed act as a protection of honest public servants instead of corrupt ones," he said while replying to a query about the proposed act at Segunbagicha's

ACC headquarters. But, he said, he didn't yet know what was exactly in the law about arrests (of public servants) as he saw contradictory news on it in different newspapers.

The ACC chief, however, sounded a note of warning against unscrupulous elements in public service, saying, "There is no reason for corrupt public servants to be pleased on passage of the law, as there would be no difficulty (for ACC) in arresting them."

Mahmood also said, "The ACC is an independent body and it is guided by law. The commission would remain independent."
