Russia hit with new US sanctions over nerve agent attack

AFP, Washington

The United States yesterday imposed new sanctions on Russia over the attempted assassination of a former spy in Britain using a lethal nerve agent.

The sanctions include halting foreign aid to Russia, blocking the sale of items or services related to defense and national security, and banning any

government credit support for any exports to Russia.

However, sales and services related to space launches, both commercial and government, will continue.

And the State Department has issued a non-specific "partial waiver" on the sanctions, a move which could dull their impact.

The sanctions, first announced

August 8, are a response to the March 4 failed attempt to kill former Russian intelligence agent Sergei Skripal and his daughter Yulia Skripal using Novichok, a military-grade nerve agent developed by the Soviet Union during the Cold War. The British government says the attack in Salisbury, England was undertaken by Russian operatives.

Moreover, a person having professional driving licence for light vehicles and one-year experience can now drive medium-sized vehicles. Similarly, a person having professional driving licence for medium-sized vehicles can operate heavy vehicles until December 31, it said.

"The government is issuing such

directives for the sake of people's interest as well as to keep the movement of passenger and goods-laden vehicles normal in the backdrop of inadequate number of people holding medium and heavy

vehicles' driving licence, compared to the

number of those vehicles in the country,"

reads the gazette notification. Prof Moazzem Hossain, former director of Accident Research Institute (ARI) of Buet, said the government should have taken a programme to train the drivers before providing them

with licences. "If you give them a licence by relaxing the conditions, it means you are giving them a licence to kill," he told The Daily Star last night.

"It can't serve people's interest," he added.

Eminent road safety campaigner Ilias Kanchan said, "I won't oppose it. However, they [drivers] should be given short training and they should go through tests before getting licence for heavy vehicles."

Asked, Kamrul Ahsan, joint secretary of the road transport ministry, who signed the gazette said, "The decision has been taken for the time being considering people's interest and to keep transport service normal."

He, however, declined to comment about the concerns that the decision would make roads riskier. Amid protests for road safety, police

launched a crackdown on errant vehicles and drivers across the country. During the drive, a large number of

bus and truck drivers was caught with light vehicle driving licence. Against the backdrop, transport owner and worker leaders urged the

government to relax the requirements. There are some 35.36 lakh registered vehicles in the country till July this year. So far, the BRTA has issued 26.39 lakh

driving licences till the same date. Of them, 1.38 lakh holds heavy licences while 60,238 possess medium licences and 14.59 lakh holds light licence.

Nepali probe panel trashes media report

"The sole purpose of the Accident Investigation Commission is to find the probable cause and try to prevent further accident of similar nature in

The probe is ongoing and the report is not complete, said the commission formed by the Nepalese government after the US-Bangla plane crashed in Tribhuvan International Airport on March 12.

The Kathmandu Post, which claimed to have a copy of the report, yesterday said Captain Abid was going through tremendous personal mental stress and anxiety, and a series of erroneous decisions on his part led to the crash of flight BS211.

The paper said the pilot was smoking inside the cockpit during the onehour flight to Kathmandu from Dhaka and he was disoriented.

It said, "The investigation of the US-Bangla Flight 211 concluded that the ATC's [Air Traffic Control] handling of the flight was not a significant contributing factor to the crash. However, the report stated that some air traffic management procedural lapses were noted on the part of the crew at the control

raised questions about the motive the plane's black boxes on April 23. behind the report, which blamed the pilot without touching on issues like the conversation between the ATC and the pilot.

One is to defame the airlines concerned and its crew and the other is to hide the truth, the carrier said in a statement signed by Kamrul Islam, general manager (marketing support and public relations) of the airlines.

It said the pilot demonstrated complacency and gross negligence of procedural discipline.

Six minutes prior to landing, he had confirmed that the plane's landing gear was down and locked. "Gears down, three greens [cockpit light indicating gears down and locked]," the pilot said, according to the Post.

However, when co-pilot Prithula Rashid conducted the final landing checklist and found the landing gears were not down, the paper The Post claimed that the investi-

gators said Abid had been smoking frequently during the flight. He had not disclosed to the airlines that he was a smoker, leading investigators to conclude that he was severely stressed in the cockpit.

The voice recorder had nearly an hour-long conversation between the captain and his co-pilot and it demonstrated Abid's tensed mood throughout the flight and a complete lack of situational awareness, it said.

The paper said the report showed that Captain Abid used profanity multiple times whilst talking about a co-pilot of US-Bangla who had questioned his reputation as an instructor, and their relationship was a major topic of discussion throughout the flight. He had said the co-pilot was the reason for his intent to leave US-Bangla.

"He also seemed to be fatigued and tired due to lack of sleep ... He was crying on several occasions," the Post quoted what it claimed to be the commission's report.

Co-pilot of the flight Rashid was a passive listener throughout, it added.

"However, the report clarifies that Sultan did not exhibit any recurring mental issues during the medical examinations from 2002 to 2018.

'None of the medical reports that the committee reviewed from 2012 to 2017 mentioned any symptoms about depression,' the report said, adding that during his routine medical evaluations, he was declared fit and free from any symptoms of depression," the Post

Malaysia bans

told the local newspaper Ouest France. The ban took effect on August 20.

Sami Hassani, a specialist in marine mammals at the Oceanopolis sea park, said the dolphin could accidentally cause "serious injuries" with its tail fin. But the ban has run into legal problems.

Lawyer Erwan Le Cornec told AFP he plans to file a petition to overturn the restrictions on the grounds of administrative over-reach.

"How many accidents involving a dolphin and a human have occurred in the region of Finistere since the two species have lived side-by-side?" he asked scornfully. "None."

"With this decree the mayor is trying to make out that the dolphin is almost like a ferocious beast, something that is completely unpredictable, able to drown people."

The mayor, he said, "will overturn the rightly positive approach that people have towards dolphins into a fear of these intelligent animals."

Robber' killed in 'gunfight'

A suspected robber was killed in what police claimed was a shootout between the law enforcers and a gang of robbers in Baliakandi upazila of Rajbari early yesterday.

The deceased was identified as Badu Sheikh, 40, of Gobinadapur village of Rajbari Sadar upazila.

Hasina Begum, officer-in-charge of Baliakandi Police Station, said, "Acting on a tip-off, a police team went to Alankarpur village where a gang of robbers was holding a meeting. Sensing the presence of the law enforcers, the gang opened fire and the policemen retaliated,

triggering the gunfight."

Badu's body was recovered from the spot after his cohorts fled. He was rushed to Baliakandi Upazila Health Complex where an on-duty doctor declared him dead around 3:00am, she said. The law enforcers also claimed to have recovered two guns, cartridges, five bullets and a knife from the spot.

Badu was a leader of the gang and was an accused in seven cases, including four for robbery, filed with different police stations, she said, adding that three policemen also sustained minor injuries in the incident.

Shahidul, 63, was picked up by law enforcers on the night of August 5 from his Dhanmondi home.

The following day, he was placed on seven-day remand after police had produced him before a court seeking a 10-day remand. He told the court that he was tortured in custody, but the police denied the allegation.

He was sent to jail on August 13 on completion of his remand.

In response to a writ petition filed by his wife Rahnuma Ahmed on August 7, the High Court directed the authorities concerned to immediately send him to Bangabandhu Sheikh Mujib Medical University, arrange his medical examination and submit a report by 10:30am on August 9.

The BSMMU authorities formed a four-member medical board to examine his health and mental condition. The board's report submitted to the HC mentioned that he was physically and mentally sound.

During hearing at the HC on August 9, the defence argued that there was no psychologist in the medical board to examine his mental condition.

The hearing of Shahidul's bail petition would be held on September 11 at the court of Metropolitan and Sessions Judge, Dhaka.

riage," Satyajit recalls, "but at first she was annoyed. Still, it worked out alright because as per Hindu traditions our wedding was in the evening. I was able to take classes that day, before arriving at my in-law's home. From there I went to school again the next day, and returned to take my wife to our house."

Gradually his wife, Arati Rani Biswas, became accustomed to her husband's ways. "Later she understood that I was doing a good thing," Satyajit reflects. "Now she cooperates with me."

Yet some of his other relatives are less convinced. Some have suggested that only a madman wouldn't take leave on his wedding day.

Nor did Satyajit apply for leave when his father passed away. "My father died early in the morning," he recalls. "I was with the body until 8 a.m. Then I went to school for two classes before returning home for the cremation."

In the course of his career Satyajit has

progressed from his initial appointment as assistant teacher to his current role as assistant head teacher. By habit he reaches the school gate not less than half an hour before school starts.

"I want to establish our school as the best in the area," says the teacher whose devotion to education has made him especially popular with colleagues, students and the community at large. Indeed several local organisations have

recognised Satyajit as an ideal teacher. "He doesn't only teach," says the school's head teacher, Nazrul Islam. "Satyajit is also there for our students when they need advice on any topic, be

it school or life-related." "Satyajit has shown unprecedented professionalism," says Jessore's secondary education officer Aminul Islam Tuku. "Over such a long period he hasn't taken a single day in leave. He has attended school despite any personal difficulty. He is an ideal teacher

At an all-party meeting the EC convened here, the opposition parties questioned how in every case of EVM malfunction, the vote goes to only one party and demanded that the Commission hand over the name and address of the firms that repair the EVMs.

Representatives of BJP, opposition Congress, Trinamool Congress, Mayawati-led Bahujan Samaj Party, CPI, CPI (M) and Nationalist Congress Party and 51 state parties were present in the meeting called by the EC to find political consensus on electoral reforms. Since the BJP's sweeping victory in

Uttar Pradesh state assembly elections in 2017, Mayawati, along with Aam Aadmi Party, had been alleging that the results were swung because of manipulation of the EVMs. The Election Commission has

dismissed the allegation and challenged anyone to hack into an EVM. Emerging from yesterday's meeting,

Congress leader Mukul Wasnik told the media that EVMs "do not reflect the will of the people".

"There have been a number of times when EVMs malfunction and it [the votel goes to only one political party. We want to know who is repairing the EVMs and how many of the old ones are being used. We want the VVPAT [voter-verified paper audit trail] and

the EVMs to be checked," he said. Going a step further, Trinamool Congress leader Kalyan Banerjee

The Election Commission had used VVPAT in some recent polls apart from keeping a paper record of every vote cast. This was matched with the result given by EVMs in only some cases.

Former Chief Election Commissioner SY Quraishi, has however, said the EC only matches one per cent of the votes. To dispel doubts, the Commission should allow matching results of at least five per cent EVMs and paper trail slips, he said.

The opposition parties want at least 30 percent of them to be cross-checked. Meanwhile, the Election Commission

said it would provide "satisfactory solution" to the concerns raised by the political parties on the EVMs. Chief Election Commissioner O P

Rawat told reporters that "we will definitely look into all the suggestions given by them [political parties] and there will be a satisfactory solution to them." Some parties also suggested that the

number of constituencies where results of EVM and paper audit trail device are matched be increased to enhance the confidence of voters and parties in the reliability of the voting mode.

"Nothing final has been decided yet but one way to dispel fears is to increase the number of constituencies where EVM and paper trail machine results are matched," said a senior EC functionary. EVMs were first used in election in

India in May, 1982 in a Kerala by-polls. But since there was no law prescribing its use, the Supreme Court struck down the election.
